

585. Kreuzer, Eugene

I met at St. John Parish, Paris with Kreuzer and the same individuals who came to see me on May 12. The only new people in the group were the trustee and trustee-elect. The meeting was long, spanning a period of three hours. It was the first opportunity of these people to ventilate some of their feelings to their pastor. One of the trustees was very defensive of Father, the trustee-elect played a neutral part. Kreuzer listened for the most part and began to respond later in the meeting. The people claimed that they were lacking in spiritual leadership. They acknowledged Father's expertise for financial matters but stated that others could do some of those things if this was preventing him from being an adequate spiritual leader. The liturgy committee expressed frustration at going through motions without the guidance and direction of the parish priest and later having their plans cancelled by him. They told Father that the children were afraid of him. They asked that he undergo periodic review soon. They acknowledged that there was some division in the community and that Father could be getting caught between the two factions. Throughout the whole meeting they seemed to evidence the feeling that they really liked Father but were afraid that he did not like them. They were concerned because often he listens to one or two complainants and he is guided by those people. The meeting was not completely negative and Kreuzer was affirmed in many things that he says and does. As he began to respond I got the feeling he was taking their message rather well and showed evidence of willing to cooperate. He has been in touch with the Office for Parish Councils and some workshops are being planned in order to examine parish structures and to see that nothing is going wrong along those lines. After the meeting I was somewhat disappointed when Kreuzer referred to this group as "the troublemakers." He also told me that he would see how things go for a few months and if problems continue, he will be seeking a change of assignment.

On Wednesday, May 22, 1991 I met with Gene as a result of the allegations brought forth by [REDACTED]. Gene acknowledged that something had happened several years ago when he was drinking, much to his embarrassment. He stated that he was not able to remember any of the events which would have involved [REDACTED] brother and gave extensive apologies to the parties concerned when he was confronted with his behavior under the influence of alcohol. Gene claims that he ceased drinking at that time and that no further incidents occurred. He repeatedly stated that there is no cause to fear in his present assignment.

On April 23, 1992 I spoke with the Mr. James Birnbaum (1-608-785-2740) who called at the request of Bishop Paul to inform us of a development reported by Dr. [REDACTED] of the Middleford Clinic in Eau Claire [REDACTED]. Apparently the Doctor called the Diocese of LaCrosse because he is treating a patient in the age of about 45 who claims to have been a victim of Fr. Eugene Kreuzer from an association many years ago at St. Anthony's Parish in Milwaukee. I asked that Attorney Birnbaum contact Attorney Matt Flynn directly and attempted to call the Doctor immediately, but he was not available.

That same day I called Dr. [REDACTED] who informed me that his patient desired to remain anonymous. I explained the normal practices which we follow as information is gleaned and promised to call him back within a week with any further information regarding action taken by the Archdiocese. He was very satisfied and assured me that his patient would be pleased with such a response.

On April 27, 1992 with the encouragement of Tom Venne and Bishop Brust I spoke with Gene by phone, alerting him to the allegation which was brought to my attention and recommending that he request retirement this Spring. I also asked that he seek professional consultation and agreed to meet with him personally later this week to work out details.

On Friday, May 1, 1992 I met with Fr. Kreuzer at his Rectory in order to discuss the allegations which had been brought to my attention. We agreed that he would seek professional counseling through the services of Dr. [REDACTED] for as long as judged helpful. We also agreed that he would request early retirement with the date to be established after consultation with the Priest Personnel Office. A variety of parish concerns led to the realization that the normal date for transfers, namely June 23, 1992, may not be the most feasible in this case. In any event, it was understood that his retirement would clearly be effective prior to the commencement of a new school year at the end of August. I called Dr. [REDACTED] that very same day to report this development and was assured that the Doctor

On February 1, 1996 Gene called asking if he had to contact the Vicar's office every time a request came for help out, according to the formal letter which he received in early January. After conversation with Carrol Straub we concurred that Fr. Kreuzer could help out at St. Mary's in Kansasville or St. John the Baptist in Paris as needed, without permission from the Vicar's office in each instance. Fr. Carrol agreed to inform Fr. Kreuzer of that decision.

On February 1, 1996 Gene inquired whether he needed any special permission to help out at 3 neighboring parishes. I told him to use good judgment and, if he is needed at those 3 parishes, to do the helpout work. I also asked him to call me in 6 months to give a report on how everything is going. I did restrict the helpout only to the 3 neighboring parishes.

On June 7, 1996 Gene called just to report in and give an accounting of his helpout work in the area. He requested continued permission to carry on as he had in the last 6 months.

On March 17, 1997 Gene Kreuzer called to request permission to do helpout work at Brighton both on Sundays and weekdays. I told him we were comfortable with him helping for worship at St. Francis Xavier at this time.

On October 3, 1999 in the context of the pastoral installation of Fr. James Volkert at St. John the Baptist in Paris, Fr. Kreuzer approached me with the assurance that he had been completely faithful to sobriety and professional ethics over these past years and was being utilized for weekday Masses at Brighton, Kansasville and Paris. He indicated that he had approached the Archbishop the prior year regarding some review of his status and wondered if any further decisions had been made in the matter. I could only promise to raise the question with the Archbishop upon his return.

In the context of my meeting of November 6, 1999 with Archbishop Weakland it was agreed that faculties could be restored to Fr. Kreuzer for full help out Sacramental ministry, maintaining only the restriction regarding unsupervised contact with minors.

On December 11, 1999 in the context of the consecration of the new altar at St. Francis Xavier Parish in Brighton, I spoke with Fr. Eugene Kreuzer who expressed hesitation about another letter requesting faculties in view of his earlier two page request to the Archbishop some two years ago, but also because of a forthcoming medical test to determine whether surgery might be required in view of a 90% blockage in his left carotid artery.

Father Joe Hornacek and I met with Father Eugene Kreuzer to discuss [REDACTED] allegations. Father Kreuzer's basic stance was to acknowledge that these events probably occurred, but to deny any specific memories, claiming he was impaired by alcoholism at the time. Underlying this layer of defensiveness it was apparent that Father Kreuzer is deeply hurting. He reports praying for his victims every day, and regrets about hurting them. He reported that in the process of giving up alcohol, he also gave up his trailer and hunting and fishing as the activities associated with alcoholism. At present he is living an isolated existence in a rural farmhouse. He told the only neighbors not to allow their sons to come to his house. He rues the absence of participation in the Church. He states a wish for an early death, as life is no longer meaningful for him.

Father Kreuzer expressed apologies for hurting [REDACTED]. He explained that he did not mean harm in attempting to contact [REDACTED].

The next step will be to convey this information to [REDACTED] and support [REDACTED].

You inquired about the canonical issues involved in the retirements of Father Eugene Kreuzer and Father Louis Okopinski. Their situations need to be studied separately as different canonical norms apply in each case.

As a preliminary, it needs to be stated that canonically there is no such category as "retirement." The status of retirement is more one of popular parlance than of canonical significance. What the law does require (of cardinals, bishops, and pastors) is the submission of a letter of resignation from office at seventy-five years of age. The key concept is that of the office. One's canonical office is lost, among other reasons, by resignation, transfer, removal, completion of one's term of office. The law mentions loss by "reaching the age determined by the law" but the age designated for each of the offices noted above seems to be more the designation of an age at which resignation is appropriate or removal could be undertaken in the absence of a resignation. In the case of these offices there is a mandatory age at which the resignation must be submitted but there is no requirement that the resignation be accepted by the authority to whom it is sent.

In the case of Father Kreuzer, since he held the office of pastor, if he has indicated that he wishes to resign (even if he uses the word retire), then the Archbishop can accept his resignation and designate him as retired. Usually the resignation is to be in writing but it can also be done orally in the presence of witnesses.

In the case of Father Okopinski, he was assigned in 1969 as "Chaplain of the Waukesha area hospitals." No term was stated at the time of his appointment. At the time of his appointment the role of chaplain was not strictly speaking designated as an office. However, under the provisions of the 1983 Code it would be considered an office and there are norms on appointment, removal, etc. There is no mandatory resignation age for chaplains as there is for pastors. However, it is clear from the Code that a chaplain is simply removed from office by the local ordinary for a just cause and according to the ordinary's own judgment. A just cause has been deemed in canonical tradition to be consideration for a person's age and ability. Therefore, a letter from the Archbishop would simply need to indicate that Fr. Okopinski is no longer the chaplain. No mention of retirement or resignation would need to be made. He could refer, if needed, to "the provisions of canon 572" (which refers to the removal of a chaplain) in his letter.

Dear Archbishop Weakland,

I received your letter of May 25th. I imagine it was as difficult for you to send this letter as it was for me to receive it. I understand the reasons for such drastic action in view of the adverse publicity which the Church received. I apologize for any embarrassment which I may have caused.

Since the allegations against me relate to an incident which took place over 30 years ago, I would like to explain what action I took at the time and the results. First of all, the sins in which I became involved were due strictly to excessive drinking on my part.

When I realized what drinking could lead to, I stopped all consumption of Alcoholic Beverages. I have always had liquor on hand but I have consumed none since that time, nor have I given any drinks to any one under the age of 21.

My confessor and spiritual advisor advised me to avoid any social involvement with teen-agers and young adults. In this way he felt that there would be no repetition of any of these things. I agreed. To this day I avoid all social involvement. I discontinued my favorite forms of recreation namely, hunting and fishing. As a result I am never alone with anyone, especially minors. As a result, there has been no repetition of any sinful actions at any time during the last 30 years +.

During the last 24 years I have been associated with St. John's Church in Paris, 21 years as pastor and the last 3 years as a member. I have not been involved in any questionable actions with any parish member or non-parish member, minors, or anyone else. During my affiliation with St. John's, I don't believe that anyone has ever heard me use any kind of vulgar expressions. I enjoy the respect of all people I have dealt with in France & Kentucky countries. Since I can face anyone at St. John's and the neighboring parishes ^{with a deep conscience} I have chosen to remain an active member of St. John's after I retired 3 years ago. I have made myself available as a help-out to the pastor of St. John's, St. Francis in Brighton and St. Mary's in Dover. Until I received your letter, I had been saying Mass on weekdays especially at St. Mary's 2 or 3 times a week. An attendance at these Masses were from 2 to 20 people.

Dear Archbishop Lambert,

My immediate purpose in writing this letter is to humbly ask permission to concelebrate the Eucharist with Father Tom Falt at St. John's on Christmas Day.

Since I met with you on June 23rd, I have faithfully followed all of the restrictions which you imposed on me in the letter which I received on 5/31/95. I have not celebrated the Eucharist since that day.

Is there any possibility that these restrictions will be lifted at some time in the future? If it is possible, what must I do to prove myself?

In the Spring of 1993 when the question of misconduct on my part arose, at Bishop Albin's suggestion I had a series of conferences with Dr. [redacted] a psychologist, at the center for psychological services at [redacted] in Milwaukee. When we first met, I gave Dr. [redacted] permission to discuss anything that we discussed, with you, Bishop Albin, or

Father Verne or Tom Trepanier of the Personnel Board. I also took the Minnesota psychological exam. At our final conference (May 26, 1992) he informed me that, in his opinion, I showed no abnormalities and that further therapy would not be necessary. In our discussions I told him of all that I had done to make up for the wrong that I had done.

I not only quit drinking... I still haven't had my first drink since then... Just for over 20 years I kept fresh flowers on the altar year round at my expense. In place of a celebration for my 25th Anniversary of Ordination, I financed the erection of a shrine honoring our Blessed Mother between the Rectory and the church at St. John's at a cost of about \$3000.00. I gave up hunting and fishing, and (I remember you saying that you never want a priest to pay this) for the last 18 years I never took a day off except when I was in the hospital following heart attacks in 1982 and 1989. Instead, I spent time every week visiting the sick and the elderly who were confined to their homes, hospitals, or nursing homes.

I kept up these visits even after my retirement until I received your letter. I had to quit at that time because after 20 years of doing this I was well known in the hospitals and nursing homes of the area and frequently nurses would ask me to visit dying persons and to anoint them (which I can no longer do..)

In Dr. [redacted] final analysis, he told me that all my actions are attempts to punish myself. He tried to impress on me that God forgave me 30 years ago but I never forgive myself... which is probably true.

During the past several months I find that I am becoming more despondent. I have shed more tears in the last 60 days than I have in the last 60 years. I will be 70 years old in January and my declining years which I thought would be happy ones are turning into a continuous nightmare. I go to Mass on Sundays and find out that I can't find priests for fear of questions about helping out. I avoid parishioners because their questions turn me to instant tears. If they notice this, I blame it on

the cataract surgery which I had in May. I used to pride myself in my ability to go to sleep in about 10 seconds from the time I lay down. Now more often than not, I lay awake for 3 or 4 hours and end up crying myself to sleep. I am not feeling sorry for myself because I know that I deserve any punishment which I receive. These are tears of frustration. The very people whom I served faithfully for over 21 years and with whom I chose to spend the rest of my life, I must now avoid. I told Father Tom last week that I may start going down to Illinois for Sunday Mass because it hurts me too much to see the people at St. John's or St. Mary's or Brighton, all of whom made up "my family" ... I can't even share any conversations with them. When someone died, I attended all parish wake services and attended or concelebrated the funeral Masses when the family or Fr. Tom asked me to. Now I don't dare to go for fear of being asked to concelebrate and I know I can't.

While I have very few visitors the most frequent visitors which I do have, are the sisters who taught at St. John and are now retired themselves. I dread the thought of them coming to my house because of the questions. I know that they sense something to be wrong. I hope that some day I will be allowed to at least offer occasional week day Masses at these parishes because I know that that will stop a lot of the questions.

My hopes were high about a month ago when I saw on TV and read in the newspaper that a priest in Chicago who was suspended for the same reason was allowed to return to parish work, the only restriction was that he would be supervised any time that he had to work with the youth of his parish. He appeared to be only half my age - I pray daily that sometime in the future I will be allowed to do the same.

I am sorry that my simple request turned out to be such a long letter but you are the only one with whom I can

share my thoughts.

If you wish to see me, I will
set up an appointment at any time.
If you wish to phone me, the number
is [REDACTED] (since I get only one
or two calls a month, I asked the
person who lives upstairs and who
shares the same telephone line, to
answer all calls and to call me
to the phone if the call is for me.
When no one is home up there, I
answer the calls myself.) I am
in most of the time since the only
time that I leave the house is to buy
groceries, go to Mass, or take the dog
out for a walk.

May God bless you and please
pray for me.




PRECEPT

In response to the pastoral needs of this Christian community, in virtue of his authority as diocesan bishop (c. 381, §1), and in accord with the provisions of canon 49, on May 25, 1995 Archbishop Rembert G. Weakland formally placed upon Reverend Eugene Kreuzer a precept for the purpose of restricting his exercise of ministry. The circumstances calling for these restrictions have now been reviewed and it has been determined that modifications in that precept can be made without endangering the good of the ecclesial community. Therefore, effective this date, the following modifications to the original precept are in effect:

- 1) The faculty to hear confession is restored and be exercised when a penitent explicitly requests the individual celebration of the Sacrament of Penance or when a pastor requests your assistance with this Sacrament at a parish;
- 2) Participation as a concelebrant of a funeral Mass is permitted provided the pastor of the parish deems such participation appropriate;
- 3) Permission for public celebration of the Eucharist on other occasions may be granted by Very Reverend Carrol Straub, Vicar for Clergy, based on his review of the reasons given in your request.

The remaining restrictions continue and will remain in effect until notice of their revocation since they are seen as necessary and prudent precautions.

I have no problems in keeping the 6th & 9th Commandments in my personal life.

I had wanted to come in to see you but I can't make myself interrupt your busy schedule. I had two questions I wanted to ask of you. First... Now that Carol Straub is watching over me from above, is there anyone else you want me to report to or to check in with? And... is there anything that I can do in offering service to the church?

for the years since I retired I have been doing a lot of book work, (payroll records, etc.) for Fr. Tom Faust at St. John's and for Providence Catholic school. I have limited my celebration of Eucharist to week days at St. John's, St. Francis in Brighton, and St. Mary's in Dover but only when needed. I have been reluctant to help out at week-end Masses without your permission. If you approve, I would limit helping out to the rural parishes in Racine - Kenosha counties. If you feel that it would not be wise for me to do so, I will continue to turn down requests for week-end help.

If you want to discuss any of the above with me I would be happy to come in to see you... or... since I seldom go anywhere, I am also available by phone... [REDACTED]

Thanks so much for your months of patience. The letter that you wrote me in January came while I was on vacation and sat on my desk after that for a bit with all the mail that had piled up. I gave it over to the Vicar for Clergy for his advice and must admit that that took some time as well. It finally came back to me and I simply want to apologize for not answering you before this time.

I think, Gene, it would be wise to keep the restrictions as we now have them. It just strikes me as being more prudent. I am very pleased that you have been able to keep your sobriety as you should and want to commend you for this. God bless you in all those efforts.

I don't think it is really wise for you, Gene, to get involved in jail or prison ministry. It strikes me as being a very difficult kind of ministry that requires an enormous amount of savvy. I think it might be a danger for you to get so involved in the Kenosha House of Correction. I would be very cautious then about saying a yes to that kind of involvement.

I hope all continues to go so well for you, and thank you for being so cooperative. Many, many blessings on you in every way.

Dear Archbishop Weakland,

First of all, I would like to thank you and Bishop Sheba for the flowers which you sent at the time of my recent surgery. I appreciate your thoughtfulness. Everything went well and I am fully recovered. It wasn't the best time of the year to be laid up since I still take care of the payroll books for St. John's parish and day care center. This is the time that I have to issue 20+ W-2 withholding tax forms to the employees as well as filing the annual tax forms for the parish. These are all going into the mail today.

I am still keeping the agreements which I made with you several years ago. I have not consumed any alcoholic beverages for at least 30 years and will continue to avoid them. I have limited "helping out" to St. John's, St. Francis Brighton and St. Mary's in Dover. I say Mass once a week at one of these parishes except when the pastor is on vacation. I explained to Tom Frit and to Jim Volkert my situation so

that they are aware of the reasons I do not keep out at other parishes. Both have been very understanding. I entertain no lay visitors to my home nor do I accept any invitations to visit private homes or even to parish dinners where parish members are apt to be present. The only visitors which I have are six or seven Lake Drive Franciscans (former teachers and principals) who come down here to visit regularly.

I have ^{been} presented with a problem recently for which I would appreciate your advice and perhaps your permission. I have been taking Communion every two weeks to a parish member of St. Johns at the Keweenaw County House of Correction. He is awaiting trial on a charge of homicide by the intoxicated use of a motor vehicle and fleeing the scene of a fatal accident. Word was passed on to me that Pastor Sandy, the Protestant Chaplain, when she heard that I visit the prison regularly, was wondering if I could meet occasionally with other Catholic prisoners who wish to see a Priest. Since most prisoners are not parish-affiliated she has not succeeded in finding a Priest to visit them.

Even though such requests are few and far between, I have been reluctant to respond to her requests because of the restrictions on my ministry. I have the time and I am willing to respond to this need, but I will not respond to this request without, at least, your tacit approval. All visits by lawyers and clergy are in glass-enclosed rooms where a guard can see them (but not hear them.)

I respect your authority to restrict the use of my faculties and I agree without question to abide by your decision.

Finally, I would like to thank you for conferring the Vatican II award on Jeffrey Honore last year. I had known Jeff for several years prior to giving him earnest instructions prior to his marriage at St. John's.

May God bless you especially during this time of preparation for your own retirement.

As I continue to adjust to my role as Archbishop, I am undertaking a review of files of priests. I note that there have been problems in your past of which you are well aware. Father Hornacek will be contacting you for a personal meeting in the near future to discuss this situation with you on my behalf. If you want to meet with me personally at some point after your conversation with Joe, I am certainly open to that possibility.

In the meantime, I see that a precept restricting your exercise of ministry is in place. I would like to confirm those restrictions: You are to have no unsupervised contact with minors and no public exercise of ministry; Private celebration with only another priest or priests in attendance is permitted, but no other sacramental ministry.

I am grateful for the opportunity to have had a brief conversation with you earlier this week in the context of our Spring Assembly of Priests. I was distressed to learn of some of the cardiac problems which you have again experienced during the past few days. This ongoing condition, together with the counsel which I have recently received, confirms the wisdom of asking that you seek the Archbishop's permission for formal retirement from the pastorate of St. John the Baptist Parish in Parish, effective June 30, 1992.

I do not know exactly how the Personnel Board will staff the Parish during the weeks immediately subsequent to that date; however, I have been assured that the pastoral care of the congregation and sacramental services will continue to be provided until a permanent replacement is determined. It may be that the permanent replacement would be available at that very same date. I recognize that some refurbishment may be necessary in the Rectory prior to a successor actually assuming residence in Paris. At any rate, I can promise that your own needs as well as the needs of the Parish community will be addressed in every way possible.

Enclosed please find some materials pertinent to the Pension Fund and the forms which you must be completed in order to begin receiving Pension payments. Please contact Sr. Rose Stinefastin Fr. Tom Venne's office for any further information regarding these materials. The completed forms should be returned directly to the office of Fr. Tom Venne.

Thank you for your understanding and cooperation during this time of transition. I am convinced that your own physical problem will be considerably alleviated as soon as the stress of these arrangements have been completed. May the graces of Pentecost be of healing strength and support for you and all whom you serve.



On 2/8/01 I spoke with [REDACTED] in Delavan. He reported that a friend of his [REDACTED] had come to him about a situation with her brother [REDACTED] who now lives [REDACTED]. [REDACTED] is aware that her brother was sodomized by Fr. Kreuser on a youth retreat in the 1970s, and [REDACTED] believes it also happened to one other boy. [REDACTED] has reportedly gone through treatment. What is re-opening this issue now is that [REDACTED] recently heard from Fr. Kreuser, according to [REDACTED].

[REDACTED] is aware that [REDACTED] himself would need to come forth and make a report. He is getting information about Project Benjamin, including a brochure, to [REDACTED] through [REDACTED].

In my files I have found indication that Eugene Kreuser was restricted from ministry at the end of 1995, apparently due to misconduct. I believe he is retired now. I have no further information about victims or specifics.

I think we need to address the question of whether Fr. Kreuzer should be contacting past victims, although at this point we really don't know how [REDACTED] perceives that.

I'll keep you informed if more about this situation comes my way.

When I phoned Fr. Kreuzer this afternoon he thought I was calling in response to his volunteering to help Fr. Jim Volkert by serving as Temporary Administrator at Brighton and Paris while Fr. Volkert is on sabbatical starting August 27, 2001. I thanked him for his offer but said we try not to use retired priests to serve as Temporary Administrators. Fr. Kohler and I will find someone to serve full-time in Fr. Volkert's absence.

I reported the reason for my call to be an allegation that Gene was trying to contact [REDACTED] from [REDACTED] who may have been a victim of his sexual misconduct in the past. Gene volunteered that he had indeed tried to reach [REDACTED] by phone as he has done every few years to check up on the status of [REDACTED] marriage.

Gene admitted that he first knew [REDACTED] when Gene was at St. Anthony's, Milwaukee (1952-1971). He also admitted that [REDACTED] "may have been" a victim of his sexual misconduct because he was "stoned" at the time and didn't remember much about what happened because of his drinking problem.

About 15 years ago (after Gene himself had given up all drinking) he "went to bat" for [REDACTED] who had a [REDACTED]. He was living in a [REDACTED]. Gene talked [REDACTED] and got a job for him working for [REDACTED]. Since then Gene claims he contacts [REDACTED] every few years simply to learn how his marriage to [REDACTED] is going. (Years ago Gene even remembered contacting [REDACTED].)

Recently Gene learned that [REDACTED] was now living [REDACTED]. He asked [REDACTED] (who lives in [REDACTED]) for [REDACTED] phone number so he could call him. Allegedly [REDACTED] who is the only one who knew Gene would try to contact [REDACTED] emailed [REDACTED] to inform him that Gene would be calling.

Gene recently phoned [REDACTED] several times, "curious to know how his marriage is working out," but never reached [REDACTED]. I informed Gene that his attempt to contact [REDACTED] may be misconstrued and he should immediately cease trying to make any further contact with him. He promised that he would follow my advice.

He ended by reporting that he never attends clergy gatherings because he tends to "break down" when asked what happened to him. He remains grateful for the opportunity to help out in a few designated parishes in keeping with the prescribed restrictions.

Please allow me to continue to update you about developments that may concern you.

On February 27, 2004 the findings of the "John Jay Study" will be released. This study was commissioned by the U.S. Conference of Catholic Bishops at their Dallas meeting in June, 2002. John Jay College of Criminal Justice conducted a survey, and this report will include cumulative numbers from dioceses across the United States who reported on their individual numbers since 1950.

Naturally you will be interested in this news story because of its personal dimensions for you, but many victim/survivors have also let me know how extensive media coverage of clergy sexual abuse causes intense personal disruption and setbacks. In addition to a "heads up" about the turmoil you may face, let me make a few suggestions about how you might manage this time period.

- Be in charge of your media doses, rather than let it control you. Choose when and where and how much exposure you want. Turn off the TV or radio, and put away the newspaper, as needed. Let people know if you don't want to talk about it now.
- Turn to people who offer you genuine caring and support. Distinguish these from the people who have another interest or purpose in talking to you about your personal relationship to the topic. Remember that you have choices about whether you publicly identify yourself as a victim. Talk with people with whom you feel "safe."
- Consider making an appointment with your therapist if you don't already have one. If you have not taken advantage of our offer to assist financially with psychotherapy, but would like to do so, please contact me. There are also support groups that focus on the healing needs of sexual abuse survivors, for which I can provide information. You are welcome to turn to me as a support person as well.


Previously we informed you that a new mediation program, independent of the Archdiocese, was forthcoming. The Clergy Sexual Abuse Mediation System is designed to resolve disputes for those who have been sexually abused by Catholic clergy, with the goal of healing, restoration and closure. If you are not already registered to participate in mediation, you may do so by calling 414-302-9215 or 1-866-302-9215. The last date for requesting mediation if you choose to seek resolution.

I pray and hope that your journey as a survivor of clergy sexual abuse starts to become easier. For the Catholic Church it is a necessary time of public accountability in order to be responsible for what happened in the past, to change the culture and ways of operating in the present, and to practice prevention in the future. As we have said before, no words or actions erase the burden you have borne as a result of this issue.

I write to you because you have experienced, firsthand, the pain caused by sexual abuse within the Church, and you courageously reported the abuse to the Archdiocese of Milwaukee. No words can apologize sufficiently for your experience, but I will continue to try by saying again how sorry I am. Knowing that no remedies can adequately address the harm done, I still want to make you aware of a variety of services available to you and intended to assist in your healing.

Dispute resolution services to address your unique needs for recovery will become available in mid-January. Eva Soeka, a nationally known expert in dispute resolution systems, is creating a process independent of the Church that will make use of the best mediators in the area. I continue to believe that this initiative represents the best way for us to meet together about your situation and provide assistance. More details and information about how to enter into this process will be available in mid-January. At this time, I ask you to start considering if this might be the right next step for you.

Catholic Charities is also offering a new support group in Milwaukee for adult survivors of childhood sexual abuse. This group will offer a faith-based perspective, and is meant to supplement other support groups available in the area. A flyer is enclosed.

Financial assistance with psychotherapy also remains available. To access this, or for other questions about our services, please contact Dr. Barbara Reinke in our office for Sexual Abuse Prevention and Response Services (414-769-3436 or reinkeb@archmil.org). Also enclosed is a brochure about our policies and procedures when a report is made.

I continue to meet privately with those victim-survivors who find that helpful. Please contact me at 414-769-3496 if you would like to arrange such a meeting. We have also arranged for several priests, sisters and lay ministers, who are professionally-trained in providing spiritual direction, to be available. If you would like to speak with one of them, please contact Barbara Anne Cusack, my delegate for sexual abuse issues, at 414-769-3341.


It is also important for me to communicate with you about our efforts to prevent clergy sexual abuse in the future. Our *Code of Ethics* makes it clear that no such behavior is to be tolerated within ministry. Our *Mandatory Reporting Responsibility* policy specifies that any employee or volunteer working in our parishes and schools must report any suspicion of abuse. In addition, all adult staff, and volunteers who work with children are required to participate in training to enhance awareness of childhood sexual abuse.

One final thing: if you would prefer not to have further contact from me or from any Church representative, please let us know using the enclosed return letter and pre-stamped envelope.

Much more remains to be done, and we welcome your suggestions. You can use the enclosed response letter and envelope for that purpose as well.

Please know that I am concerned about you and I pray for you. I apologize for the past misdeeds and wish to restore your wholeness as best we can.



I am truly sorry to hear that you were sexually abused by Fr. Eugene Kreuzer. Obviously this should not have occurred and it was not your fault, but I think you know all this. I realize the harm inflicted upon you has been substantial, causing years of pain and therapy.

Fr. Kreuzer has been known to us for many years as someone who offended against teenage boys, and he was one of the first to be removed from ministry and placed under restrictions. Under the laws in effect at the time, civil prosecution was never possible. He is currently retired, under supervision, with no faculties. As it happens, I did confront him personally with another allegation. As information only, because I know it does not in any way excuse what he did, in his case he acknowledges and takes responsibility for what he did and expresses considerable remorse and concern about the harm he has caused. I am hoping this information can contribute to your needs for truth and justice, and ultimately healing.

I would like to speak with you about how we can assist your healing. It is our routine practice to pay therapy costs for someone who has been harmed. Please sign a release so that your therapist may contact me and I may send out a packet to set up payment arrangements. We review a treatment plan, not for the purpose of restricting therapy, but to ensure that we pay for quality therapy.

 I want to acknowledge another minor connection between us. Prior to taking this job, I conducted private practice in Dr.  office/Parkland Clinic one day per week. Obviously I knew of you, even though I'm not sure we ever directly met. I don't think this would lead to any problems now, but please let me know if you see it otherwise.

I hope you've had a wonderful vacation. As you get back into the swing, here are some of the items requiring your attention.

1. Please make a call or send a letter to [REDACTED] apologizing for the abuse he suffered from Fr. George Nuedling. His phone # is [REDACTED] his address is: [REDACTED]
2. [REDACTED] now in his late sixties, was a victim of Fr. Eugene Kreuzer, starting shortly after his ordination. [REDACTED] first contacted us last winter, but delayed in getting back to us about financial assistance for therapy. Over the years [REDACTED] has spent a tremendous amount of his own money for therapy. As with so many other victims, the issues were reopened for [REDACTED] last winter and he started having marital problems. He resumed therapy with a psychoanalyst whom he is seeing three times a week at \$190 per hour out of his own pocket. He expects this to end in the next month. It sounds like it has been quite effective therapy with regards to the sexual abuse. At this time there doesn't seem to be a point in sending out a treatment plan. I think the right thing to do for [REDACTED] would be to reimburse him for his out-of-pocket therapy costs since he contacted us last on March 31, 2002 with his initial report. This will be a significant amount of money, but with the understanding there will be no further financial assistance.
3. Fr. Jim Arsenault in Blacksburg, Virginia has contacted me about [REDACTED] ongoing need for therapy. As you recall, this was an adult relationship with minimal sexual contact, but a lot of psychological dependency and the dynamics of a sexual abuse case. We had agreed to pay [REDACTED] co-pays for therapy through April, with her insurance covering the majority of costs. [REDACTED] is now working as [REDACTED] and her income is so low that the co-pays are a problem for her. Should we continue to assist with co-pays, as Fr. Arsenault in his anger about the whole sexual abuse situation thinks we should? I did tell both of them that she should get the treatment she needs and we would work out the financial part after you return. It seems to me that since we've assisted her quite a ways in her healing, we should complete the job.





Barbarba Wisnefski [REDACTED] called to discuss the situation at Paris regarding the pastor. Kreuzer has been there for ten years and the people are dissatisfied with him she claims. She was relieved when I told her about our current method of choosing a new pastor, of the Term of Office Policy, and of the coming Periodic Review. I asked her to be patient and since they have a new Parish Council to try to work through the Council to resolve some of the Issues that she feels are at stake.

456. Kreuzer, Eugene

I visited him at Paris where we discussed the conversation I previously had with a number of his parishioners. I told him I was there mainly because I was concerned about him and his health. He never looked better to me and he showed me the medication the doctor is giving him to slow down the heart beat. He is suppose to run a mile a day according to his doctor's instructions. He does not see himself as having a health problem. However, I indicated that there is stress apparently coming from the parishioners and he agreed with this. Since so many of these families have intermarried and from time to time feud, Kreuzer is caught in the middle of that feud. There are problems with the structure of the parish council and its operation. He has already spoken to the Parish Councils Office about this and expects them to help straighten the matter out. His liturgical committee is evidently a problem. Yet, he gets involved in all kinds of small issues (e.g., the use of purple candles for the RENEW program). He told me that the people that came to see me were his troublemakers. At the same time, he saw them as great individuals who may be moving too fast in their expectations of getting the parish moving ahead against the wishes of some of the more conservative people. I saw this as a classic case of pastor caught in the middle of two groups of people and in trying to please both groups talking out of both sides of his mouth. As expected, he has a logical answer to all the complaints that had been raised. He said he would be willing to have another meeting with myself and the complainants. The most positive things that came out of the meeting was the fact that I saw he was in good health apparently, and that he is of goodwill and agreeable to further discussion.

He came to see me because he wanted to talk before our meeting with the parishioners next Friday. He told me he had authorized the release of any medical information from his doctor, [REDACTED] MD [REDACTED]. I told him I wanted to try to facilitate some reconciliation between him and the parishioners. He showed me that the recent election for a trustee had produced some politicing. One of the incumbants was voted out of office by a number of people voting for only one rather than two trustees. When he showed me the ballots, I pointed out that the directions did not forbid such an exercise of voting. I told him that if there were rules, they should be announced before the election not after. From our conversation I got the impression that he is caught in the middle of two factions and is trying to please both of them. This is resulting in his pleasing mainly the more conservative element.

Kreuzer, Eugene called to say that at Parishioner, [redacted] my advice she and her group had waited until after the 125th anniversary celebration to approach Father Kreuzer for a discussion. She said that he became very angry and adamantly refused to meet and discuss anything with them. He told her that he would not go through another session like he did a couple of years ago where everyone vented their emotions on him. She said that she explained that they did not want to do that but wanted to dialogue with him about some of their concerns. She said that he told her he was not "married to this parish" and could go to another parish if necessary. I told her that I would talk to him and see if I could encourage him to have that discussion with them. If not, I would be willing to facilitate the discussion between him and them or just talk to them if this would help.

He has agreed to meet with them at an open parish meeting where other parishioners can be present and help in his defense. He said he is sure the majority of people do not want to go along with some of the ideas this group is proposing. Another thing he said he would be willing to do is meet with these people on an individual basis. I told him that there were people here at the Central Office who could sit in on a meeting and bring some objectivity to it and support for him if this would be helpful. He told me he is not "married to the parish" and he would sooner resign than meet with this small group.



Saturday morning Fr. Gene Kreuzer called the Chancery to say that he was discharged from the hospital Friday afternoon. He said the doctor told him to convalesce for two more weeks (Holy Week and Easter Week). The doctor was not worried that Gene would be alone or needed to climb stairs, and he did not object to Gene's hearing confessions this week or to his celebrating Mass for children on Thursday.

However, he did not want him to celebrate Mass and preach.

On this basis, Gene wanted me to inform you that he will let us know if he needs anyone beyond that two week period. He seemed optimistic, although he alluded spontaneously to the tension in the parish as something still bothering him.

I hope that this information is helpful to you. May I wish also that you have a joyous and blessed Easter!

As you are aware I must frequently review the situation of priests who have had allegations of misconduct placed against them. You know of my comments at the Spring Assembly for Priests where I indicated that even retired priests may have to have some restrictions placed on the ministry they can offer. My concern is both to ensure that the integrity of the priesthood is upheld and to protect the diocese from any allegations of improper monitoring which might place persons at risk.


I have pondered how best to proceed with decisions regarding your status and exercise of ministry. I must bear in mind both my responsibility toward the good of the whole community and respect for your individual rights.

Given the serious nature of the obligations of celibacy, as well as the seriousness of violations alleged to have occurred by you, I find that some necessary and prudent precautions must be taken. This decision is ultimately a pastoral measure to protect the rights and reputations of all involved.

Therefore, I am enclosing a document which specifically details any ministerial restrictions which are to be observed by you.

CLERGY ADVOCACY AND MONITORING PROGRAM PROTOCOLS

I *Eugene Thomas Kruezer*, an ordained priest/deacon
Rev. Eugene Thomas Kruezer

of the Archdiocese of Milwaukee have read and fully understand the protocols detailed below. I acknowledge they are intended to assist me in leading a life that is holy, virtuous and appropriate, befitting that of an ordained minister of the Catholic Church. I understand they are also intended to support my desire to lead a life within socially accepted boundaries.

The Clergy Advocacy and Monitoring Program protocols that I have been notified of, and are applicable to my individual case, are as follows: All of the Tier # 1 -Monitoring Protocols and the below listed sub-sections

Tier #1, Section #2, sub-section #:

- A. Cannot Identify himself as a priest or deacon.
- B. Must not wear "clerical garb" such as the "Roman collar" or any other garb or symbol that would cause someone to believe he was a cleric of the Catholic Church.
- C. Must provide his current address and telephone number(s), including landline and cell phones, and e-mail address(es). He may also be required to move his residence to a residence that is approved by the archbishop.
- D. Is prohibited from performing any public act of worship, e.g., no sacramental ministry, no public prayer or worship service of any type.
- G. Is forbidden to own or possess any indecent or pornographic materials, e.g., magazines, periodicals, movies, books, etc.
- J. Must meet with the program coordinator on regularly scheduled basis, e.g., once per month, twice per month, bi-monthly, to be determined by the program managers.
- K. Agrees to unscheduled visits at his residence by the program coordinator. These visits may be made at any time of the day or night,

- seven days per week. Must agree to meet with assigned "onsite" monitors as designated by the program managers.
- M. Must notify the program coordinator anytime that he is leaving his city of residence for an extended period of time (in excess of 24 hours). All "out-of-town" or vacation travel must be submitted to the program managers or program coordinator for approval before travel is allowed. Information to be presented is to include the destinations(s), date(s), of departure, date(s) of arrival and itinerary. All out-of-town travel must be in the company of another person approved by the program managers.
 - N. Must notify the program managers or the program coordinator anytime he is detained by law enforcement for any reason, i.e., routine stop due to time of day/night and area, suspicious circumstances as defined by law enforcement, traffic or other stop, issuance of citation(s) for any local or state ordinance or law violations, arrest(s), or any other reasons for/of confinement by law enforcement.
 - O. Must abide by any other directives established due to special circumstances as deemed necessary and appropriate by the program managers.
 - P. Must comply with the aforementioned restrictions and/or guidelines to receive additional compensation. Failure to comply with the restrictions could cause a reduction in salary and/or benefits provided to the member by the Archdiocese of Milwaukee.
 - Q. Must not have any contact with alleged victims or their families without express written consent from civil authorities and/or the archbishop.


P#1-Must live a life of prayer and penance.

Select Kreuzer Sexual Abuse Intake Reports

- 3/5/01 Sexual Abuse Intake Report documenting abuse perpetrated by Kreuzer in 1969 when victim was 12-13 years old. Abuse occurred at a campground where Kreuzer had a trailer and included oral sex. Intake Report is a follow-up to the abuse first reported on February 8, 2001. Archdiocese will assist with locating a therapist.
- 1/25/10 Sexual Abuse Intake Report documenting abuse perpetrated by Kreuzer in 1961-1965 when victim was 9-12 years old. Abuse included fondling and forced oral sex and masturbation. Abuse occurred on trips the youth went on with Kreuzer. Abuse survivor wonders if others knew because he remembers Fr. Toelle at St. Anthony's always giving him a weird look when Kreuzer brought him into the rectory.
