

### Fr. Vijaya Bhaskar Godugunuru Timeline

- 1998 Fr. Vijaya Bhaskar Godugunuru ordained a priest of the Diocese of Cuddapah, India
- June 2003 Higher Studies in Rome, Italy
- Summer 2006 Fr. Vijaya Bhaskar Godugunuru came to the United States to Bonifay, Florida to work at parish
- June 23, 2006 Fr. Vijaya Bhaskar Godugunuru sexually abused Jane Doe.
- July 26, 2006 Holmes County Florida charged Fr. Vijay Godugunuru with Lewd and Lazcivious Battery, a 2nd degree Felony, for "sexual activity with [redacted initials] a person 12 years of age or older, but less than 16 years of age by fondling her breast with his hand and placed his fingers on or/in her vagina"
- August 23, 2006 Jane Doe's mother wrote to Pope Benedict XVI. She stated that Fr. Vijaya Bhaskar Godugunuru sexually assaulted her daughter in June of 2006. She also told the Pope that Fr. Vijaya Bhaskar Godugunuru was doing his studies in Rome and was a priest of the Diocese of Cuddapah, India. Jane Doe's mother asked the Pope to help them. Jane Doe's family received no response.
- October 2006 Bishop of Pensacola-Tallahassee emailed Jane Doe's mother that the Diocese had "been in direct contact with the Vatican concerning Fr. Vijaya and are gathering documents to be sent to them detailing the entire incident. The documentation will include the report of the psychologist, the sheriff and court documents they will be send to the Office in the Vatican which deals with priests who have been accused of misconduct, especially when they involve minors. The Vatican Office will in turn do a complete examination of the data and make a final disposition concerning the fitness of a priest to continue in ministry. All of this takes place through the office of the Apostolic Nuncio in Washington." (Bishop Richard email to Jane Doe's mother)
- February 16, 2007 Fr. Vijay Bhaskar Godugunuru pled no contest to aggravated assault, a 3rd degree felony. Required to return to India, undergo counseling, and not be in position of leadership over minors for a year.
- February 23, 2007 Bishop of Pensacola-Tallahassee wrote to Vatican's congregation of the doctrine of faith and provided them with all information on Father Vijay Godugunuru. (Diocese privilege log)
- Feb. 2008 Jane Doe files suit against Diocese of Pensacola-Tallahassee for abuse by Fr. Bhaskar
- April 2010 Fr. Godugunuru Vijaya Bhaskar listed on Diocese of Montepulicano-Chiusi-Pienza website on the clergy roster as being at Nome di Maria in Querce al Pino, Italy (the roster states is was last updated May 8, 2009).
