Allegations of sexual abuse have been made regarding the following deceased Vincentian priests:

1. **Rev. John J. Casey, C.M.** Earlier this month an LAPD detective sought out info re Fr. Casey at St. Vincent's Church and was referred to the provincial office. He the phoned the office and indicated that allegations had been made re Fr. Casey while he was assigned at St. Vincent's during the 1940s. I informed him that Fr. Casey had died in December, 2000. He asked the name of the place of death and I so informed him. He later came to the provincial office asking for the dates of his assignment at St. Vincent's and this information was provided.
