

Father James Vincent Fitzgerald, o.m.i. Timeline

- 1950 Ordained
- 1952 – 54 St. Joseph Novitiate, Godfrey, IL (Diocese of Springfield in Illinois)
- 1955 – 57 King’s House (Order Retreat House), Buffalo, MN (Diocese of St. Paul)
- 1957 – 61 St. Michael’s, Northome, MN; Our Lady of the Snows, Bigfork, MN; and St. Theresa’s, Effie, MN (Diocese of Duluth)
- 1963 – 64 Holy Cross, Orr, MN (Diocese of Duluth)
- 1963 – 66 Immaculate Conception, Nett Lake, MN (Diocese of Duluth)
- 1968 – 69 Indian Mission, Sisseton, SD (Diocese of Sioux Falls)

According to a 2010 lawsuit, Fitzgerald sexually abused at least two children (Victim 1 and Victim 2) while working at the Tekakwitha Orphanage on the Lake Traverse Indian Reservation

- 1968 – 79 St. Catherine’s, Squaw Lake, MN (Diocese of Duluth)
- 1973 – 74 St. Patrick’s, Kelliher, MN; St. Joseph’s, Shooks, MN (Diocese of Crookston)

During his time in Squaw Lake, MN, Fitzgerald was sent to participate in a program run by Father Francis Garvey at the Willmar State Hospital in Willmar, Minnesota. While participating in the program, Fitzgerald worked at St. Thomas More Parish in Lake Lillian, MN in the Diocese of New Ulm. Plaintiff (Doe 30) was a parishioner at St. Thomas More.

- 1976 **Fitzgerald brought Plaintiff, when Plaintiff was about 13 years old, to St. Catherine’s Parish in Squaw Lake, MN and repeatedly sexually molested him.**

- 1979 – 80 Indian Parishes and Missions (Foreign Miss.)
- 1979 – 83 St. Catherine’s, Squaw Lake, MN (Diocese of Duluth)
- 1983 – 86 St. Anne’s, Naytahwaush, MN; St. Frances Cabrini, Big Elbow, MN; St. Benedict’s, White Earth, MN (Diocese of Crookston)

During this time period, Fitzgerald sexually molested Doe 19 (Victim 4) when he was 8 or 9 years old.

1992 – 94 Oblate Provincial Offices, St. Paul, MN (Diocese of St. Paul and Minneapolis)

1994 – 2002 Missionary Oblates of Mary Immaculate, St. Henry's Oblate Residence,
