

6/12/13 Email from Bp. Prakasam to Msgr. Colletti stating he's sorry to learn about Koppala. He hopes Colletti received his previous mail in response to the information Colletti provided to him. Prakasam requests they give all legal support and help to Koppala to "come out of this problem." He asked Koppala's brother, Fr. A.S. Savio who works in the Jackson Diocese to visit him. 6/14/13 Louise Blissenbach, LICSW, reports Koppala admitted kissing. Bishop Quinn and Monsignor Colletti met with interested parish people. (LK-00015) 6/16/13 Email from A.S. Savio, Koppala's brother, to Colletti in response to Colletti's email from 6/12/14. Savio thanks Colletti for spending time with him and the Bishop and he hopes the lawyer Koppala has will prove him innocent. 7/8/13 BCA opens Koppala computer and finds: Homemade pornographic videos; clip art posters stating "Sometimes you just want to break the law." "According to Koppala's case file, there were several instances that people brought forward concerning unwanted physical contact initiated by the defendant." 7-21-13 Faribault County Register (LK-000056-57) 7/22/13 Bishop Quinn writes to Koppala at Mount Carmel Hermitage in Houston, MN, accepting his resignation from parishes in Blue Earth and Winnebago. (LK-00054-00055) Undated "Boundaries for Fr. Leo Charles to follow: let Fr. David or Sr. Rosemary know where he is going and where he is at all times; not to walk outside hermitage grounds: he can celebrate private Mass in the Chapel of his house at the Hermitage; no dressing as a cleric; no public ministry; can do manual labor in caring for the Hermitage; no visitors without permission." (LK-000136) 10/13/13 Vicar General Msgr. Colletti visits Koppala at Mount Carmel Hermitage investigating whether Koppala sent \$20K back to India. (LK-00007 & LK-00010) Memo from Colletti to Quinn stating a family from St. Francis who Father Steve 10/16/13 Peterson knows, revealed Koppala asked their mom for help for the poor and she wrote out two checks for \$10,000 each in Father Leo's name. Colletti says he will ask Koppala about it. (LK-000053) Colletti notes about meeting with Koppala who claims the money was sent to his 10/30/13 home diocese to help with schools and orphanages in India. He did not have written documentation of this. (LK-000007) 1/8/14 Bishop Quinn to Cardinal Mueller at CDF. Father Koppala released from custody and currently under supervision of the Hermits of Mount Carmel, Houston, MN.
