

Jury indicts 2 men in Nutley sex cult

Two Nutley men, who authorities say were connected to a satanic cult involving sex with orphan boys, were indicted Thursday by an Essex County grand jury.

John Sileo, 23, of Bloomfield avenue, and his friend Michael Abidiwan, 19, of Beech Street were charged in a 14-count in-

dictment with endangering the welfare of children and aggravated sexual assault. Sileo also was charged with making terroristic threats.

Sileo is in Essex County Jail in lieu of \$50,000 bail. Abidiwan is free on bail.

Police charged them with sexual assault on four Nutley boys, ages 9 to 15, after their arrest last November. Sileo, identified as

the cult leader, is charged with threatening a girl who witnessed some of the sexual episodes, according to Essex County Assistant Prosecutor Martin Lieb.

Authorities said the pair used Sileo's apartment, where the boys were whipped, chained, had wax burned upon their bodies and were forced to act like dogs, wearing collars and lapping milk from bowls.

Police said they found several guns licensed to Sileo in the apartment, handcuffs, chains, whips, a dog collar, red and black capes, a rubber mask with horns, sexually oriented material, plastic skulls bearing candles, a satanic bible and a book called "The Mark of Lucifer."

The youths were lured into the group through Sileo's position as

a Boy Scout and community leader, police said.

Police said drugs and alcohol were also used in the recruiting effort. They said the cult operated for two years and wasn't discovered until last November when the parents of some of the children learned what was happening and reported it.

Nutley Police Capt. Donald Casciano said that about seven or

The facts: John Sileo, 22, Nutley, NJ arrested 11/16/83 on 3 "sex offense" charges stemming from an alleged satonic cult operating in Nutley area and involving some 35 boys and girls age 15, 16 and 17. Drugs, alcohol, weapons, and an array of sexual material allegedly involved. Sileo WAS assistant cubmaster Pack 145, Radcli School, Nutley, through Oct. 1982. NOT NOW REGISTERED.

Michael Abidiwan, 19, Eagle Scout, CURRENTLY registered ASM Troop 147, Franklin Reformed Church, Nutley, involved. Extent, details of his involvement not immediately known. Council is processing Standards of Leadership removal papers today.

One of the above is being pictured on NY area tv, from a print, in his Scout uniform.

ACTION OR RECOMMENDATIONS: Council president advised of usual procedures and asked to forward any printed material to national communications. Advised to point out that Sileo is NOT registered with BSA and that Abidiwan is being removed.

Nutley cultist facing new sex charges

Further charges will be filed against a 22-year-old man arrested last week in connection with a devil-worshipping sex cult involving at least 35 teenagers, Nutley police said yesterday.

"At this point, this is far from over," Acting Police Chief Robert DeLitta said.

John Sileo of 168 Bloomfield Ave. was arrested after police raided his home and confiscated various drug paraphernalia and sexually oriented material, DeLitta said. Also taken from Sileo's residence were three rifles and two handguns, which police said Sileo legally possessed.

Sileo was charged with three sex offenses and is being held in the Essex County Jail, Newark, in lieu of \$75,000 bond.

An investigation into Sileo's activities was started three weeks ago when some of the parents of the teenaged victims complained to police, DeLitta said.

Sileo lured his victims, who ranged from 15 to 17, with drugs and alcohol, said Det. Sgt. John Holland, in charge of the investigation.

"I realized we were becoming a cult," Holland quoted one of the female victims as telling him. He said Sileo apparently used a form of devil worship as an initiation ritual. Found in Sileo's home was a crimson-colored robe and a pair of horns, Holland said.

Sileo had been involved with the Boy Scouts in Nutley and been associated with other civic organizations, Holland said.

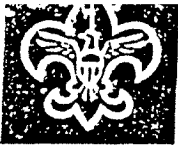

Gentlemen:

The enclosed news article refers to Mr. John Sileo, 168 Bloomfield Ave., Nutley, NJ 07110, Birthday May 1961, formerly registered as a Den Assistant in Pack 145, sponsored by Padcliff School PTA, Nutley, from October 1980 to October 1981.

Mr. Sileo has been denied registration locally due to a Neurological Impairment which causes difficulty in relating and functioning as an Adult Leader. We did not and could not find any indication of moral problems as indicated in this article. Pack 145 registered him as an Assistant; however, soon after registration, did not allow him to continue in their activities. His problems were reviewed with the Nutley Family Services Agency over the past 3 1/2 years and we have avoided registering him except for this aforementioned period since he was a Scout in Troop 159, a Troop for the mentally handicapped, when he was under 18 years of age.

Michael Abidiwan is an Eagle Scout as of July 29, 1982, and is currently registered as an Assistant Scoutmaster in Troop 147, sponsored by Franklin Reformed Church, Nutley, N.J. until February 1984.

I have informed their Troop Leaders and Church Pastor that we are suspending his membership and requesting his membership card and Eagle credentials and badge be returned.

The Detective in charge of this case will furnish additional information including both men's description in the first week of December and I will forward the full report to you at that time.




