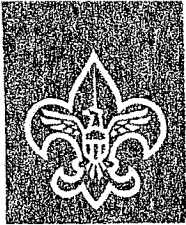

Dear Paul,

Enclosed herewith is a letter to me from Juan Anderson. We feel this letter was written by Nanci Rude, a committee member of one of the Fort Hood Troops. Ms Rude recently tried to register Juan Anderson as a committee member of her Troop, but we returned the application of Jaun Anderson to her with the explanation of why we could not accept same.

Reference Juan's enclosed letter: It seems that the question asked is: Why can the boys be registered in Scouting if he cannot be?

Perhaps this is a valid question, and here is where we need your help in the answer or interpretation of our policy.

Following are some facts which may have some bearing on the issue:

1. The [redacted] boy, currently registered in T-229, Feb 1980 expiration date, has withdrawn from Scouting & is inactive.
2. The [redacted] boy's parents have transferred him to T-222, (a Fort Hood sponsored unit) with the approval of the Scoutmaster, Troop Committee Chairman, and Battalion Commander of the military unit sponsoring the Troop, who all have full knowledge of the issue.

I would appreciate your advice on any course of action we should take.

This letter is a follow up of our telephone conversation held in June. As I recall that conversation, you had agreed to consider the withdrawal of registrations of all parties concerned upon the outcome of the trial. Those involved were [REDACTED] and [REDACTED].

The outcome of the trial was, I pleaded guilty as charged. The details of that trial were not printed in the newspapers or broadcast on the local radio stations. Therefore some of the recorded facts involving both boys are:

1. No force was used either mental or physical.
2. No drugs or alcohol was used to persuade the boys, and
3. The boys willingly participated in a homosexual activity.


In the eyes of the law and by virtue of the fact I pleaded guilty I was assessed a two to five year prison sentence unprobated. I sincerely believe the punishment was unjust. Therefore I have filed an appeal. The by-laws state homosexual activities on the part of leaders or Scouts will not be tolerated. Therefore, if I pleaded guilty to homosexual activities with two Scouts, no force used, how can I have my registration pulled and the boys equally involve allowed to remain active in the Scouting program? Is this just or fair?

Ben, which ever way your decision goes thank you for the great Scouting in this Council. Thanks too for the pleasure of calling you friend. Just for your information Ben, I'd like for you to know I have been seeing a psychiatrist since May. I fully intend to stay in therapy until my doctor feels I can handle my shortcoming.

I know I'll never want to be a Scoutmaster again, however I would like the oportunity to work in the Scouting program again actively as I'm sure [REDACTED] and [REDACTED] would too.

I eagerly await your decision.


This is to request termination of the registration of the above referenced Scouter. He is currently registered as Scoutmaster of Troop 299, Fort Hood, Texas.

Dear Ben:

Please begin whatever steps are necessary to terminate the registration of Staff Sergeant Juan Maceos Anderson, Scoutmaster of 6 A.C.C.B. Troop 299, Ft Hood Texas, (The Charter expiration date is 29 Feb 80.) I also recommend that the National Council be requested not to accept Andersons' registration at any future time for the following reasons:

At 3:00 PM on Thursday, 15 Feb 79, I received a call from MAJ [REDACTED], Committee Chairman of Troop 229, stating that one of the families in the Troop had filed charges of homosexual activity against Anderson at which time I called you for guidance. Due to the Federal Privacy Act, I cannot get a copy of the charges filed, but here is a chronological account of events, as best as I can reconstruct them.

After Troop 229's meeting on Wed, 14 Feb 79, Mrs. [REDACTED] visited with her 16 year old son [REDACTED] about something that was troubling the boy. [REDACTED] admitted having homosexual activity with Anderson (I do not know the exact types of activity), and implicated several other boys. Mrs. [REDACTED] filed charges against Anderson at 3:30 AM on 15 Feb 79 with the Killeen Police Department. [REDACTED] then visited with [REDACTED], mother of [REDACTED] - a 15 year old member of the Troop and next-door neighbor of the [REDACTED]s'. Mrs. [REDACTED], after visiting with [REDACTED] and discovering that the allegation was true, filed similar charges against Anderson in late afternoon on 15 Feb 79. Anderson was arrested on 15 Feb on charges of Indecency with a Child, a third degree felony, arraigned and released on \$5,000 bond. On Monday, Feb 19, Anderson was arrested on charges of Sexual Abuse ([REDACTED] case), a second degree felony, arraigned and released on \$10,000 Bond.

Mrs. [REDACTED] informed Maj. [REDACTED] of the charges in the afternoon of 15 Feb; he then contacted me. [REDACTED] visited with Anderson Thursday evening for 2½ to 3 hours, during which conversation Anderson admitted to being a homosexual - I do not know whether or not he admitted guilt to the felony charge. On Friday morning, 16 Feb 79, I received a call from [REDACTED] informing me of the substance of the conversation with Anderson, and asked for advice. I recommended that the Troop Committee and Chartered Organization be advise as soon as possible to take action.

MAJ [redacted] advised me that Anderson had been relieved as Scoutmaster after the Thursday evening visit, and that the Committee would meet on Mon., 19 Feb and asked that I be present.

I met with the Committee from 1:00 to 3:00 PM. They affirmed the decision to remove Anderson as Scoutmaster and planned a sound course of action to inform the families of all the boys in the troop prior to the Troop meeting on Wednesday. It was agreed that trying to protect the identities of the boys ([redacted]) would be most helpful in protecting them from peer pressure, in which I agreed. MAJ [redacted] and I then personally visited with the [redacted] and [redacted] families (The District Chairman and District Commissioner had been kept abreast of all developments, but due to business priorities, could not join us for these visits). Both families understand the BSA position on homosexuality, and do not hold the movement responsible; they are, however, understandably angry, hurt, etc., that the events took place. The boys will stay active with the Troop - primarily because the boys enjoy the program and the parents see the good that we do, and secondarily because withdrawal from the Troop will serve to identify the boys to their peers, and increase the possibility of ridicule being directed to them.

On Monday 19 Feb 79, KCEN-TV devoted several minutes covering this story, listing the boys' ages and the fact that they are Scouts. That evening, and on Tuesday, 20 Feb, I called or visited the news editors of all radio stations and newspapers in the Killee/Copperas Cove area asking them not to sensationalize the story, and not to list the boys' ages - stressing the effects the publicity would have on the boys. All agreed, and (so far) the coverage given has been relatively low-key.

Attached to this statement are: 1) a letter from the Troop 229 Committee, endorsed by the head of the Chartered Organization, requesting that Juan be terminated effective 15 Feb; 2) a letter from [redacted] and [redacted] requesting same; and 3) a copy of the case disposition letter sent to the [redacted] from Killeen Police Department stating that the arrest took place. The Juvenile Division of Killeen Police Department and the Bell County District Attorney cannot give us anything in writing, pending judicial disposition, but from visiting with them, there is virtually no chance of Anderson being acquitted. I will be receiving letters from Mrs. [redacted] similar to the [redacted]'s.

Finally, yesterday I visited by phone with [redacted]. She said that some good friends of theirs who are now at Fort Wainwright Alaska have TWO sons who are similarly involved; Mrs [redacted] has sent a statement of particulars to the National Council - I'll be getting a copy of this too. In visiting with Ed Jones of our staff, I found out that two years ago, Anderson was asked to leave Camp Tahuaya in mid week due to rumors of homosexual involvement with the older of these boys. Nothing could be proved so nothing was said.

It is the concern and love for scouting that brings me once again to write this letter in regards to my scouting past, present, and most of all future. I firmly believe that because of my concern and love for the scouting program, that I haven't and will never fail in given my full and just support to scouting.

In the year of 1966, I joined the US Army and when I was assigned to as army post in Kansas I decided that I would join a scout troop. However, my assignment there was short and I soon left for Vietnam. From Vietnam I went from one state to another and did not get involved in the scouting program. Then I received an assignment to Okinawa and while there I registered as scoutmaster of Troop #1. During the time that I was scoutmaster of this troop, I was selected to attend the Woodbadge Training. A year later I became scoutmaster of Troop #113, which was my last year in Okinawa. Upon my return to the states, I joined a troop on Fort Lee. Here I earned the Scoutmaster's Award. Two months later I was asked to be a Neighborhood Commissioner. 

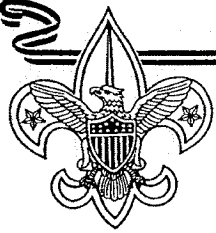

I have your correspondence concerning Mr. Juan M. Anderson expressing his interest in registering once again with the Boy Scouts of America. As you know, Mr. Anderson had been working with a Troop at Fort Lee and attempted registration as a Neighborhood Commissioner and it was returned by you to us. I called him on at that time and we had a long discussion. I then felt that perhaps he was being penalized a bit too much for an offense that happened several years ago and had great sympathy for his efforts to seek registration.

Since that time however, I have talked to the Scoutmaster of the Unit with which Mr. Anderson was working and the Institutional Representative who is exceptionally active in Scouting. Both have advised me that Mr. Anderson operated very strangely for an Assistant Scoutmaster. Without knowledge of his previous problems, they expressed to me concern over his tendency to be alone with boys too often, particularly to invite individual boys to go swimming with him and other suspicious activities that cause them to question his desirability as an Assistant Scoutmaster.

Every person serving in any official relationship with the Boy Scouts of America shall subscribe to the statement of religious principle, the Scout Oath and Law, and the Bylaws. Each such person either shall be a citizen of the United States or shall satisfy one of the following alternative requirements if applicable to him: (a) A person other than a member of the Executive Board or a regional chairman (all of whom must be citizens of the United States) shall legally declare his intention to become a citizen of the United States; (b) A visiting alien, whether adult or minor, shall satisfy the requirements of Article XVI, Section 6, Clause 4 of the Bylaws. All adult leaders must be 21 years of age except assistant Scoutmasters, associate Advisors, and merit badge counselors for subjects in which the principal requirements are for physical skill only. These leaders may be 18 years of age.

**PURPOSE OF THE BOY SCOUTS OF AMERICA**

The purpose of the Corporation is as set forth in the original certificate of incorporation under the laws of the District of Columbia, dated February 8, 1910, and restated in the Act of Incorporation enacted by the Congress of the United States of America on June 15, 1916, as follows: "That the purpose of this corporation shall be to promote, through organization, and cooperation with other agencies, the ability of boys to do things for themselves and others, to train them in Scoutcraft, and to teach them patriotism, courage, self-reliance,

and kindred virtues, using the methods which are now in common use by Boy Scouts." In achieving this purpose, emphasis shall be placed upon its educational program and the oaths, promises, and codes of the Scout program for character development, citizenship training, mental and physical fitness. Article I, Section 2.

**DECLARATION OF RELIGIOUS PRINCIPLE**

The Boy Scouts of America maintains that no boy can grow into the best kind of citizen without recognizing his obligation to God. In the first part of the Scout Oath or Promise the boy declares, "On my honor I will do my best to do my duty to God and my country and to obey the Scout Law." The recognition of God as the ruling and leading power in the universe and the grateful acknowledgment of His favors and blessings are necessary to the best type of citizenship and are wholesome precepts in the education of the growing boy. No matter what the religious faith of the boy may be, this fundamental need of good citizenship should be kept before him. The Boy Scouts of America therefore recognizes the religious element in the training of the boy, but it is absolutely nonsectarian in its attitude toward that religious training. Its policy is that the organization or institution with which the Scout is connected shall give definite attention to his religious life.

Only persons willing to subscribe to this declaration of principle shall be entitled to certificates of leadership in carrying out the Scout program. Article II, Section 2.
