16 Indicted By County Grand Jury

ALBION, La. (AP)—Six people have been indicted on various charges by an Orleans County Grand Jury, according to District Attorney Curtis L. Lyman Jr. The indicted are: John Sedwick, 72, of 701 South Main St., charged with felony driving while intoxicated; Rodolfo V. Verdesla, 22, of 617 Genesee St., indicted on charges of second-degree criminal possession of a forged instrument; second-degree forgery; and petit larceny; and Jeanne Shawn Verdesla, 19, of 617 Genesee St., Medina, charged with second-degree forgery. Also, Hector J. Fuentes St., 40, of 633 East Center St., Medina, indicted on charges of first-degree rape, first-degree sodomy and incest; Kyle R. Marciszewski, 18, of 123 West Ave., Lyndonville, charged with third-degree burglary and petit larceny; Richard T. Fulwell, 22, of

505 Ann St., Medina, charged with second-degree assault; Robert Letta, no age available, of 2205 Edgemere Dr., Rochester, indicted for second-degree assault; and Timothy W. Kreef, 17, of 83 Main St., Hilltop, charged with first-degree perjury. The Grand Jury has also returned indictments against: Michael Nowak, 18, of 18 North St., Holley, and Rodney Shaver, no age available, of 76 Public Square, Holley, charging both with third-degree robbery and petit larceny; Lynn Ambrose, 41, of 117 Einsign

Ave., Medina, indicted for second-degree grand larceny and making false welfare application; Perry Letta, 23, of 2589 Lyell Ave., Rochester, charged with second-degree grand larceny; Karl W. Poler, 38, of 3082 Horan Rd., Medina, charged with felony driving while intoxicated; and Theodore J. Rhum, 23, of 221 South Ave., Medina, charged with second-degree forgery.
