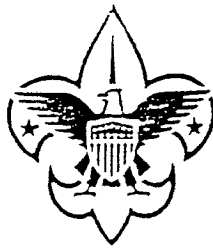




Dear Jerry:

We have had previous communication concerning the above named individual. Originally, I received a phone call from LaVerne Gaugler indicating this person had been charged with sexual abuse of boys and he had been arrested in October of 1988.

We have never received anything from your council, since that time and we talked in early summer and you indicated you had never heard of Douglas Getman. Is there some way in which you can check the records related to Flessels, NY. Apparently, from what I found out the Hiawatha Council indicates this town is in your council territory. Apparently, there must not be any scout troop in this particular community.

If you cannot get us any further information at this time, we will just have to drop this whole matter, since we cannot keep somebody on the file to stop registration, unless we have some definite proof that they have done something wrong. We certainly do not want to damage anyone's reputation unless we have the substantiating information.
