At least on victim forced to sign confidentiality agreements

At least ten more boys come forward to allege abuse

Lay Review Board saw none of the allegations

The year 1991 was a bad one for Fr. Michael Gibbney. It was the year of his first allegation of sexual abuse, and the beginning of the end of his career as a priest. As a result of the allegation, Gibbney was sent to Jemez Springs, New Mexico for treatment. In a letter, Gibbney states that he is "looking forward" to serving again in the Joliet Diocese.

Instead, Gibbney took a leave of absence in 1992 and never returned to active ministry. But the allegations—that spanned his 20-year career as a priest—continued. In 1994, one of Gibbney's victims was forced to sign a confidentiality agreement.

Things did not remain quiet for long. In 2002, more allegations began to flood the Joliet Diocese. By 2010, the Diocese of Joliet admitted that Gibbney had at least eleven known victims. They also stated that none of the allegations were reviewed by the Lay Review Board because the charges pre-dated 2002.

Gibbney was laicized in 2010 to marry. He is living in Oak Forest, Illinois.

Doe K reports to Kaffer that in 1978 Doe K had three year sexual relationship with Gibbney (Doe K was 13-16 years old). Doe K would stay at rectory – Gibbney would get parent's permission. (174)

1/27/92	Resigns as pastor from Immaculate Conception Parish, Morris, IL due to personal spiritual and emotional reasons. Enter Jemez Program. Looks forward to serving again in the Joliet Diocese after the program. (179)
4/16/92	Gibbney requests from Bishop Imesch a one-year leave of absence from the Diocese of Joliet and from active priestly ministry.
6/1/92	Withdrew from active ministry. (604)

4/25/02	Thomas A. O'Donnell interviewed Doe K. Writes memo to Diocesan Review Committee. Memo states date of interview as April 25, 2002. Doe was abused approximately 2 times a month for three years. Doe states Gibbney left Mary Queen of Heaven abruptly and was assigned to, he thinks, St. Andrew in Bolingbrook. Doe visited Gibbney there one time and was sexually abused. (273-74)
4/29/02	O'Donnell writes memo to Diocesan Review Committee of interview with another Doe who has knowledge of Gibbney and inappropriate behavior. Mentioned Doe K and Gibbney had a relationship and Doe K spent the night at the rectory often. (276)
4/30/02	O'Donnell writes memo to Diocesan Review Committee of interview with another Doe, Doe B Q, who has knowledge of Gibbney. Q attended Mary Queen of Heaven in Elmhurst. Stated Doe K has a "relationship" with Gibbney and was often abused by Gibbney. Q denies being abused other than wrestling matches. (277)
5/2/02	Memo to File from Bishop Goedert regarding Mr. PK's call on April 30, 2002 – returned call on 5/2/02. In around 4 th to 6 th grade while attending Mary
