Thank you for the information which you sent us concerning Guillermo Gonzalez. This information will certainly be most helpful to us in refusing registration at a later time.

We would like more information from you concerning this matter which will help to strengthen our file, in case neither one of us are on our present jobs when registration applications might be processed.

If you can secure statements from individuals or copies of the police record or newspaper clippings, these will help to strengthen us. We would also like to know the outcome of the charges after the trial takes place. It is most helpful to have this so that we know the final outcome, since this indicates whether he was judged guilty or innocent.

How did Mr. Gonzalez become informed of his rejections as a leader of the Boy Scouts of America? If he was registered at the time of his arrest did someone approach him from the chartered organization or secure a letter of resignation? This also will be helpful if we can have a copy of the information.

Let us know if we can be of any help.

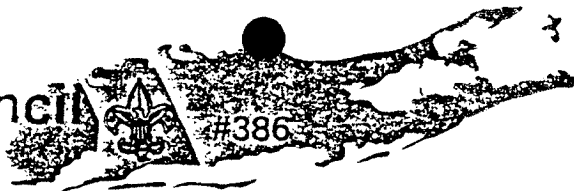

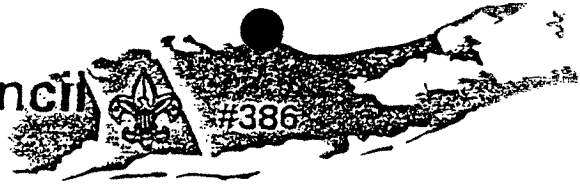
