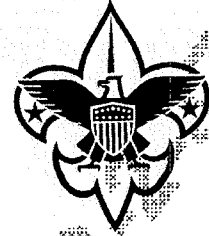

Subject: Request for appeal on basis of mistaken identity.

Dear Sir,

In response to your letter of date. I am sorry I haven't replied sooner. In 1994 my doctor had me step down from Assistant Scoutmaster to a Committee member for medical reason. At that time I was informed that my registration had been denied. At that point I was not well so I did question the denial. However since then my health is some-what better and my son wants me with him. My son is in O.A. and only needs swimming and an Eagle project to become an Eagle Scout. I have compiled a life history and I have chronicled my scouting activity which I am enclosing, so that you may review my case of mistaken identity. While I was stationed at Sembach A.F.B. where I was a member of the Transatlantic Council, Scoutmaster Troop #58, I was informed that a Robert Kelly in Brooklyn, New York was trying to use my Boy Scouting records for his use. The Transatlantic office informed the Brooklyn, New York Boy Scout office that those records were mine and that I was in Germany and not to let him have or use my records. That was all I knew. I heard nothing else until I received your denial of registration. I know I should of brought this up sooner but I was barely managing the every day functions without adding scouting on top of everything else.

At present, I work for Stanley Smith Security Inc. In December of 1992, I filed for a Eugene, Oregon Security license. I needed this to work in Eugene, OR. The Eugene Police Department did a complete criminal background investigation through the F.B.I., Children Services and Police Agencies. In January 1993 I was issued a Security Officers License.

My description is as follows:

I am a white male 5' 8 1/2", 175 lbs., Hair was black now grey and balding. Eyes blue. I have an appendectomy scar on my abdomen and I have a 16" scar on my left knee.

I was born August 17, 1934, as Robert Kelly, at Brooklyn, New York. Hospital address, 753 Bushent Ave. Brooklyn, New York. I lived at 371 Cheancy Street, Brooklyn, New York. In 1940 we moved to Coney Island, Brooklyn, New York. I went to Our Lady of Solace School, West Third Street and Mermaid Ave. Brooklyn, New York, from December 1940 through June 1943. We then moved to 27 Center Place, (Benson Hurst) Brooklyn, New York. The Schools I went to P.S. 101 Benson Ave. and Third Ave., Brooklyn, New York from November 1943 to June 1947. David A. Boody, Junior High School, S.W. Third Street Brooklyn, New York from September 1947 to June 1950. Lafayette High School, Benson Ave. Brooklyn, New York from September 1950 to February 1952. I am Catholic. I was Confirmed as Robert James Kelly. St. Mary's Brooklyn, New York.

June 19, 1952 I enlisted in the U.S. Air Force, Serial No. AF12404705.

From June 20, 1952 to October 1952, Rome Air Force Base, Basic Training

October 1952 to February 1955, Geiger Field Spokane, Washington. Got married.

March 1955 to May 1956, stationed at several bases in Japan.

May 1956 to August 1956, discharged from USAF. Working at Boeing Co. Seattle, Washington.

Reenlisted in USAF. August 1956 to July 1959, stationed at Paine Air Force Base, Everett, Washington. Wife divorced me.

July 1959 to October 1962, Kingsley Field, Klamath Falls, Oregon.

November 1960 married Joyce A. Peterson, Kelly. My present wife.

October 1962 to November 1965, Aviano AFB, Italy

November 1965 to October 1968, Vandenberg AFB, California

October 1968 to August 1972, Sembach AB, Germany.

August 1972 to October 1972, Oakridge, Oregon.

Retired from U.S. Air Force October 1, 1972. Served 20 Years.

October 1972 to May 1973, Hotel and rental Duplex, Eugene, Oregon.



The following letter is sent regarding the registration request of Robert J. Kelly, and is a follow-up of our telephone conversation of May 30, 1995.

There is considerable evidence that this is not the Robert J. Kelly placed on the confidential file in 1964 by the Greater New York councils.

Since our telephone conversation, I have checked with the public library and they verify that in 1964 Robert J. Kelly was living in Eugene at 1200 Blkay Drive, and was bar manager of Cathy's Restaurant.

The February 18, 1964 letter from Greater New York councils indicates his age at that time was twenty-eight. His 1994 adult application shows a birthdate of 8/17/34.

The 1964 letter identifies a long scar on left side of neck below jawbone. This was not observed by me, and he claims he has no such scar.

He points out that he works for a security company and has been checked for security purposes.

Enclosed is a copy of our June 1994 letter denying his registration at that time, and a copy of the check which was returned to him.

Wolfe Road, PO Box 3464, Sunnyvale, CA 94088-3464. In your request, you must include your version of what occurred in support of your claim that registration should not have been denied.
2. Upon receipt of your written request, a committee will be appointed to review the situation.
3. The committee will review the facts as presented and may interview you or any other persons whose testimony might assist them in arriving at a reasonable course of action.
4. You will receive a letter setting forth the findings of the committee.
5. If you are dissatisfied with the results of the Regional review, you may request further review by the national Council. The decision of the National Council will be final.

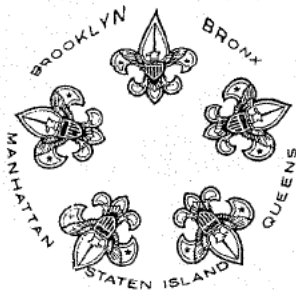

Robert J. Kelly, Scoutmaster of T203, Flatbush District, sponsored by the Flatbush Presbyterian Church has been charged by his unit committee with molesting boys on a winter camping trip. Subsequent investigation by the committee has revealed that this has occurred on several recent camping trips.

Investigation has shown that at least four boys have been molested, three of which were ~~some~~ ^{sons} of Troop Committeemen. Present when the facts were presented to me were Robert Gray, Abe ~~Silverman~~ Silverman, Byron Maher [REDACTED] and Tony Pinnavaia.

I informed Rev. Ralph Hibbitt, minister for the sponsoring institution of the charges ^{made} by the committee. Kelly was then asked to sit down with Rev. Hibbitt and myself to discuss the alleged accusations. Kelly at first expressed shock that anyone would think him "that way". He then said, "I don't know why anyone would say such a thing, but if the committee said it's true, it must be. They are all my close friends and wouldn't lie about me."

Resignation of ROBERT J. KELLY (JR.) from position of Scoutmaster, Troop 203, Flatbush District, Flatbush Presbyterian Church, E. 23 Street and Foster Avenue, Brooklyn, New York

SCOUT #1 (Age: 13) - This Scout voluntarily approached a member of the Committee (Trop 203) with the following complaint. On occasions, for the past year-and-a-half, particularly during over-night camping trips, the above named Scoutmaster took liberties with his person. The Scoutmaster would first massage the boy's midriff while talking to him and, after a time, his hand would move lower and lower in the direction of the boy's groin. At this point, the Scoutmaster proceeded to fondle the boy's organ. No other physical contact reported.

** SCOUT #2 (Age: 13½) - In essence, same as above. In addition, this Scout reported that his sleep was interrupted by steady movement and pressure exerted in the region of his buttocks. He was aroused from his sleep, turned around, and found the Scoutmaster beside him (facing in the direction in which he turned). The Scout reported that the zipper of his sleeping bag had been pulled down to a point below his buttocks. (Please refer to double '**' asterisk.)

He had also experienced the same treatment that Scout #1 reported, but for a longer period - approximately two-and-a-half years.

** At the time this incident occurred, the Scout was on an overnight camping trip and occupied a tent together with the Scoutmaster and another junior leader. The Scoutmaster occupied the center portion of the tent, placing himself between the two Scouts.

SCOUT #3 (Age: Approx. 14) Reported that he was startled out of his sleep when he felt someone's hand on his groin which proved to be that of the Scoutmaster. He rolled over in his sleeping bag in an effort to break this contact. He expressed his desire to leave the troop and further stated that he will make this fact known to his father.. The father of this boy conferred with the committee and stated that the matter will

~~be pursued no further especially since~~ in view of the fact the resignation of the Scoutmaster was in order.
