Troop S0065 - Elgin, Minnesota

Late September - We received a call from Tom Schmitz, a District Executive from the Mankato, Minnesota Council. Tom stated he had recently seen a TV news article relating to Child Abuse with a YMCA Camp and Tom thought he recognized the name of Ken J. Knoll from summer camp (B.S.A.).

Tim called the Gamehaven Council, BSA and spoke with Jeff Schwab, Field Director. Tom stated he saw the article but didn't positively identify Ken Knoll - he thought it sounded familiar.

Jeff then took information to Karl Rowley, Scout Executive, who instructed Jeff to contact the Police Department for further follow up. Jeff did so, contacting the Sheriff Department and no confirmation of any Child Abuse came back.

Jeff reported this to Karl and upon Karl's recommendation, contacted Tom Schmitz and found that he had investigated and found nothing.

No further action was taken until Bob O'Connor, District Executive for the Council happened upon a problem when working with the unit in regards to rechartering. At that point, Bob contacted Karl Rowley immediately to inform him of the change in status regarding Ken Knoll.

According to Ken's mother, he was living in the cities and no longer was active with the Troop. Bob, at that point, contacted the Scoutmaster in regards to rechartering and in the midst of conversation the Scoutmaster stated that Ken was in the cities in treatment for an incident regarding a young boy. Bob believes that Ken has not been active with the troop since the summer of 1990 and is not reregistering with the troop in February 1991.

The Scoutmaster did not indicate any inappropriate behavior on Ken's part in serving as an adult leader with the Boy Scouts of America.

Conversation with Ron Kurth, Chartered Organization Representative and Institutional Head and Jeff Schwab.

Regarding - Ken Knoll of Elgin, Minnesota - Troop S0065.

Spoke with Ron at 4:50 P.M. on February 19, 1991 in regards to current situation.

Ron was aware of the incident with Ken and had indicated to Jeff Schwab that the incident occurred in 1990 at a YMCA Camp.

Ron also acknowledged that Ken was in the Minneapolis - St. Paul, Minnesota area undergoing treatment for his conduct.

Ron was very clear to point out that he had absolutely no knowledge of inappropriate behavior with boys in Scouting. The troop always adheres to two deep leadership and until the incident became public had no idea that Ken may have been an abuser.

Ron also confirmed that Ken has not been active with the troop since the incident was made public and that the Troop Committee had no intention of registering Ken again at recharter time.
