2/21/91 2:30-3:00 P.M.	Mr. Kistner was brought in to see me by Ike Easterling, District Director in Newark.
	Mr. Kistner explained that a Cub Scout by the name of state of Pack 529 at the sin Newark was saying things about Mr. Kistner that were false. Mr. Kistner indicated that on Wednesday, February 13, he transported home after the Cub Scout meeting in his car, and that two other boys, (?) , went with him. Mr. Kistner indicated that to drive or help drive the car and climbed onto his lap to steer. Mr. Kistner indicated that he told he couldn't and made him get down. Mr. Kistner said nothing happened and reminded me that two other boys were in the car. Mr. Kistner wanted me to call a friend and neighbor and a member of the Pack Committee. I'm not sure why. Mr. Kistner's appearance concerned me. He had scratches on the left side of his neck, blotchy patches of beard and no beard on his face, his eyes looked strange and he kept sniffing. He acted and looked to have a mental handicap.
	I gathered information from Mr. Kistner and told him that I would look into the matter and either he could call me or I would call him. He told me that the Pack leaders told him to stay away from Cub Scouts for the next week. I reaffirmed their request.
2/21/91 4:00 P.M.	(Phone Concerning Mr. Kistner and Concerning Mr.
	She had noted that was upset when he arrived home from Cub Scouts. In pursuing the reason, stated that on the way to Cub Scouts, Mr. Kistner offered him a chance to help drive the car and invited him to sit on his lap, which he did. In route to the meeting, the boy felt Mr. Kistner begin to move under him, and then something hard was felt against his backside. That is as far as it goes. Stated that shared that she had asked Mr. Kistner to take to the meeting. He said he was scared and that he still had to ride home with Mr. Kistner. (Note: Newark.) She used to live at Newark.)
2/22/91 A.M.	I gave her the number of DYFUS in Trenton and shared our concern. I told her that I was investigating and was next going to contact DYFUS myself. I asked her to call me if needed and that I would be back to her.

Called Lt. Michael Luzzi, Prosecutor's Office, shared information with 2/22/91 him. He asked me to complete my memorandum and to mail it to him for 12 Noon review and follow up.

Secretary typed memorandum, mailed copy to Lt. Luzzi, prepared a file 2/25/91 folder on Mr. Kistner, and then prepared the Ineligible Volunteer Record Sheet, the letter denying registration and appeal form. I requested Mr. Kistner's registration fee in the form of a check. I plan to visit Mr. Kistner with another member of the staff later today or tomorrow.

Peter Kistner was called and met with Alan Greene and I at 3:10 P.M. today. 2/28/91 I presented him with the denial letter and review procedure, I read the letter to him and gave him his registration back in the form of a \$7.00 check. I explained that his story and the boy's story were very different, that we were not making a decision of guilt or innocence, but that we were removing him based on our right to uphold the privilege of membership.

If you wish to have this decision reviewed by a B.S.A. regional review commuttee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a B.S.A. member should be granted. The procedures for a review of this decision are attached.

The following information is provided should you desire a review by the Northeast Region, B.S.A., of the decision to deny your registration.

- 1. Within 60 days, you must request in writing a review of this decision. Your request should be sent to: Northeast Region, B.S.A., PO Box 350, Dayton, New Jersey 08810-0350. In your request you must include your version of what occurred in support of your claim that registration should not have been denied.
- 2. Upon the receipt of your written request, a committee will be appointed to review the situation.
- 3. If the regional review committee determines that a review hearing is necessary, the committee will advise you whether or not you may attend. In some instances, no useful purpose would be served by having the applicant present. The hearing is not adversarial in nature and neither the committee nor you, if you attend, will be represented by legal counsel. If you wish, in the event you attend, you may be accompanied by no more than two other individuals if their testimony might assist the committee in discovering the truth and arriving at a correct decision.
- 4. The committee will review the facts as presented, and may interview any persons whose testimony might assist them in arriving at a correct decision.
- 5. You will receive a letter setting forth the decision of the committee.
- 6. If you are dissatisfied with the decision of a regional review, you may request a further review by the National Council. The decision of the National Council will be final.
