Mr. Milczarek was previously associated with the Boy Scouts of America in the capacity of Assistant Scout Master and his Order and Conditions of Probation specifically prohibit contact with minors under the age of 17.



As a result of my asking Investigator Long to let the family of the abused boy know we would pay for counseling, I received a call from a [REDACTED] indicating her son was one of the abused Scouts and that she very much appreciated our offer to help as she felt her son needed support (she indicated that emotions were further complicated by the fact that she would shortly undergo cancer surgery). I advised her to proceed with the counseling and to send us the bill.

We did receive a bill from Wendy Evers Gordon, PhD. for services rendered to the family (name was spelled incorrectly on the bill). We paid this bill as you advised and are sending a copy for reimbursement.

I am also enclosing a copy of a newspaper article reporting additional charges filed by the Onondaga County Sheriff's Dept.

I will continue to update you as additional information becomes known.

Scoutmaster faces sex charge

A scoutmaster, accused two weeks ago of sodomizing two members of his troop, was arrested Monday by Onondaga County sheriff's deputies who accused him of molesting one of the boys outside a Cicero shopping mall.

Deputies charged Charles L. Milczarek, 40, of 404 E. Herman St., East Syracuse, with single counts of third-degree sodomy, third-degree sexual abuse and endangering the welfare of a child.

Milczarek was arraigned before Salina Town Justice Helen Burnham and was released on his own recognizance, deputies said.

The newest charges stem from an encounter that occurred in the

Penn Can Mall parking lot on July 4, deputies said.

City police charged Milczarek with second-degree sodomy, second-degree sexual abuse and endangering the welfare of a child. Those charges are pending.

Milczarek, scoutmaster of Troop 500 in East Syracuse, was suspended from the Boy Scouts after his arrest last month.

None of the abuse occurred during scout-sponsored camping trips or other activities, police said.

The abuse began about three years ago and occurred regularly, according to statements Milczarek and the two boys gave to city police.

Sheriff's department detectives began their investigation after city police investigators alerted them.

FACTS REGARDING CHARLES L. MILCZAREKOctober 20, 1989

At approximately 3:30 p.m., I received a call from Investigator Mike Long, of the Child Abuse Unit of the Syracuse Police Department, indicating that Charles L. Milczarek, Scoutmaster of Troop 500 in East Syracuse had been arrested for Sodomy and Sexual Abuse and was currently in jail. He said that the abuse involved a Scout - not in his unit - not on Scouting activities - but acquaintance and relationship began through Scouting. He suspects that this might be just the "tip of the iceberg" - that there may be others. Because the boy is a minor, he is unable to release the name.

I immediately informed Rev. Douglas Eddy, Pastor of the East Syracuse United Church, Chartered Partner, of the situation and that we were suspending Mr. Milczarek from all Scouting activity. I then prepared the letter as described in the latest edition of "Child Sexual Abuse", How to Deal With It", and because he was at that time in jail, sent it Registered Mail - Return Receipt Requested to his home. I then called Registration Service, spoke with Claire and informed her of the situation, that the letter had been sent, that he should be placed on the Ineligible Volunteer File, that we have removed his name from our computer and that we would send a full report as soon as we received a copy of the Arrest Report. I also got word to Charles Ball, Assistant Regional Director, who was attending the Northeast Region Board Meeting.

At 4:30 p.m. I received a call from John Doherty, a reporter from the Syracuse Herald Journal. The article (copy enclosed) appeared in the next day's paper. It is inaccurate in that it reported that the abuse took place with boys in Milczarek's Troop. He asked if we had had any complaints. I responded - "not of this nature - that we have had some complaints about his leadership style".

October 21, 1989

I advised Council President and Vice President for Public Relations whom I had been unable to reach Friday night. I left a message on the answering machine at the home of our Legal Counsel. (He was out of town and did not call me until Monday morning, October 23rd.) I spoke again with Rev. Eddy. He had met with Mr. Milczarek, who is a member of his church. I suggested he call the Unit leadership and the parents of the boys in his Troop to let them know we were on top of the situation and to calm them before any anxiety began to build. I also suggested he listen very carefully for any hint of problems with boys in the Troop.

October 23, 1989

I advised our Council attorney and reviewed steps taken - he felt it was handled correctly. I received a call from Rev. Eddy indicating he had talked with all families, in fact had a special meeting Sunday night. He said they were surprised and he feels that no abuse had occurred with Scouts in the Troop (at least with current membership). They are putting in a plan to strengthen the Troop leadership and select a new Scoutmaster.

October 24, 1989

I called Investigator Long's office to indicate we had not received the Arrest Report as yet. He called back while I was out and spoke with my secretary (copy of her notes of the conversation enclosed) He indicated that the newspaper article had generated several calls to him, one of those calls indicated that Mr. Milczarek had been asked to resign from another Troop in 1979 as a result of several complaints of this nature. My secretary was the Scout Executive's secretary at that time and knew of no such complaints. We checked the file to find no indication of a complaint. A District Executive's Check Out Report at that time indicated no problems other than Milczarek did not participate in District or Council activities. I also spoke with Commissioners who had served that community at that time. They knew of no problems. Our assumption at this time, is that, if there were complaints or problems, they were within the Unit, kept quiet and not reported to the Council.


October 25, 1989

Investigator Long personally brought a copy of the Arrest Report to me. He was concerned with Mr. Milczarek's being on Pre-Trial Release - that he might continue Scouting involvement. - I assured him this was not possible, and shared with him our Ineligible Volunteer File Process. I also asked him (as we do not know the name(s) of the abused youth - and he cannot tell us) to advise the family that the BSA would pay for counseling if needed and that they could call us in confidence. He felt that was a good idea and would do so.

In Conclusion

We do not at this time know the name of the abused youth. The Investigator feels that there may well be others that come to light in the near future.

Dear Mr. Milczarek:

After careful review, we have decided that your registration with the Boy Scouts of America should be denied. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a BSA Regional Review Committee, please write to the Regional Director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for a review of this decision are attached.

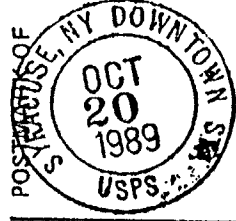

The following information is provided should you desire a review by the Northeast Region, BSA, of the decision to deny your registration.

1. Within 60 days, you must request in writing a review of this decision. Your request should be sent to the Regional Director, Northeast Region. In your request you may include your version of what occurred in support of your claim that your registration should not have been denied.
2. Upon receipt of your written request, a committee will be appointed to review the situation.
3. You may attend the Review Hearing, but it is not adversarial in nature and neither the committee nor you will be represented by legal counsel. If you wish, you may be accompanied by no more than two other individuals if their testimony might assist the committee in discovering the truth and arriving at a correct decision.
4. The committee will review the facts as presented and may interview any persons whose testimony might assist them in arriving at a correct decision.
5. You will receive a letter setting forth the decision of the committee.
6. If you disagree with the decision of the committee, you may request a review of this decision by the National Council of the Boy Scouts of America.

Scoutmaster charged with sexual abuse

A scoutmaster was accused Friday of sodomizing and sexually abusing two young boys enrolled in his troop.

Charles L. Milczarek, 40, of 404 E. Heman St., East Syracuse, was charged with second-degree sodomy, second-degree sexual abuse and endangering the welfare of a child.

The investigation is continuing and other charges may be filed, Syracuse police said.

Milczarek, scoutmaster of Troop 500 since 1980, was suspended from the Boy Scouts Friday, said Donald F. Blacker, head of the local Hiawatha Council of the Boy Scouts.

"Of course we do not tolerate that kind of thing," Blacker said. "We've already told the sponsor of the troop that he's not to have any contact with the troop or any of its members."

Troop 500 is sponsored by the First United Methodist Church of

East Syracuse, 6641 Franklin Park Drive.

Blacker said police told him of Milczarek's arrest shortly after 1:30 p.m. Friday.

Blacker said no serious complaints had been filed with the council against Milczarek prior to his arrest.

"There may have been an occasional complaint about his leadership style, but certainly nothing like this," Blacker said.

Investigators said Milczarek bought the boys presents and took them on trips and to other events.

The abuse began about three years ago and occurred regularly, police said. Investigators were alerted Tuesday, when the boys' parents became suspicious about their children's relationship with Milczarek, police said.

In their affidavits, Milczarek and the boys said the sodomy and abuse happened several times.

All three said none of the abuse occurred during Boy Scout-sponsored camping trips.

"He's a nice guy. He's very sincere and well-liked by the parents we talked with. They all said he's above reproach," said Investigator Michael Long of the department's Child Abuse Unit.

Onondaga County sheriff's detectives also have been briefed on the case against Milczarek because most of the abuse occurred outside the city of Syracuse, Long said.

In his three-page affidavit, Milczarek said the abuse began about three years ago on a private camping trip with one of the youngsters he had befriended.

Milczarek also told investigators he took nude pictures of one of the boys and kept them in the glove compartment of his Toyota pickup truck. He said he destroyed the photographs when they were discovered by another boy.

He denied having sexual contact with any other children.

"I have been affectionate with other children and have hugged, touched and kissed them, but I never had sex with any of them. I also have never forced anybody to have sex with me," Milczarek said in his affidavit.

While you were at lunch today, Investigator Long returned your call re Milczarek, and I reminded him about sending you the arrest report. He will put it in the mail today.

While on the phone, he told me that:

- 1 - Milczarek is out of jail. On pre-trial release program.
- 2 - Long has received "numerous" calls regarding the case. One such call was from Jim Gooley, who indicated Milczarek was a ASM in East Syracuse back in 1979, and was asked to leave the troop. This man said there were about 30 complaints about Milczarek.
- 3 - Some calls indicated Milczarek took boys into his tent.
- 4 - One call was from his [REDACTED] who said he was made to leave Pop Warner and Little League.
- 5 - Long feels that this may be just the "tip of the iceberg".
