Scoutmaster Arrested on Morals Rap

An Astoria scoutmaster was arrested last night on morals charges involving members of his scout troop.

He is John Montgomery, a 44-year-old bachelor, of 21-34 36th St., scoutmaster of Troop 53.

Police were called last week by the parents of one boy, and Detectives Roger Horan, Richard Mooney and Timothy Betts questioned each member of the troop.

Asst. Dist. Atty. Nicholas Ferraro said 25 of the 40 members of the scout troop were involved.

Montgomery, a film technician with a Manhattan company, was arrested at his home last night. Police said he was "remorseful."

He has been scoutmaster of the troop ever since he became interested in scouting after seeing a film on the subject five years ago. He goes to Kew Gardens Felony Court today.

Morals Charge Holds Scouter

A 44-year-old Astoria scoutmaster was to appear today on a morals charge in Kew Gardens Felony Court.

Police said the charge against John E. Montgomery of 21-34 46th street, a film technician, accuses him of molesting scouts in Boy Scout Troop 53, of Astoria. Montgomery has been scoutmaster of the troop for the last five years.

Police said Montgomery's activities first came to their attention Thursday when a troop member complained to his father. The district attorney's office was quickly called in, and after a four day investigation, the suspect was arrested last night.

Montgomery, a bachelor, was described by police as "remorseful and repentant."

Police said Troop 53 was the only one Montgomery never was associated with. The troop meets in a building at 47th street and Ditmars Bou'
