

2 Plead to Sodomy

Two men pleaded guilty to sodomy charges in Fulton County Court yesterday before Judge Angelo D. Lomanto in Johnstown.

Timothy Montana, 34, of 21 Homestead Drive pleaded guilty to first degree sodomy, a Class B felony. The charge was based on a July indictment alleging his involvement in a February incident with a 6-year-old girl.

He was represented by County Public Defender Ralph M. [unclear].

County Assistant Dist. Atty. Richard Giardino appeared for the

prosecution.

John E. Myers, 48, of St. Johnsville RD. 1 waived indictment yesterday and pleaded guilty to second degree sodomy.

The incident allegedly involved a 12-year-old boy during his arrest in the Town of Caroga.

Myers was represented by Atty. George Abdalla of Gloversville.

Assistant Dist. Atty. Vincent DeSantis appeared for the prosecution.

Sentencing for both men was adjourned to a later date.



Area Man, 48, Is Charged with Sodomizing Boys

A 48-year-old St. Johnsville man was incarcerated in the Montgomery County Jail following his arrest last night by the Fonda State Police Bureau of Criminal Investigation (BCI) on two counts of sodomy.

Police said John E. Myhre was arrested on charges of third degree and second degree sodomy, Class B and C felonies. The suspect allegedly had deviant sex with boys ages 11 and 14 last summer in the Towns of Caroga and Oppenheim, State Police reported.

Myhre was arraigned in Town of Caroga Court before Justice Harry Hayner, who sent him to jail in lieu of \$10,000 bail pending a further court appearance.

The initial complaint was lodged by Fulton County child protective services. BCI Inv. A.R. Repenhagen made the arrest at the [unclear].
