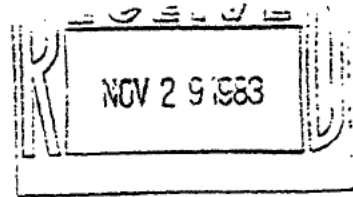

We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the Boy Scouts of America seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to me, explaining your version of the facts supporting your claim that your registration as a Boy Scouts of America leader should be granted or reinstated.

Handyman charged with altering paychecks

[redacted] was charged by Daniel Parsons, state police investigator, with second-degree forgery, a felony, yesterday. He is accused of changing the amounts on 10 paychecks he received from an elderly Town of Dickinson woman for work he did from mid-June to mid-October. State police said the amounts were increased by a total of more than \$200. Councilman Town Justice J. Michael Bishop released Carnar for later court action. State police did not think the name of the victim should be released.

[redacted] was charged by Broome County sheriff's Detective David Harder with second-degree sodomy, a felony, yesterday. He is accused of going camping with two 13-year-old boys near Hawkins Pond Park in the Town of Windsor and having sex with one of them on Oct. 13. Dickinson Town Justice Annette Slocum sent Pugh to Broome County Jail without bail.
