As I mentioned in my first letter, we will do everything we can to keep Fr. Prybis from doing any ministry at all at the retreat center. Fr. Ray is well aware of our concerns, and he has been most cooperative in the past. Since Bro. Tony Szklarski was assigned to help with the administration of the residence in Rome, we were in need of someone who could help with the business affairs at the retreat center. Fr. Ray has the ability to do that, but he also has the allegation against him of which we are all well aware.

I will also ask Fr. Hitpas and Fr. Ettensohn to share your concerns directly with Fr. Prybis. While he cannot be put back into ministry as such, we believe that he has addressed the issues involved and would be able to serve in the capacity of Business and Plant Manager.

I thank you, as always, for your friendship and your support. I will certainly continue to keep you informed as to such issues. You and your staff have been very helpful in the past when we have dealt with other kinds of concerns.

Let us continue to remember one another in prayer.

Ex-lawmaker says clergyman molested him

The Catholic Diocese of Palm Beach publicly called Friday on former congressman Mark Foley to name his alleged abuser and end speculation about the identity of the clergyman he said abused him as a youth.

Foley's attorney, David Roth, announced Tuesday that Foley had been molested by a clergyman when he was 13 to 15 years old. He refused to elaborate.

Diocese spokeswoman Alexis Walkenstein told the Herald-Tribune that conducting an inquiry without a name from Foley would amount to a "witch hunt."

Walkenstein said the church had no plans to start its own investigation and was adamant that her organization had no responsibility to review its records and determine the credibility of Foley's claim.

A spokeswoman with the Archdiocese of Miami, which had jurisdiction over Lake Worth when Foley was growing up there in the 1960s, also said Friday there were no plans to review records they keep on priests accused of abuse unless Foley offered a name.

The situation would be handled differently if the accusation had been against a public school teacher, according to Ron Stowers, an attorney for the state Department of Education.

Stowers said his office, which reviews dozens of cases of alleged sexual abuse every year, would launch an investigation even in reaction to vague allegations like the ones leveled by Foley.

He said DOE investigators would contact school officials, law enforcement and the Department of Children & Families and try to identify the abuser.

Meanwhile, Walkenstein said even a cursory inquiry into Foley's claims would be "impossible" without more information.

Given the information Foley has provided, church officials could review priests Foley had contact with in Lake Worth, where he was an altar boy at Sacred Heart Catholic Church and attended a Catholic high school.

Foley attended the church while aged 13 to 15 and was at Cardinal Newman High School for one year during that time.

At least two Catholic priests who were later accused of abusing children worked at the school or churches in the area during the same period.

According to a database of accused priests compiled by bishopaccountability.org, Reverend Raymond Prybis was at Cardinal Newman between 1968 and 1974. Foley attended the school during the 1969-70 school year, a yearbook from the school shows.

The Boston Globe reported in 2003 that Prybis, while a priest in Boston in the 1980s, stripped naked and asked a 14- or 15-year-old boy to beat him with a belt. Church records posted on bishopaccountability.org show that the boy told his parents, who then confronted church officials. The records show that officials promised to get Prybis counseling.

Questions about Prybis were referred to the Washington, D.C., law firm Akin Gump Strauss Hauer & Feld. But an attorney there, Heather Pellegrino, would not answer questions.

The other accused priest in Foley's area, Rocco D'Angelo, allegedly raped an 11-year-old altar boy in Boynton Beach. The Miami Herald reported in 2002 that D'Angelo, who is now dead, raped at least 12 boys during more than 30 years as a priest in Florida.

Foley, 52, resigned from Congress last week after ABC News disclosed lewd e-mails that he'd sent to teenage boys who had served as congressional pages. Foley has since checked into an alcohol rehabilitation facility.

Even if Foley did not violate federal laws by exchanging sexually explicit Internet communications with underage boys, he still could find himself charged under state statutes. Federal law generally requires a person to meet, or attempt to meet, a minor for sex before a crime has been committed. But in some states where the Florida Republican communicated with children, attempting to seduce a minor might be enough to bring charges.

Federal prosecutors investigating Foley are examining whether Florida authorities might be better positioned to seek charges against him, according to a senior Justice Department official who spoke Friday on condition of anonymity.

Archbishop: Fortunately, rumors late last Friday that the priest who had allegedly abused Rep. Mark Foley as a teenage altar boy was now part of the Oblate community at Christ the King Retreat Center in Buffalo, proved untrue.

I was in constant contact Friday with Pam Miller of the Star Tribune who had a tip on the story and was working on it very hard, but in her normal ethical style, would not write anything until she had definite proof. She in fact even went to the retreat center Friday evening and found the former priest, Raymond Prybis, but he fled from her once he saw her press credentials.

Father McDonough managed to reach the Oblate Provincial in D.C. who told him the attorney for Foley reported that the alleged abuser's name did not "begin with P" which we relayed to Pam. However, the web site of the *International Herald Tribune* printed a story (attached) that named Prybis along with a deceased Oblate offender, as primary suspects.

On Monday morning, I got an email from Pam Miller telling me that she'd received a call from Foley's attorney, a Mr. Roth, who informed her that Prybis was, "unequivocally NOT the offender" of Mark Foley.

Then I reached the director of the Oblate retreat center in Buffalo, a Father Ettensohn. He said they'd been informed that Prybis was innocent, although he reported that SNAP had staged a protest at Sunday Masses (flyer attached.). When I asked him about Prybis' whereabouts, he said that Prybis is still at the Retreat Center finishing up his work as business manager there. He added that, shortly, they plan to send Prybis to their house at 104 Mississippi River Blvd. in Saint Paul. After a month or so, Father said the Provincial leadership will decide on next locale for Prybis.

I reported this conversation to Bishop Pates and he finds it unacceptable and states that Father Ettensohn (or perhaps the Provincial) needs to be made aware of that quickly.

This whole episode revealed another problem in our communications and record keeping. Prybis is still listed as an active priest in our directory and on the Serra website, the Kennedy Directory, etc. Bishop Pates is in the process of putting together a foolproof process to assure this doesn't happen again.

Priest in Foley scandal to be investigated

ROME (AP) - A Roman Catholic diocese has opened an investigation of a priest who said he fondled and shared saunas while naked with Mark Foley when the former U.S. congressman was a boy in Florida.

In interviews in the past two days, the Rev. Anthony Mercieca, 69, who is now with a diocese on an island off Malta, has given different details about his encounters with Foley four decades ago.

On Wednesday, he told the Sarasota (Fla.) Herald-Tribune by telephone that he massaged the boy in the nude, was naked in the same room on overnight trips with him and had gone skinny dipping with him. On Thursday, he told The Associated Press that he was naked in a sauna with Foley.

Also Thursday, he told WPTV of West Palm Beach, Fla., that he touched Foley "once, maybe."

In all of the interviews, he denied having sexual intercourse with Foley.

"It's not something you call, I mean, rape or penetration or anything like that, you know," he told the TV station in a telephone interview. "It was just fondling."

Foley, a 52-year-old Florida Republican, resigned from Congress last month after the release of his sexually explicit computer messages to young male pages.

After Foley's resignation from Congress, his lawyer said that Foley was an alcoholic, gay and had been molested as a boy by a "clergyman." Foley's civil lawyer, Gerald Richman, said the alleged abuser was a Catholic priest whose name he shared with Florida state prosecutors.

A statement from the diocese of Gozo, a small Mediterranean island off Malta, said that its bishop, Mario Grech, contacted the Archdiocese of Miami on Thursday evening seeking further information about the case. The statement, issued late Thursday, said the diocese had learnt of the case for the first time in the international press.

"In the light of all this ... Bishop Grech will instruct the response team to investigate these allegations according to the policies established by the Maltese Ecclesiastical Province with regards to cases of sexual abuse in pastoral activity," the statement said. "Grech will pass all information he receives pertaining to this case to the response team as he has done in similar cases."

The Maltese Church instituted the team in 1999 to deal with any sexual abuse allegations.

The statement said the team would present the bishop with a report, and that Grech promised to cooperate. It did not say whether Mercieca was still serving as a priest on Gozo, where he regularly hears confession and celebrates Mass in the cathedral, one of two main churches on the Mediterranean island.

It also did not say whether it would investigate anything other than Mercieca's recent statements about Foley.

Gozo, 60 miles south of Sicily, has a population of about 32,000 and is one of Malta's three inhabited islands - filled with vacation homes and holiday resorts.

"Bishop Grech, conscious of the gravity of pedophilia, reiterates that he will cooperate with those responsible for investigating such cases so that justice is done to the victims, the perpetrators are reformed and the common good is safeguarded," the statement said.

The Sarasota Herald-Tribune published an interview with Mercieca on Thursday in which the priest described several encounters that he said Foley might perceive as sexually inappropriate.

Among the activities described by Mercieca in the newspaper were massaging the boy in the nude, skinny-dipping together at a secluded lake in Lake Worth, Fla., and being nude in the same room on overnight trips while he was a priest and Foley was a

parishioner.

Mercieca later told The Associated Press in Rome by phone that the report was "exaggerated."

"We were friends and trusted each other as brothers and loved each other as brothers," Mercieca said in the AP interview. Asked if their association was sexual, the priest replied: "It wasn't."

Mercieca told the AP that he and Foley would go into saunas naked when he was a priest in Florida and Foley was a parishioner, but he said that "everybody does that."

Sarasota Herald-Tribune Executive Editor Mike Connelly said Thursday the story is accurate, including the reference to a night in which Mercieca said he was in a drug-induced stupor due to a nervous breakdown and couldn't clearly remember what happened.

"The reporter talked to the priest four times yesterday and carefully reviewed his account, especially of the one night," Connelly said. "The story accurately reports what the priest said."

Mercieca had worked at Sacred Heart Catholic Church in Lake Worth in 1967, according to church records. Foley would have been 13 at the time.

A spokesman for the state attorney's office in West Palm Beach, Mike Edmondson, said that an e-mail from Foley's attorney was received late Wednesday identifying the alleged abuser. He said the e-mail was being forwarded to the Archdiocese of Miami. Edmondson said law enforcement action is over, unless other alleged victims come forward, because Foley's attorneys have said that the politician doesn't want to prosecute.

WHO

Three victims of clergy sexual abuse who are members of a support group called SNAP (Survivors Network of those Abused by Priests), including a Chicago woman who is the organization's founder and long-time president.

WHY

Despite repeated pledges to be more "open and transparent," about clergy sex abuse, Minnesota's bishops continue to hide the identities and presence of credibly accused pedophile priests. Four such clerics have been exposed in media accounts recently, and now SNAP is exposing a fifth.

In 2003, a court order forced Boston Catholic officials to release records about Fr. Raymond A. Prybis. Those records showed that Prybis had "been accused of approaching, while naked, a 14- or 15-year-old boy in the 1980s and asking the teenager to beat him with a belt."

A few weeks ago, reporters notified SNAP that Prybis now quietly lives and works at a church facility in Buffalo, MN. (Several journalists had learned that Prybis worked at the Florida parish where former Congressman Mark Foley belonged as a teenager, which led some reporters to suspect that Prybis had abused Foley.)

To increase public safety, SNAP is calling on all Minnesota bishops to create, maintain and publicize a website listing the names and locations of all proven, admitted, credibly accused cleric molesters. They are urging Minnesota Catholics to donate to schools and charities, but not to the church, until such a disclosure is made.

Such information is particularly needed today, SNAP feels, because even now, despite years of scandal, pedophile priest are moving around and/or being moved around.

With Prybis, an Oblate priest, there are two possibilities. Either Archbishop Flynn knew and kept secret that Prybis was living in his archdiocese. (If so, Flynn should publicly apologize for his secrecy.) Or Flynn did NOT know and was thus deceived by the Prybis's superiors the Oblates. (If so, Flynn should publicly condemn the Oblates for putting Minnesota kids at risk.)

Until two weeks ago, when reporters began suspected in Prybis might have molested Foley, Prybis was listed on the Christ the King Retreat Center website. (Copies of that listing will be included.) On Sunday, November 5, Flynn plans to dedicate the new St. Francis Xavier Catholic School building in Buffalo, MN.

Three times in the last few weeks SNAP has leafleted at Catholic churches in Minneapolis, Anoka and Shoreview where credibly accused abusive priests have worked. The SNAP fliers urge anyone with information about clergy sex crimes – whether victims or witnesses – come forward and contact the police.

PCYI does not create the audit report based on ArchDB's "status". We report based on CATracking excluding records for those marked "Inactive for Audit Cycle 2011—2012".

Rita can verify or correct, but it is my understanding that the difficulty of ArchDB statuses not considering the Charter's criteria "working within the diocese" was at least part of why a separate database was developed.

The reason many of the priests on the list from Jennifer's team did not appear in CATracking is that they were gone from the Archdiocese and so did not meet the criteria for the audit, and were not put into CATracking when it was built in 2009. e.g.: Bishops in other dioceses.

One solution is to ensure that Lawson (or whatever database we use for this) has a field something like "Charter Clergy". This would mean a man who is serving in the archdiocese and is subject to the criteria the Charter established.

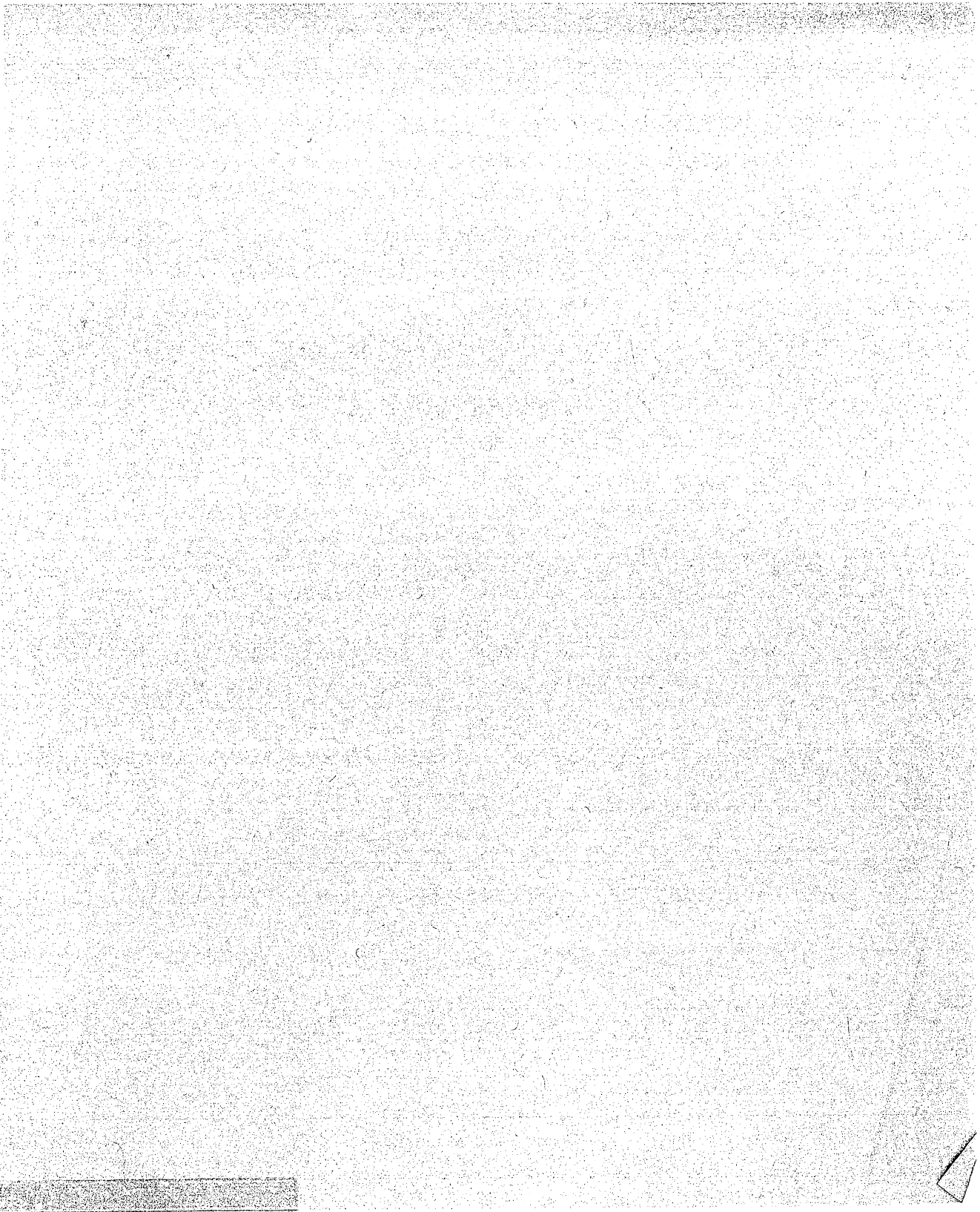
