April 1983 –	Bishop Robert Carlson met with Fr. Robert Thurner after the Archdiocese received another call about Thurner's conduct with a child. Bishop Carlson stated that Thurner should resign from St. John the Evangelist. (Thurner Int. Answers pg. 5.)
