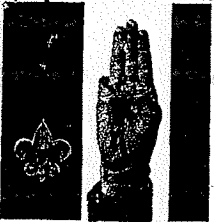

This is to officially notify you that one Robert Sykes, age 19, either being or is registered as an Assistant Scout Master <sup>(Top 153)</sup> is a truly undesirable character and must be listed as such in the Scouting program.

~~He was accused and admitted to indecent liberties with minors while on a Scout outing at St Ignace on ~~the~~ Saturday weekend. As a result of the investigation, the military authorities and the OSI have been fully briefed and are taking appropriate action to eliminate him from service. Sykes has stated that this same type mess occurred in a previous troop that he belonged to, and as soon as he can be found out, will let you know what troop and where.~~

The Scouts have officially notified Sykes that he is suspended from further activity with us and will undoubtedly be barred for good but only after confirmation with the Council.

We families have had good cooperation and understanding from our parents but it is unknown at this point what effect the incident will have on our membership. Will keep you advised.
