He wrote apology letters to victims

Imesch knew about abuse, transferred priest

Victim told Auxiliary Bishop Kaffer he wouldn't sue if Ross removed

Instead, Imesch and Kaffer send the priest to California

In 2004, Imesch says that with a "good report," he would put abuser back in ministry

The career and personnel file of Father Anthony Ross is the perfect example of how Bishop Imesch easily kept an abusive priest in ministry.

Ross sexually abused at least one boy in 1982, while he was a priest in Joliet. Approximately one year later, Ross wrote the victim and his family apologizing for the abuse. When Imesch and Bishop Ryan learned about the letter, Ross remained in ministry, eventually being transferred to a parish in Lombard. In 2004 testimony, Imesch said that if a credibly accused priest had a "good report," Imesch would put him back in ministry.

In 1992, Bishop Roger Kaffer approached the victim. The victim told Kaffer he would not pursue a civil suit if Ross were removed from ministry. Ross was put on a leave of absence because, according to Bishop Imesch, there were fears that the victim would sue and go public.

By 1997, things had quieted down. Ross was quietly transferred to the Diocese of Santa Rosa, California. By 2002, Kaffer told Ross' victim that the cleric was still in ministry. At the same time, the Santa Rosa Diocese learned about the allegations and suspended Ross.

In 2005, the Vatican decided to allow Ross to remain a priest, but he was suspended from all ministry. His last known address is in Santa Rosa, California.
