Teeling, 36, Admits Sodomy With 3 Boys


A 36-year-old Schenectady man who police have said is a former Boy Scout leader has admitted in Schenectady County Court that he engaged in deviate sexual intercourse with three boys, one 13, one 12 and one 9 years old.

Robert H. Teeling of Hulett Street pleaded guilty Friday to three counts of second-degree sodomy, and acting County Court Judge Angelo Lomanto deferred sentencing without setting a specific date.

Teeling admitted that he engaged in deviate sexual intercourse with the 13-year-old on July 9, with the 12-year-old between Jan. 1, 1985, and July 30 of this year and with the 9-year-old between Oct. 1 and Nov. 31, 1985.

When Teeling was arrested July 31, police said he had engaged in sexual activity with 12 boys during the past four years.

12 boys during the past four years.
They said that he met boys through his contact with the Boy Scouts and that he was connected with a troop which was sponsored by the Police Department's Community Center but which has since disbanded.

Mr. Teeling was charged on the accusation made by a 13 year old boy. Police have identified more than 12 boys whom he sodomized. Police recovered photographs of the boys. Mr. Teeling reportedly blackmailed the boys with the photographs for their silence.
