

FATHER THOMAS DUANE

(By Father Joseph C. Frisch, Ph.D., S.T.D., Holy Cross, Dakota, Mn.)

The French have a unique way of describing and categorizing . things. For example, if they wish to discuss virtues in general, they will distinguish between the great virtues (les grandes vertus) that refer to the theological and cardinal virtues and the little virtues (les petites vertus). Their distinction does not imply that the so-called little virtues are not important, but rather that they are subordinated and derived from the great virtues.

If we were to examine the life of Father Thomas Duane, we would observe that he practiced some of those little virtues. included such good habits as generosity to others, thoughtfulness,

and gratitude.

During the depression years, when poverty was part-and-parcel of most families, Father Duane used the gifts he received at the time of his ordination to pay for his brother's tuition at St. Mary's College in Winona. Without such financial assistance, James Duane would have never been able to attend college. The enormity of the gift becomes quite evident when one learns that Father Duane received a salary of only \$33.33 per month during the early years of his priestly ministry.

Such generosity was not an isolated incident in his life. Throughout the many years of his priestly career, Father Tom often sent monetary gifts to his nephews whenever he wrote to them. His thoughtfulness of others was demonstrated when he expressed an interest in their activities and encouraged them to persevere in

their studies.

Occasionally he spoke to me in glowing terms about his Some individuals ascribe their vocation to the good example offered by other priests or nuns. But Father Tom claimed that he was influenced mostly by the example of his mother who attended daily Mass whenever she was able to do so. He said that he will always be grateful to God for giving him auch a wonderful mother andallowing her to live long enough to celebrate the 103rd anniversary of her birth.

Father Duane often expressed his gratitude for the opportunity to spend his years of retirement at St. Anne's Hospice in Winona. He was especially thankful that for the first time in his life he was able to live under the same roof with our Blessed Lord who is

always present in the chapel's tabernacle.

Father Duane was noted for his efforts to befriend everyone. Wherever he was stationed, he maintained close ties with the members of the Protestant clergy. He was a pioneer in ecumenism. Residents of Spring Valley, Minnesota insisted that their softball team had the best double play combination in the state, namely,

Father Duane at second base and the Lutheran minister at shortstop.

He manifested his gratitude and love for the priesthood by once declaring to me that if he were to relive his life, he would still choose the priesthood in preference to any other profession. In the same breath, he added, "If I have ever hurt or offended anyone in my

life, I am truly sorry."

Father Tom left his mark on the Caledonia community. Not only did he provide religious instructions for the students at Loretto High School, but he also coached their basketball team. Many students enjoyed his religion classes because they said that he related religion to real life experiences.

One former student at Loretto High School, Leo Cavin, mentioned that he still remembers the rich, resonant voice of Father Duane when he sang a Latin High Mass. "If I were to be a priest," declared Leo, "I would like to sing as well as Father Duane."

People who were acquainted with Father Tom told me that his frequent smile attracted them to him. They also recall that he was very supportive of school functions: he chaperoned class trips, school dances, and attended all athletic events. He will be long remembered as one of their favorite priests.

Bishop F.W. Freking, retired bishop of the La Crosse Diocese and a college classmate of Father Duane, epitomized the life of

this likeable priest with the following comments:

"Father Tom helped to dispel prejudice against the church in every community where he served."

"Visiting his parishioners at regular intervals was an

important part of his priestly ministry."

"In one parish to which he was assigned, Father actually provided nursing care for the ailing pastor in spite of the fact that the pastor made life difficult for him."

"Father Thomas Duane had the support of a loving family, and

he, in turn, was generous to them."

Mrs. Louise Heydon, Fr. Duane's sister, called from Rochester today and said that Fr. Duane was back at Cronin Homes. It seems that Father may need more attention than he can get at Cronin Homes and so the man who directs Cronin Homes and Louise herself thinks that it might be better for Father to come to St. Anne's Hospice.

Sr. Dorothy has been working on this matter already; she has sent an application form to Louise.

In talking with Sr. Dorothy today, I found out that the kind of care Father would need, at least to begin with, would be \$49 per day, or \$1470 per month. To stay at St. Anne's with regular room and board is \$32 per day. Sr. Dorothy said that if Father's finances would not be enough to cover that cost, the county would be able to help through Medicaid. If his finances are not enough to cover the first six months, he can apply for aid before that time. Otherwise after six months he can get the aid more easily. It seems that he can keep \$3,000 assets, and then his income from retirement and Social Security, etc. needs to be given over, and in return he will get \$35 or \$40 a month to spend.

I relayed this information to Louise, and she said that she has already gotten the name of a social worker in Olmsted County. She will fill out the application for Father and send it to Sr. Dorothy and she will contact that social worker.

Louise said that Father's income at this point is \$495 per month from retirement, \$173 per month Social Security, and about \$100 per month on a CD. Louise's telephone number is 282-1303.

Dear Louise,

I am enclosing the tax returns for Father Tom for 1978 and 1979 along with some other items that are pertinent to it. What follows may be more in Jim's line of work; I hope it's not too confusing.

I really only used his salary as income and did not count what he got from the Priests' Retirement. And each case, I estimated about \$200 a month as salary; the rest of his check, which they tell me was \$450 a month while he was at Claremont, went for car expense and food expense. The interest income I got from the Security State Bank in Claremont for both 1978 and '79; in '79 he had some interest at the bank in Lewiston too.

Father Robert Taylor, the secretary for the Bureau of Priests' Retirement, tells me that if Father paid taxes on the money he contributed to the Bureau over the years, then what he gets back for the first couple of years will not have to be reported as income. Father said you could call him at St. Mary's College for any further information.

As you can see, Father Tom got a notice back from the IRS for both '78 and '79 that he was going to have a refund. I believe he actually got the refund of \$186.45 back for 1978, but did not get the refund back for 1979, Instead, he sent an additional \$19 to make the difference between the \$176.70 and the \$194.40 which appears on the 1979 return that I sent in.

Another bit of explanation: Father Tom sent in a 1979 return about this time a year ago, and since he didn't have a copy of it and we needed a copy for his Social Security, I made up another 1979 one and sent it in before Apr. 15, 1980. Then last summer the Social Security Administration told me that if we could get ahold of his 1978 return and turn that into the Social Security Administration he would get more benefits. I wrote to IRS for the return for both '78 and '79 but did not actually receive the returns, though IRS acknowledged our request. When we filed the 1978 return, Father Tom sent in \$309.94, and we was at that time that he also sent in the \$19 for the 1979 tax.

I think all the other enclosed documents will speak for themselves. I am really glad that you are going to help Father Tom, and I hope that if I have gotten anything mixed up in the process, you will be able to straighten it out.

I talked with Ray Felton at the Social Security Administration and he said that if we filed the 1978 tax return for Fr. Duane, benefits of \$145 (approximately) per month and hospital Medicare Benefits would be extended back from Oct. '79 to March of 1979. Thus Father would receive seven months more benefits or approximately \$1000. He said that the Medicare part B for doctors would not be moved back beyond July 1, 1980.

I spoke with Diane Weich at Cronin Homes and she said that she was going to talk with Louise Hodon, Fr. Duane's sister, and they would have Father sign the tax return that they have for 1978 and send in the payment of \$309.94 with that return to the IRS. Diane will also have Father send in a check of roughly \$19 for 1979. Apparently the IRS has calculated the difference between the \$194.40 plus interest on that sum, the difference between that and what Father sent in originally which was \$176 as being the \$19 which Father now owes on his 1979 income tax.

He has a brother Joe who is in good health. A sister Kathy who is 64 and in good health. Also sisters Jim and Louise. Social standing: This patient is retired, living in an apartment in Lewiston. He had eight years of elementary, eight years of college, and four years of high school, and he is a retired priest. I have recieved the Bishop's letter to you granting permission for your disability retirement. I say disability retirement advisedly, because if you consult the Documents in the front of the blue book, Art. XII, EARLY RETIREMENT which reads, ''If a priest retires before the age of 68, with the approval of the Ordinary of the Diocese of Winona, he will receive retirement benefits according to his age. For each year of early retirement, the benefits will be reduced by six percent(6%) and remain constant, i.e., a priest who retires five years early will receive benefits amounting to seventy percent(70%) of the monthly benefit for the remainder of his life.'' you are on reduced pension because your present age is 66.

If however, you persue Art. X in DISABILITY, evidence should be given which means essentially the line relating to the inclusion of a physicians certification of permanent inability to perform pastoral duties in a sustaining and continual basis.

(t would seem to me that you could and should seek such certification and persue the benefit outlined in Art. X in Disability.

Since the board meets periodically and we will not meet again until the end of July, [am following the policy set by the Retirement Committee of sending you full retirement benefits beginning with the June 28, 1979 check. I want to remind you however, that the Retirement Committee must approve your benefits and that you should expeditiously seek a physicians certification of your disability. For the time being then, your benifit will total \$410.23

Enclosed is the form of resignation of your parish and acceptance of the new assignment. I ask that you sign this and return it to the Chancery.

I wish at this time to commend you for your priestly work exercised in all pastoral offices to which you have been assigned. I am sure that you will give the people of God of your new parishes zealous pastoral care which will lead them closer to the kingdom of God.

I delegate the Reverend Leroy Eikens, Vicar of Region III, to install you in your new parochial assignment. Your installation as pastor should be arranged for as soon as is convenient for you and for Father Eikens. This ceremony should be a public event to which the members of the parishes are invited. It is an important sign by which pastoral authority is entrusted to you. I shall enclose the Decree of Possession and the Profession of Faith andOath Against Modernism which you should take at the time of your installation. Please send these documents to the Chancery immediately after the ceremony of installation.

As both of us know, the Second Vatican Council and the implementation of its directives by the Sacred Congregations, especially For the Doctrine of the Faith, For the Discipline of the Sacraments, For Divine Worship, and For Catholic Education continues to touch and influence the faith life of the people in every parish. In asking you to share with me the serious responsibility of providing pastoral care to all the people living within the boundaries of the Dodge Center and Kasson parishes, including those who for whatever reason have grown careless in the practice of their faith,

I wish to stress the importance of celebrating the Eucharistic Liturgy and the Sacraments according to the revised rites. The various options which our official liturgical books provide can be used to nourish the faith and devotion of our people if they are prepared for their use by careful explanations. From time to time and with an announcement of the fact, the New Order of the Mass should be celebrated in the Latin language (the Kyrie, Gloria, Credo, Sanctus, Agnus Dei either sung or redted by the people with the Preface, Eucharistic Prayer, and Communion Rite prayed out loud by the celebrant).

In order that the people play their proper roles in the life and worship of the Church each parish must have an elected parish council with working committees (e.g. Liturgy, Education, Temporal Affairs, Commanity Life, and Vocations). Each parish is expected to send elected representatives to the meeting of the Regional Pastoral Council and to cooperate with the other parishes in the activities and projects of the Diocesan Pastoral Council. For 1974-1975 this means active involvement of priests and people in the preparations for the Diocesan Symod in the traditional sense which the Priests' Senate has called for to define for our times all the dimensions of the Church in the Diocese of Winona. Your leadership in St. John's and St. Olaf's parishes is the only thing that can make certain that the Synod actually furthers the interior and spiritual renewal of your parishioners. It is because I am confident of your cooperation that I am asking you to give the Synod top priority in your new pastoral assignment. And finally, I want to ask you to make a special effort to observe this Year of Reconciliation in your parish; on my return from the ad limina around the first of October I will be happy to celebrate a Eucharistic Liturgy of Reconciliation for groups of parishes, perhaps on the regional level. Each parish should have a Holy Year Committee; at least, the Liturgy Committee should sponsor this important effort toward spiritual renewal.

Let me begin by saying that I deeply appreciated your fine cooperation last spring and the wonderful progress you made by your whole-hearted participation in the program at Guesthouse. Both the time and the expense, as long and as great as they were, did seem more than worthwhile as you seemed to continue to make progress each of the few times we met during the summer and fall. However, sorry to say, reports have reached me that it seems that the problem is returning; for example, people at the bingo party a week ago last evening (Jan. 30) were embarrassed and, according to their letters, were unable to help you.

Obviously, I don't know if these reports and other previous ones are true; you will have to tell me that. On the other hand, I do feel that I can ask about your attendance at AA meetings and visits to Guesthouse; as you know better than I do, Guesthouse insists that no priest is able to keep sober when he leaves that wonderful institution unless he is faithful to weekly AA meetings.

I was pleased to receive your letter this morning with the acceptance of the administratorship of St. Patrick's Church at LeRoy effective March 1 and that you plan to be there for Mass that evening.

I have heard that you have not been faithful in observing my injunction of complete abstinence from intomicating liquor since your transfer from Fulda. This truly was a surprise to me; but knowing human nature as I do and realizing that we are sometimes weak, I believe that I must take further action in your case. I am sure that you can, if you wish, voluntarily observe this injunction to abstain from all intoxicating liquor including wine and beer, excepting only the small quantity of wine that is necessary at the offering of Holy Mass.

This is a command from me to you so that if you violate it you will automatically be deprived of your assignment to St. Patrick's at LeRoy since a command is accompanied by a very severe canonical penalty of <u>suspension ipso facto</u>, the censure to be reserved personally to me. This means that if you violate this injunction you may not offer Holy Mass or confer the sacraments publicly excepting in case of an emergency sick call which may arise. This penalty means nothing more than what it says so that it should not hamper you in any way nor interfere with your freedom to do what you ought to do.

I sincerely pray that it may never become effective, but that rests entirely with yourself. I am sure that you have sufficient faith to realize the seriousness of this command which is given for your own benefit as well as for that of the souls committed to your care and the good example that needs to be given to the community in LeRoy.

I assure, Your Excellency that I am much harder on myself at times than you were in your letter to me, I hate myself for my failures and for my lapses, but thank God I do go to confession regularily and I hope that God will pardon me.

I wish also herewith to promise, Your Excellency, that I will not take a drink of any alcoholic drink even beer for at least a year and I make this promise under the penalty of suspension, ipso facto, no exceptions. In your kindness you did not ask this of me but I gladly submit this as a token of my determination to be a better priest in the future. Humilit happens to be a virtue that I can practice, in some measure, and I thank Almighty God that He gives me the grace to do so.

I still have one other favor to ask of Your Excellency, I hope that you will not ask me to go to some hospital or home like Nevis of Jemez Springs, I suffer a bit from a malady called Claustrophobia and to be assigned to one of these places would surely exaggerate this phobia.

When I leave Fulda I think I can stay at my brothers house for a few days, live with my mother and sister for a short time and then take off and leave the countryside for whatever time you suggest and be ready to report for duty whenever you ye suggest.

As far as health is concerned I have frequently been trobled with Gout during the past two years and also I have had a nerve problem that would not allow me to sleepfor several days in a row so this can be as you suggest an easy way out. I do not want to leave with a choud of shame over my going because I still feel that while I have failed and some have complained to you, many still do truly love me because they love a priest.

I assure, Your Excellency, that I will not say, or breath a word about your letter until I hear from you again.

I have received several complaints concerning your conduct and actions at St. Gabriel's Church in Fulda, and particularly certain circumstances at Mass on Sundays which would seem to indicate a serious illness or excessive use of intoticating liquors. These reports come to me that it is a subject of conversation throughout Fulda wherever people gather.

Since this recent episode is not the first complaint I have had, nor is this the first warning I have given you, I am herewith asking you for your resignation as pastor of St. Gabriel's Church on account of health. I trust that you will send this to me immediately so that I may then make arrangements to appoint another priest and to assign you for a rest, and I hope, a cure of alcoholism with which you seem to be troubled.

"I . . . firmly hold and accept each and every definition of the unerring teaching of the Church, with all she has maintained and declared, but especially those points of doctrine which expressly combat the errors of our time, In the first place I profess my belief that God, the beginning and end of all, can be certainly known and therefore proved to exist by the natural light of reason from the things that are made, that is, from the visible works of the creation as a cause from its effect. Next I recognize and acknowledge the external arguments of revelation, that is, divine facts, especially miracles and prophecies, as most certain signs of the divine origin of the Christian religion, and I hold that these are altogether suited to the understanding of every age and of all men, also of our times. Thirdly, I likewise hold with firm faith that the Church, the guardian and exponent of the revealed Word, was proximately and directly founded by the true and historic Christ Himself, while He dwelt amongst us, and that she was also built upon Peter, the Prince of the Apostolic Hierarchy, and upon his successors to the end of time. Fourthly, I sincerely accept the teaching of faith as transmitted down to us from the Apostles through the orthodox Fathers in the same sense and even in the same wording; and, therefore, I wholly reject the heretical notions of the evolution of dogmas, which pass from one sense to another alien to that which the Church held from the start; and I likewise condemn every error whereby is substituted for the divine deposit, entrusted by Christ to His Spouse and by Her to be faithfully guarded, a philosophic system or the creation of a human consciousness, gradually refined by the striving of men and finally to be perfected hereafter by indefinite progress. Fifthly, I hold for certain and sincerely profess that Faith is not a blind religious sense making its way out of the hidden regions of the sub-liminal consciousness, morally tinged by the influence of heart and will, but is a true assent of the intellect to truth received from without by hearing, an assent whereby we believe to be true, because of the authority of the all-true God, whatever by the personal God, our Creator and Lord, has been spoken, testified and revealed.

"I further, with all due reverence, submit and with my whole mind adhere to all the con-

demnations, declarations, and ordinances contained in the Encyclical letter *Pascendi* and in the Decree *Lamentabili*, particularly regarding what is called the history of Dogma.

"I also reject the error of those who aver that the Faith proposed by the Church may be in conflict with history, and that Catholic dogmas in the sense in which they are now understood cannot be harmonized with the more truthful "origins" of Christianity. Moreover, I condemn and reject the opinion which declares that a Christian man of better culture can assume a dual personality, one as a believer and another as an historian, as if it were permissible for the historian to hold fast what his faith as a believer contradicts, or to lay down premises from which there follows the falsity or the uncertainty of dogmas, provided only that these are not directly denied. Likewise I reject that method of estimating and interpreting Holy Writ, which, setting aside the Church's tradition and the analogy of Faith and the rules of the Apostolic See, adopts the rationalists' principles and with equal arbitrariness and rashness considers criticism of the text the one only supreme rule. Furthermore, I reject the opinion of those who hold that a teacher of the science of Historical Theology or the writer on the subject must first put aside the notions previously conceived about the supernatural origin of Catholic tradition or about the divine aid promised for the perpetual preservation of each revealed truth; then, that the writings of individual Fathers must be interpreted solely by the data of science, without any reference to sacred authority, and with that freedom of judgment wherewith every profane record is usually examined.

"Finally and in general, I declare myself to be far removed from the error of the modernists who hold that in sacred tradition there is nothing inherently divine; or who—far worse still-admit it in a pantheistic sense; so that thus there would remain only a bare simple fact equal to the ordinary facts of history, viz., that the school started by Christ and His Apostles finds, in the ages that follow, men to carry it on by their energy, their skill, and their genius. Wherefore most firmly do I retain and to my last breath will I retain the Faith of the Fathers of the Church concerning the sure endowment of truth, which is, has been, and ever will be in the succession of the Episcopate from the Apostles; not in such a way that what seems best and most fitting according to the refinement of each age may be held, but that the absolute and unchangeable truth preached from the beginning by the Apostles may never in any different wise be believed, never in any





I, Father Thomas Edward Duane, resideing and domiciled in Fillmore County, Minnesota, hereby revoke all former wills made by me, and declare this to be my last will.

Ι.

I direct that the belance of my savings account in the First National Bank, located in Spring Valley. Minnesota and the proceeds from the sale of my automobile shall be used for the purpose of paying all expenses incurred in my last illness and funeral expenses. The balance after said payment, if any there be, shall become a part of the residue of my estats and the disposition of the residue is herinafter mentioned in paragraph VII, herein.

II.

I am possessed of two (2) Life Insurance policies. One policy having a value of Two Thousand and no/100 (\$2,000) dollars is written by the New York Life Insurance Company. The other policy, having a value of Three Thousand and no/100 (\$3,000) dollars is written by the State Farm Mutural Insurance Company. Both of said policies carry a double indemnity clause and both of said policies name my mother and father, Farma and Thomas Duene, as beneficiaries. It is my desire that should my life terminate by accidental means and should the above mentioned insurance companies see fit to pay my benificiaries double the amount of said policies, my benificiaries are requested to pay one half (\$\frac{1}{2}\$) of such payment on both insurance policies to the Diocese of Winona, a corporation.
