Dear Paul:

This letter is in response to your letter of February 14, 1989 to Lyla Antonides pursuant to the disposition of the Menica Thorpe case.

I talked by telephone, with Robert Luden, Town Justice, Town of Tusten. Mr. Luden said that Menica Thrope was charged with a misdemeanor Sexual Abuse, 2nd degree. The parents failed to show up at the hearing or to press charges.

Consequently, Menica Thorpe plead guilty to a lessor charge of harassment. He was fined \$250.00 and will not be permitted to affiliate with a youth agency for one year (which is called Conditional Discharge). Monica Thorpe will have no violation on his record and the case is sealed.

I asked Mr. Luden to send me a letter confirming our telephone conversation and he said he is forbidden to put anything in writing when a case is sealed.

I hope this will help you in completing this matter.
