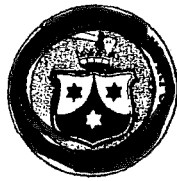

Dear Brother,

We recently learned that a lawsuit has been filed in California in which [REDACTED] is accused of sexual misconduct with a minor. The lawsuit names as defendants the Archdiocese of Los Angeles, S [REDACTED] sh, the Order of Carmelites, and [REDACTED]. The alleged incidents took place approximately twenty years ago in California while [REDACTED] was teaching at [REDACTED]'s parish.

When an allegation is received, our policy requires that the accused priest be withdrawn from public ministry while the accusation is being investigated. Consequently, [REDACTED] has left Our Lady of [REDACTED]. A statement was read at all the Masses this past weekend.

[REDACTED] understands the policy and is fully cooperative. For now, he is residing [REDACTED]. We are not publicizing his residence. Obviously, withdrawal from ministry is *not* a judgment of guilt. We have no record of any other allegations made against [REDACTED].

[REDACTED] and his family ask us to pray for all involved in this difficult situation. Our prayer is that, in the end, justice and truth will be served.

This past week we learned of a lawsuit filed in California involving Rev. REDACTED [REDACTED], who has been serving at [REDACTED] since July of 20[REDACTED]. The lawsuit alleges that Father REDACTED engaged in sexual misconduct with a minor when he was stationed in California. Father REDACTED was stationed in California from 19[REDACTED] to 19[REDACTED].

The [REDACTED] et take all such allegations very seriously and have adopted policies for such situations. In accord with their own policies, the [REDACTED] have temporarily removed Father REDACTED from ministry pending the investigation of this matter. It is important to note that the [REDACTED] policies call for temporary removal upon receipt of an allegation, but temporary removal is not a finding of guilt.

If anyone would like to discuss this matter, or is aware of any inappropriate behavior by Father REDACTED please contact [REDACTED] superior, at [REDACTED] and/or the appropriate civil authorities.

We offer our prayers for all involved in this matter and hope for a just and speedy resolution.

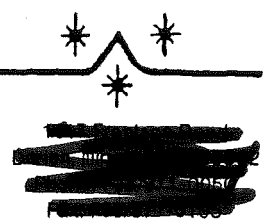

In accordance with the Archdiocesan Policy on reporting to police authorities in instances of possible abuse or neglect involving minors, we have enclosed a copy of an amended complaint filed on October 16, 2006 in the Superior Court of Los Angeles. The initial complaint was filed in late September, 2006.

The complaint alleges abuse between 1987 and 1989 by Fr. REDACTED a [REDACTED] Priest who was assigned to that Parish during that period. He is currently in [REDACTED] and I understand that he has been removed from Ministry pending the outcome of the investigation. According to the complaint, the plaintiff/victim is in Los Angeles and was not yet twenty-six years old when the complaint was filed.
