Purpose & Background

For decades, numerous courageous survivors have spoken their truth and brought lawsuits related to the sexual abuse of children in the Catholic Church throughout Arizona. Survivors became plaintiffs in civil lawsuits and together with their attorneys were able to reveal secret Church records through the courts and civil litigation process. These lawsuits resulted in the release and disclosure of identities and histories of sexually abusive clergy and those engaged in sexual misconduct, and the release of documents and information reflecting the knowledge of institutions that covered up sexual abuse and misconduct.

The Anderson Report on Sexual Abuse in the Diocese of Phoenix contains the names of diocesan priests, religious order priests and other religious clerics associated with the Diocese of Phoenix, including those of whom were assigned within, working in, or living in the geographical boundaries of the Dioceses of Tucson and Gallup before the Diocese of Phoenix was formed in 1969, who have been accused of sexual misconduct with minors. While lawsuits were filed involving many of these alleged perpetrators, the vast majority of the claims against these individuals have been settled or have not been fully evaluated in a civil or criminal court. Accordingly, the allegations should be considered just allegations and should not be considered proved or substantiated in a court of law.

All individuals should be considered innocent until proven guilty. In some situations, the statute of limitations has expired preventing the cases from being heard in a court of law. It is believed that the Diocese of Phoenix does not make available to the public the full history, knowledge and context of the sexually abusive clerics within the Diocese. *The Anderson Report on Sexual Abuse in the Diocese of Phoenix* is an attempt to compile information already available to the public from various public sources including the public media, bishopaccountability.org, the Diocese's public statements, and other sources that have attempted to chronicle this information for public use. This Anderson Report is intended to raise awareness about the important issue of clerical sexual abuse, provide the public with vital information including assignment histories, and provide awareness to survivors. The assignment histories provided are approximations which were compiled from the *Official Catholic Directory*, BishopAccountability.org, statements attributed to Diocesan and Religious officials, Diocesan and Religious records, and media reports.¹

¹The abbreviation in parenthesis following each assignment indicates the Diocese the individual was working and/or residing in at the time of the assignment.

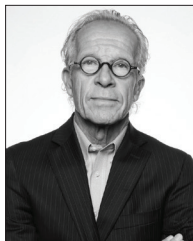

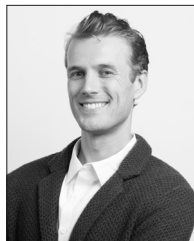

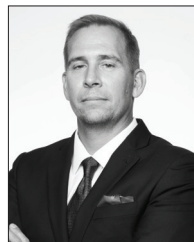

Abuse in the Diocese of Phoenix

The Anderson Report on Sexual Abuse in the Diocese of Phoenix is intended to be a chronology and analysis of the sexual abuse of children within the Diocese of Phoenix, including a discussion of how the highest Church officials enabled the abusers and covered up crimes of sexual misconduct and abuse.

The data reveal the horrifying scale of priests sexually abusing minors from early history, when the Diocese of Phoenix was included within the Dioceses of Tucson and Gallup before it was formed in 1969, to the present day. The data collected suggest the patterns and practices of Church officials, including the orchestrating of an institutional cover-up. Perhaps most shocking among the discoveries is that some perpetrators were transferred and retained in trusted positions with direct access to children even after they were alleged to be abusers. Modern means of analysis and availability of data through the Internet and social media is exposing perpetrators who operated in the geographical boundaries of this Diocese, but until full transparency and accountability exist, children remain in grave danger.

Historically, the Diocese of Phoenix, like many other dioceses and archdioceses, knew of priests who were perpetrators and posed a significant danger to children. The sexual abuse of children has long been a crime in Arizona. However, Church officials chose and continue to keep these crimes hidden, allowing their priests continued and unfettered access to children. During the 1980s and 1990s, occasional bits of information about clerical abuse surfaced, but the Church's strict policy of secrecy kept most of the information and full extent of the problem hidden from the public. This has continued despite mandated reporting laws.

History of the Diocese of Phoenix

The Diocese of Phoenix was established by Pope Paul VI on December 2, 1969. Prior to that establishment, the parishes, schools and other institutions within the Diocese of Phoenix were part of either the Diocese of Tucson or Diocese of Gallup. Edward A. McCarthy was appointed the first Bishop of the Diocese of Phoenix, serving from 1969 to 1976.

James S. Rausch was Bishop of the Diocese of Phoenix from 1977 to 1981. Thomas J. O'Brien, who previously served as Vicar General for the Diocese, was Bishop of the Diocese of Phoenix from 1982 to 2003. In 2003, after a Maricopa County Grand Jury investigation of Bishop O'Brien and the Diocese of Phoenix regarding clergy sexual abuse in the Diocese, Bishop O'Brien admitted that he covered up for sexually abusive priests. According to the investigation, he admitted that he allowed priests under his supervision to work with minors after he became aware of sexual abuse allegations and that priests accused of sexual misconduct were transferred to other assignments where children could be victimized without disclosing the priests' dangerous propensities to their new assignments.¹ The Maricopa County Attorney's Office noted that the grand jury uncovered evidence that Bishop O'Brien "failed to protect the victims of criminal sexual misconduct of others associated with the Roman Catholic Diocese of Phoenix." *Id.*

AGREEMENT

PARTIES

This Agreement is entered into this 3rd day of May, 2003, by and between the State of Arizona, ex. rel. Richard M. Romley, Maricopa County Attorney; Thomas J. O'Brien, Bishop of the Roman Catholic Diocese of Phoenix and the Roman Catholic Diocese of Phoenix, a corporation sole ("the Diocese").

DEFINITIONS

For purposes of this agreement, the following definitions apply:

"Priest" means any Diocesan priest, or any priest who is a member of a separate order.

"Diocesan Personnel" means the Bishop, any priest, nun, seminarian or deacon, and all employees and volunteers who perform any type of service or work for the Diocese, whether clergy or layperson.

INTRODUCTION

A Maricopa County Grand Jury is investigating and considering information relating to criminal sexual misconduct by diocesan personnel including, but not limited to, the criminal conduct of individual priests. The grand jury has also been investigating whether Thomas J. O'Brien or the Diocese failed to report to law enforcement authorities criminal sexual misconduct by priests and other Diocesan personnel, and whether Thomas J. O'Brien or the Diocese placed or transferred priests or other Diocesan personnel in or to a position to commit additional criminal conduct after becoming aware of prior criminal conduct.


Since 1961, Thomas J. O'Brien has been an ordained priest of the Roman Catholic Church. In 1969, Thomas J. O'Brien was appointed Chancellor of the Diocese. In 1978, Thomas J. O'Brien was appointed Vicar General of the Diocese. In 1981, Thomas J. O'Brien was appointed Bishop of the Roman Catholic Diocese of Phoenix. In that capacity, he assumed the responsibility of administering, supervising and overseeing the operation of the Diocese.


5. The Diocese, in conjunction with the Maricopa County Attorney's Office, shall implement a training program to educate Diocesan personnel on sexual misconduct issues, including the Mandatory Reporting Law (A.R.S. § 13-3620), and Maricopa County's Multidisciplinary Protocol for the Investigation of Child Abuse. The Maricopa County Children's Justice Project Team will be invited to conduct regular and ongoing training of all Diocesan personnel, including the training of Diocesan school personnel.
6. Thomas J. O'Brien shall, in a written public statement which is incorporated at Tab A, acknowledge that he allowed Roman Catholic priests under his supervision to have contact with minors after becoming aware of allegations of criminal sexual misconduct. He shall further acknowledge transferring offending priests to situations where children could be further victimized. In addition, Thomas J. O'Brien shall apologize and express contrition for any misconduct, hardship or harm caused to the victims of criminal sexual misconduct by Roman Catholic priests assigned to the Roman Catholic Diocese of Phoenix.
7. The Diocese will make a contribution to the Maricopa County Attorney's Victim Compensation Fund (Victim Assistance Fund, A.R.S. § 41-2408) in the sum of Three Hundred Thousand Dollars (\$300,000.00) within fourteen (14) days of the execution of this Agreement. These funds shall be used to compensate child victims of criminal sexual misconduct.
8. The Diocese will allocate a total of Three Hundred Thousand Dollars (\$300,000.00) of funds received by the Diocese for counseling of those victimized by child sexual abuse. The allocation shall be made at a rate of One Hundred Thousand Dollars (\$100,000.00) per year from the signing of this Agreement. It may be accelerated at the discretion of the Diocese.
9. Within 180 days of the signing of this Agreement, the Diocese shall create a Victim Assistance Panel. It will be a three-person panel composed of established and respected mental health professionals. This panel will consider requests from persons who indicate that they are victims of sexual misconduct by Diocesan personnel for counseling assistance for the victim and the victim's immediate family. This process will be available to all victims of sexual misconduct, including those persons whose legal claim for sexual misconduct are foreclosed by the statute of limitations, and those persons who have entered into binding settlement agreements, but now find that those settlement agreements were inadequate to address unforeseen impacts of their victimization. The panel will have the authority to approve requests for counseling. Approved requests for counseling would result in payment of counseling fees and costs to qualified treatment providers of up to Fifty Thousand Dollars (\$50,000.00) per any one victim and that victim's family, over the victim's lifetime.
10. The Diocese and the Maricopa County Attorney's Office will host a summit meeting on sexual abuse within twelve (12) months following the execution of this Agreement. The cost of the summit will be borne by the Diocese. Both the County Attorney and the

Diocese may invite anyone to attend the summit. The purpose of the summit is to provide a forum for exchange of information on sexual abuse and the responsibility of public and private employers and others to identify and appropriately deal with these issues.

11. One Hundred Thousand Dollars (\$100,000.00) shall be paid by the Diocese to the Maricopa County Attorney's Office as reimbursement for investigative expenses. The sum shall be paid within fourteen (14) days of execution of this Agreement.
12. The State of Arizona agrees not to initiate criminal charges against Thomas J. O'Brien or the Diocese arising out of information relating to the subject matter of this investigation for acts occurring on or before the date of the execution of this Agreement with the following exception: If information is forthcoming of personal, direct involvement of Thomas J. O'Brien in any act of criminal sexual misconduct, then charges shall not be precluded. This Agreement shall not preclude the Maricopa County Attorney's Office from prosecuting any other individual for criminal misconduct.
13. To protect the integrity of on-going investigations and not impede the conclusion of those investigations, this Agreement and its terms shall be kept confidential to be disclosed at the discretion of the Maricopa County Attorney's Office. Upon a decision of the Maricopa County Attorney's Office to disclose this Agreement and its terms, it is acknowledged that this Agreement will be a public document and the parties to the Agreement are free to hold separate and distinct public announcements and to supply supplemental information and to respond to questions posed by the media or members of the public except as prohibited by law.
14. In the event of any material breach of this Agreement, by Thomas J. O'Brien or the Diocese, as first determined by the Maricopa County Superior Court after notice and a hearing, this Agreement shall be rendered null and void and the State of Arizona shall have the right to pursue any and all remedies provided by law including, but not limited to, initiation of criminal proceedings. If Thomas J. O'Brien or the Diocese breaches this Agreement and the State files criminal charges, Thomas J. O'Brien and the Diocese agree that any applicable period of limitation is tolled from the effective date of this Agreement until the date on which the Agreement is rendered null and void.







STATEMENT OF BISHOP THOMAS J. O'BRIEN

I acknowledge that I allowed Roman Catholic priests under my supervision to work with minors after becoming aware of allegations of sexual misconduct. I further acknowledge that priests who had allegations of sexual misconduct made against them were transferred to ministries without full disclosure to their supervisor or to the community in which they were assigned. I apologize and express regret for any misconduct, hardship, or harm caused to the victims of sexual misconduct by Roman Catholic priests assigned to the Diocese.

TAB A

During the course of the grand jury's investigation, to this date, no credible evidence has been received that would establish that Thomas J. O'Brien personally engaged in criminal sexual misconduct. However, the investigation developed evidence that Thomas J. O'Brien failed to protect the victims of criminal sexual misconduct of others associated with the Roman Catholic Diocese of Phoenix.

This Agreement is executed upon the conclusion that the public interest would be best served by settling the matter without criminal prosecution of Thomas J. O'Brien or the Diocese. The following terms, representations, and conditions will insure that the Diocese complies with all applicable laws relating to criminal sexual misconduct by its agents, representatives, or employees. The following terms, representations, and conditions will contribute to the well-being of the community at large by offering counseling to victims of criminal sexual misconduct, reimbursing the State of Arizona for certain costs expended during the course of this investigation, and assuring compliance by the Diocese with all applicable laws relating to sexual misconduct.

THEREFORE, it is hereby represented and agreed that:

1. Bishop Thomas J. O'Brien has appointed a Moderator of the Curia. The Moderator of the Curia is a canonical position equivalent to "chief of staff". Certain administrative duties have been delegated by Thomas J. O'Brien to the Moderator of the Curia, which shall include the responsibility for dealing with issues that arise relating to the revision, enforcement and application of the sexual misconduct policy.
2. The Diocese has created and appointed the position of Youth Protection Advocate. That person shall be responsible for the implementation and enforcement of the policy on sexual misconduct by Diocesan personnel. Under the Diocesan policy, all Diocesan personnel, including the Youth Protection Advocate, are required to comply with all applicable federal, state and local laws regarding the reporting of incidents of actual, alleged, or suspected sexual misconduct without restriction. The decisions of the Youth Protection Advocate to report allegations of child sexual abuse to Child Protective Services or law enforcement is to be made by the Youth Protection Advocate independently and not subject to the consent of Thomas J. O'Brien, or any other Diocesan personnel.
3. With input from the Maricopa County Attorney's Office, a special counsel will be employed within sixty (60) days of the signing of this Agreement. This attorney shall be counsel for the Youth Protection Advocate. This special counsel's advice will not be subject to approval by anyone within the Diocese including, but not limited to, Thomas J. O'Brien or any other priest.
4. The Diocese's Policy on Sexual Misconduct is to be reviewed and modified. The Maricopa County Attorney's Office and the public shall be offered the opportunity to provide input prior to any adoption and/or revision of such policy.

Notes: Fr. Santiago Alamaguer was a member of the Franciscan Friars of the Province of Saint Barbara, part of what is formally known as the Order of Friars Minor. In 2018, Fr. Alamaguer was named on the Diocese of Las Cruces' list of "Priests and Religious Credibly Accused of sexual abuse of minors who have served within the current territorial boundaries of the Diocese of Las Cruces." According to this list, a report was made in 2012 alleging that Fr. Alamaguer sexually abused a minor from approximately 1975 to 1978. In 2019, Fr. Alamaguer was included in the Franciscan Friars Province of Saint Barbara's "List of Franciscan Friars from the St. Barbara Province with Credibly (sic) Claims of Sexual Abuse of a Minor" in the section "Former Province of St. Barbara Friars who have been Credibly Accused who have Left the Order." According to this list, a report was made in 1979 alleging that Fr. Alamaguer sexually abused a minor in approximately 1978. The Franciscan Friars' list also states that Fr. Alamaguer returned to the Mexico Province in 1979. Fr. Alamaguer's current status as a priest, his whereabouts, and whether he has access to children are unknown.

Fr. William G. Allison Ordained, 1948

Notes: Fr. William G. Allison has a storied history of child sexual abuse, having been accused by numerous individuals in Arizona, New Mexico, Louisiana, and California. The full extent of Fr. Allison's sexual abuse was not uncovered until 2011 when a man filed a lawsuit claiming he had been sexually abused as a child by Fr. Allison at Cathedral of San Carlos Borromeo in Monterey, California in approximately 1966. A file related to the lawsuit alleged that Fr. Allison was a known serial predator and there was documentation that he underwent treatment for his "psychosexual disorder" at Servants of the Paraclete, an institution known for treating priests accused of child sexual abuse. Despite all of this, Fr. Allison was still allowed to work in the Diocese of Monterey, where he purportedly continued to sexually abuse children. Due to a ruling on the statute of limitations, the case was dropped. In 2013, Fr. Allison was included in a civil lawsuit, which has since been settled, brought against the Diocese of Gallup for allegedly covering up child sexual abuse.

In 2005, Fr. Allison was named on the Diocese of Gallup's "List of priests, religious and other persons who have been credibly accused of sexual abuse of minors and who have served in parishes or institutions of the church located within the territorial limits of the Diocese of Gallup." The Diocese of Gallup published an updated list in which Fr. Allison is named again, titled "The following is a list of clergy identified by the Diocese of Gallup as having credible allegations of sexual misconduct made against them." In 2019, Fr. Allison was named on the Diocese of Alexandria's list of, "Clergy duly incardinated or at one time serving in the Diocese of Alexandria accused of sexual misconduct and abuse of minors by allegations brought by victims or by written testimony." Fr. Allison is also named on the Diocese of Monterey's "List of Credibly Accused" in the section "Credibly accused Clergy previously released or in the public domain who were working in the name of the Diocese of Monterey when the alleged abuse occurred."

Notes: Fr. Solomon Bandiho was a priest from the Diocese of Bukoba in Tanzania who attended the Jesuit School of Theology at Santa Clara University in Berkeley, California for doctoral studies. As part of a work-study program, Fr. Bandiho was assigned to Holy Cross in Mesa, Arizona in July 2014. Approximately five months after his assignment to Holy Cross in Mesa, Arizona, Fr. Bandiho was one of five arrested in an undercover child prostitution sting. Fr. Bandiho was named on the Diocese of Phoenix's list of "Names of priests and deacons from other dioceses who may no longer serve in the Diocese of Phoenix due to an accusation of sexual misconduct with a minor." According to this list, Fr. Bandiho also worked at St. Helen in Glendale, Arizona. Fr. Bandiho's current status as a priest, his whereabouts, and whether he has access to children are unknown.

Fr. Russell J. Banner

Notes: Fr. Russell J. Banner was ordained in the Diocese of Cleveland, Ohio. In 2002, Fr. Banner was placed on leave amid allegations of child sexual abuse. In a 2004 lawsuit, a second survivor accused Fr. Banner of child sexual abuse from approximately 1967 to 1969 at Parmadale, a Catholic children's home in Cleveland, Ohio. The survivor reported that Fr. Banner was a Deacon at the time of abuse and that he later served as an altar boy at Fr. Banner's ordination. Fr. Banner was named on the Diocese of Phoenix's list of "Names of priests and deacons from other dioceses who may no longer serve in the Diocese of Phoenix due to an accusation of sexual misconduct with a minor." The Diocese of Cleveland dispensed Fr. Banner from his clerical state in 2015. Fr. Banner is believed to be living in Bradenton, Florida and serving as the Coordinator of the Venice Diocese of Pax Christi International. Whether Fr. Banner has access to children is unknown.

Msgr. Leonard Adolph Bogdan

Ordained, 1960

Notes: Msgr. Leonard Adolph Bogdan was first accused of sexually abusing a minor child in 1981. Shortly thereafter, a second survivor reported that he had been allegedly sexually abused as a child by Msgr. Bogdan a year earlier. Msgr. Bogdan was transferred to the Diocese of Kalamazoo in approximately 1988. Msgr. Bogdan was eventually incardinated into the Diocese of Kalamazoo, in Michigan, in approximately 1993. Msgr. Bogdan became a high-ranking priest and worked as a Judicial Vicar in both the Archdiocese of Chicago in Illinois and the Diocese of Kalamazoo in Michigan. After he retired in 2000, the Archdiocese of Chicago Review Board found the original allegation of child sexual abuse to be credible, but the Archdiocese of Chicago is believed to have made no public announcement regarding the risk Msgr. Bogdan posed to the community until 2006, when the Archdiocese of Chicago named Msgr. Bogdan on their list of *“Archdiocesan Priest with Substantiated allegations of Sexual Misconduct with Minors,”* and on their 2018 list of *“Clergy with Substantiated Allegations of Sexual Misconduct with Minors.”* Msgr. Bogdan is believed to be living in Surprise, Arizona. Msgr. Bogdan’s status as a priest and whether he has access to children are unknown.

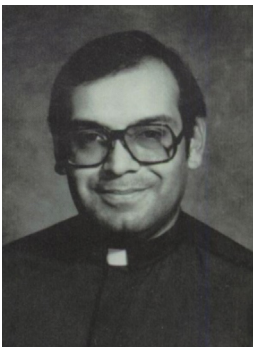
Fr. George V. Bredemann

Ordained, 1983

Notes: Although there were several letters in Fr. George V. Bredemann’s priest file recommending that he should not become a priest, Fr. Bredemann was ordained in the Diocese of Phoenix. Fr. Bredemann is alleged to have sexually abused 15 minor boys prior to becoming a priest and at least 8 minor boys while he was a priest in the Diocese of Phoenix. In 1988, Fr. Bredemann was arrested on charges relating to the sexual abuse of minor boys. In 1989, Fr. Bredemann was found guilty of the charges of child sexual abuse and was sentenced to one year in prison. After serving his sentence, Fr. Bredemann violated his probation by reportedly attempting to flee to Brazil. Fr. Bredemann was subsequently sentenced to 45 years in prison. In 2003, Fr. Bredemann was laicized and later died in prison. Fr. Bredemann was named on the Diocese of Phoenix’s list of *“Names of Diocese of Phoenix priests and deacons who have been laicized and/or removed from ministry due to sexual misconduct with a minor.”* Fr. Bredemann’s status as a priest, whereabouts, and whether he had access to children from 1991 until his death are unknown.

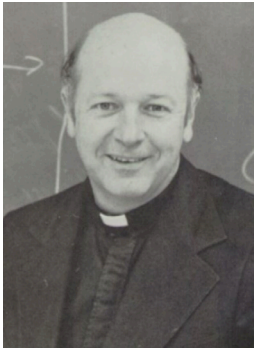
Fr. Joseph Cervantez Briceno (Brecino)

Ordained, 1981

Notes: Fr. Joseph Cervantez Briceno was ordained in the Diocese of Phoenix. The Diocese of Phoenix is believed to have first learned of an allegation of child sexual abuse by Fr. Briceno in 1992, but he was not removed from ministry until approximately 10 years later, when the allegation became public. In 2002, Fr. Briceno was permanently removed from ministry amid the allegation that he repeatedly sexually abused a minor boy from approximately 1982 to 1983 at St. Mary’s in Chandler, Arizona. Fr. Briceno was indicted later that year, but he reportedly had already fled to Mexico in response to the allegation of child sexual abuse. In 2003, Fr. Briceno was indicted on six counts relating to child sexual abuse. It is reported that Fr. Briceno worked as a priest at Cristo Rey in San Luis, Sonora, Mexico until he was extradited back to the United States in 2005. Fr. Briceno was sentenced to approximately two years in prison after admission of two counts of sexual conduct with a minor. Fr. Briceno was named on the Diocese of Phoenix’s list of *“Names of Diocese of Phoenix priests and deacons who have been laicized and/or removed from ministry due to sexual misconduct with a minor.”* Fr. Briceno was reportedly released from prison in 2007 and is believed to be living in Phoenix, Arizona. Fr. Briceno’s status as a priest and whether he has access to children are unknown.

Br. Robert Noel Brouillette, C.F.C.

Notes: Br. Robert N. Brouillette was a member of the Congregation of Christian Brothers. He worked in numerous dioceses nationwide and has been accused of child sexual abuse in several states including New York, California, Washington, Hawaii, Montana, Michigan, and Illinois. There have been several civil lawsuits filed against Br. Brouillette across the country which accuse him of child sexual abuse. At least six survivors allege that Br. Brouillette sexually abused them while they were minors between approximately 1984 and 1988 at Damien Memorial High School in Honolulu, Hawaii. Br. Brouillette was transferred to St. Laurence High School in Burbank, Illinois, where several survivors allege he engaged in child sexual abuse from approximately 1992 to 1998. It was also brought to light that superiors purportedly knew of Br. Brouillette's previous alleged sexual abuse with minors at other schools in Hawaii, Massachusetts, Michigan, and New Mexico. In 1998, Br. Brouillette was arrested when he solicited from an undercover law enforcement officer posing as a minor. In 2000, Br. Brouillette was convicted on 10 counts of child pornography charges and sent to residential treatment at St. John Vianney, a facility known for the treatment of priests accused of sexual misconduct with minors. In 2016, Br. Brouillette was named in the Archdiocese of Seattle's "*List of Clergy and Religious Brothers and Sisters for Whom Allegations of Sexual Abuse of a Minor Have Been Admitted, Established, or Determined to be Credible.*" The true number of survivors of child sexual abuse perpetrated by Br. Brouillette is unknown. Br. Brouillette has purportedly changed his name to Robert Sullivan and is believed to be living in Helena, Montana, where he is a registered sexual offender. Whether Br. Brouillette has access to children is unknown.

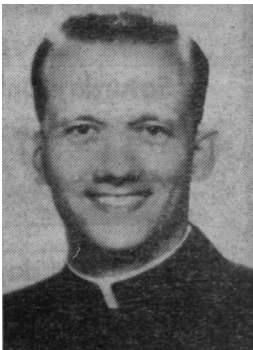

In 2006, a settlement was reached in a case involving Fr. Cimmarrusti and seven other priests accused of sexually abusing students at St. Anthony's Seminary High School, the Santa Barbara Boys Choir and the Santa Barbara Mission. At least 12 survivors have come forward to the Archdiocese of Los Angeles alleging sexual abuse between 1962 and 1969. Fr. Cimmarrusti was included in the Archdiocese of Los Angeles' "Report to the People of God: Clergy Sexual Abuse Archdiocese of Los Angeles" in the "Religious Order Priests and Brothers" section. Fr. Cimmarrusti's last known address was the San Damiano Retreat House in Danville, California. From approximately 1994 to his death in 2012, Fr. Cimmarrusti's whereabouts, his status as a priest and whether he had access to children are unknown.

Fr. 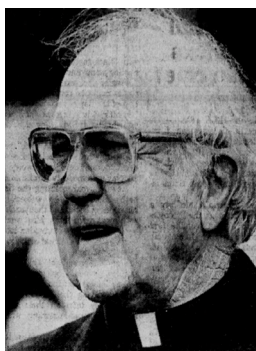

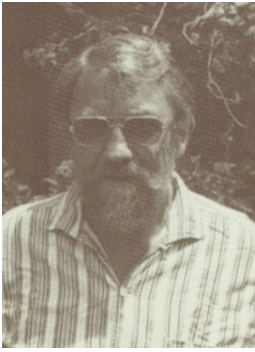

Deacon Gonzalez was listed in Diocesan records as a chaplain for the Federal Bureau of Prisons in the Diocese of Harrisburg, Pennsylvania, from 1983 to 2010. While in Dallas, he was assigned to a parish in Coppell, Texas. Deacon Gonzalez's name was included in the Diocese of Harrisburg's 2018 list of "Clergy & Seminarians Accused of Sexual Abuse of a Child" under the section "Cases Where Abuse was First Alleged While the Accused was Living" and "Cases Involving Allegations of Indecent Behavior." Deacon Gonzalez was also included on the Diocese of Phoenix's list of "Names of priests and deacons from other dioceses who may no longer serve in the Diocese of Phoenix due to an accusation of sexual misconduct with a minor." Deacon Gonzalez's current whereabouts and whether he has access to children are unknown.



Fr. Harold P. Graf

Ordained, 1968

Notes: Fr. Harold P. Graf was ordained in the Diocese of Rockville Centre, New York. In June 2002, Fr. Graf was suspended due to allegations of sexual misconduct with a child that occurred in approximately 1978. Fr. Graf was permanently barred from ministry later that year. Fr. 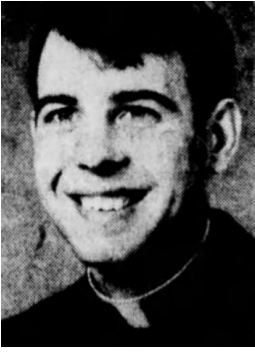

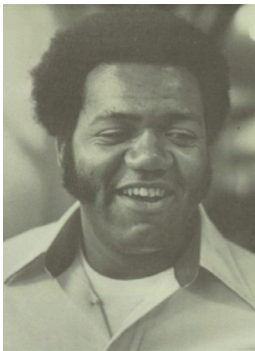

Knighton was criminally charged on counts relating to child sexual abuse that occurred in approximately 1988 and 1989 while he worked at Pius XI High School in Milwaukee, Wisconsin. Fr. Knighton was acquitted in a jury trial the following year. In 2003, another survivor came forward to accuse Fr. Knighton of child sexual abuse in or about the 1970s. Following the second allegation of child sexual abuse, the Archdiocese of Milwaukee allegedly removed Fr. Knighton from public ministry. Fr. Knighton was named on the Archdiocese of Milwaukee's list of "Diocesan priests of the Archdiocese of Milwaukee who have been (or would be if they were still alive) restricted from all priestly ministries due to substantiated reports of sexual abuse of a minor." Fr. Knighton was also named on the Diocese of Phoenix's list of "Names of priests and deacons from other dioceses who may no longer serve in the Diocese of Phoenix due to an accusation of sexual misconduct with a minor." Fr. Knighton was laicized in 2011 and is currently believed to be living in Phoenix, Arizona. Whether he has access to children is unknown.

Fr. Louis “Louie” Wayne Ladenburger, O.F.M. Ordained, 1963

Notes: Fr. Louis Ladenburger was a member of the Franciscan Friars of the Province of Saint Barbara, part of what is formally known as the Order of Friars Minor. Fr. Ladenburger worked in various parishes throughout California, Oregon, Washington, Nevada, and Idaho. In 1993, Fr. Ladenburger was restricted from ministry and ordered to undergo a psychological evaluation. Fr. Ladenburger purportedly refused the evaluation and instead asked for a dispensation of his vows. He was officially laicized in 1996. After leaving the priesthood, Fr. Ladenburger reportedly became licensed in marriage and family therapy and as a chemical dependency therapist. In 2007, he was arrested on charges relating to sexually abusing minor students while he worked as a therapist at Elk Mountain Academy in Clark Fork, Idaho. When arrested, Fr. Ladenburger supposedly admitted to police that he was a long-suffering sex addict. In 2008, Fr. Ladenburger was sentenced to five years in prison with the possibility of parole after six months.

Fr. Ladenburger was named in the Franciscan Friars Province of Saint Barbara’s “*List of Franciscan Friars from the St. Barbara Province with Credibly (sic) Claims of Sexual Abuse of a Minor*” in the section “*Deceased Former Province of St. Barbara Friars Who Have Been Credibly Accused*.” According to this list, reports were made in 1984 and 2018 alleging that Fr. Ladenburger sexually abused a minor from approximately 1973 to 1974. Additionally, in 2018, a survivor came forward to accuse Fr. Ladenburger of child sexual abuse from approximately 1972 to 1974 while he worked at St. Mary’s of the Assumption in Stockton, California. As of 2012, Fr. Ladenburger was believed to be living in Bakersfield, California, and is currently believed to be living in Phoenix, Arizona. Whether he has access to children is unknown.

Fr. Fr. Sung Lam

Ordained, 1966

Notes: Fr. Sung Lam was reportedly a priest from the Diocese of Phnom-Penn in Cambodia who worked in the Diocese of Phoenix. Fr. Lam was named on the Diocese of Phoenix's list of "Names of priests and deacons from other dioceses who may no longer serve in the Diocese of Phoenix due to an accusation of sexual misconduct with a minor." According to this list, a report was made in 1993 accusing Fr. Lam of sexual misconduct with a minor. This list also states that Fr. Lam worked in the Vietnamese Catholic Apostolate within the Diocese of Phoenix and left the Diocese in 1994. Fr. Lam's status as a priest, current whereabouts, and whether he has access to children are unknown.



Fr. Paul LeBrun, C.S.C.

Ordained, 1983

Notes: Fr. Paul LeBrun was ordained a Holy Cross priest and has been accused of sexually abusing at least 10 children in the Diocese of Ft. Wayne-South Bend, Indiana and the Diocese of Phoenix. In 2002, four survivors came forward alleging Fr. LeBrun sexually abused them as children from approximately 1979 to 1986 when he worked at St. Therese Little Flower in South Bend, Indiana. A fifth survivor came forward to allege child sexual abuse by Fr. LeBrun in approximately 1991 while Fr. LeBrun worked at Blessed Sacrament in Tolleson, Arizona. Fr. LeBrun was subsequently arrested on charges relating to child sexual abuse in 2003. Several more survivors came forward to allege child sexual abuse by Fr. LeBrun at St. John Vianney in Avondale, Arizona. In 2005, Fr. LeBrun was convicted of sexually abusing five minor boys between approximately 1986 and 1991 at St. John Vianney in Avondale, Arizona and Blessed Sacrament in Tolleson, Arizona. Fr. LeBrun was given the maximum sentence of 111 years in prison in 2006.

An attorney for the Congregation of the Holy Cross allegedly stated that reports of child sexual abuse by Fr. LeBrun were reportedly made to the Congregation of the Holy Cross in 1987, 1993, and 1998. Fr. LeBrun was named on the Diocese of Phoenix's "Names of priests of religious communities who have served in the Diocese of Phoenix and have been laicized and/or removed from ministry by their communities due to sexual misconduct with a minor." Fr. LeBrun was also named on the Diocese of Fort Wayne-South Bend's list of "Priests and deacons credibly accused of sexual abuse of a minor" in the section "List of the names of priests and deacons who have served in the Diocese of Fort Wayne-South Bend and have been credibly accused of at least one act of sexual abuse of a minor." According to this list, Fr. LeBrun's faculties for ministry were removed by the Diocese of Fort Wayne-South Bend in 2000 and he was laicized in 2008. Fr. LeBrun is currently still in prison in Arizona.

LeClaire was arrested on multiple charges relating to child sexual abuse. During the trial, another survivor accused Fr. LeClaire of allegedly sexually abusing him when he was a minor in approximately 1999 at Queen of Peace in Mesa, Arizona. Fr. LeClaire was subsequently sentenced to one year in jail and three months' probation. Fr. LeClaire was named on the Diocese of Phoenix's "Names of priests of religious communities who have served in the Diocese of Phoenix and have been laicized and/or removed from ministry by their communities due to sexual misconduct with a minor." Fr. LeClaire is currently believed to be living in Apache Junction, Arizona. His status as a priest and whether he has access to children are unknown.

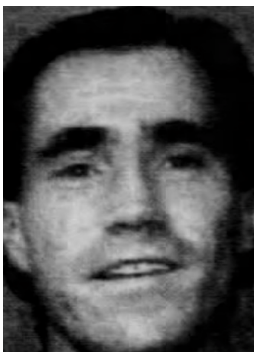

Fr. Mark Allen Lehman

Notes: On June 29, 1990, Bishop O'Brien reportedly publicly admitted that Fr. Lehman, then 28 years old, a teacher at St. Thomas the Apostle, and an associate pastor of the parish, was placed on leave of absence after allegations of sexual abuse were reported by two minor girls at the school. In 1992, Fr. Lehman was criminally convicted and sentenced to 10 years in prison without parole for the sexual abuse of one minor girl and sentenced to lifetime parole for the sexual abuse of three additional minor girls and one boy. The Diocese of Phoenix purportedly provided financial support while Fr. Lehman was in prison and gave him \$1000 and other benefits when he was released in 2002. In 2005, a lawsuit was filed alleging that Fr. Lehman sexually abused a child at St. Timothy's in Mesa, Arizona in approximately 1985. Fr. Lehman was laicized in April 2006 and was reportedly listed on the Arizona sex offender registry at one time. Fr. Lehman was included on the Diocese of Phoenix's list of "Diocese of Phoenix priests and deacons who have been laicized and/or removed from ministry due to sexual misconduct with a minor." Fr. Lehman is currently believed to be living in Tempe, Arizona. Whether he has access to children is unknown.

Notes: Fr. Joseph Marcel Lessard was ordained a priest in the Diocese of Phoenix. In 1985, Fr. Lessard was arrested and charged for alleged sexual misconduct with a minor in Phoenix, Arizona. Fr. Lessard reached a plea agreement and was sentenced to three years' probation. In 2001, Fr. Lessard was reportedly removed from ministry by the Diocese of Rockford and in 2002, he was subsequently removed from active ministry by the Diocese of Phoenix. In 2003, Fr. Lessard was named in a child sexual abuse lawsuit which was later settled by the Diocese of Phoenix. In 2006, the Diocese of Phoenix reportedly stated that Fr. Lessard had moved to Thailand. In 2018, Fr. Lessard was included in the Diocese of Rockford's list of "Religious Order Priests/Brothers or Priests of another diocese, who worked within the geographical boundaries of the Rockford Diocese or were assigned in this Diocese, against whom a substantiated allegation of sexual abuse of a minor has been reported." Fr. Lessard is also included on the Diocese of Phoenix's list of "Diocese of Phoenix priests and deacons who have been laicized and/or removed from ministry due to sexual misconduct with a minor." According to this list, Br. Lopez moved to Mexico in 1997. Br. Lopez's whereabouts, status as a brother, and whether he had access to children from 1998 until his death are unknown.

In 1986, after being criminally charged for sexually abusing a child, Fr. Lovell pleaded no contest and received three years' probation. After he was criminally convicted, Fr. Lovell was removed from ministry. At some point, Fr. Lovell was sent to Servants of the Paraclete, an institution known for treating priests accused of child sexual abuse. He was laicized in 1992. It is believed that Fr. Lovell was residing in Rio Rancho, New Mexico in the mid-1990s. In 2003, Fr. Lovell was arrested and criminally charged in California for sexually abusing a child under the age of 14, but the charges were later dismissed. Fr. Lovell was also indicted for child sexual abuse in Arizona in 2003 and pleaded guilty. As of 2013, Lovell was serving a 14-year sentence for sexually abusing children in Yavapai and Maricopa counties in Arizona. Fr. Lovell was included in the Archdiocese of Los Angeles' "Report to the People of God: Clergy Sexual Abuse Archdiocese of Los Angeles." Fr. Lovell was also included in the Diocese of Phoenix's list of "Diocese of Phoenix priests and deacons who have been laicized and/or removed from ministry due to sexual misconduct with a minor." Fr. Lovell is currently still in a correctional facility in Florence, Arizona.

Madigan was included on the Crosiers' "List of names of Crosiers with one or more credible claims of sexual abuse of minors" in the section "The following Crosiers were named publicly. Since then, three have died and one has left the Crosier Order." Br. Madigan is believed to be living under restriction in Phoenix, Arizona. His current status as a brother and whether he has access to children are unknown.

Madrid resigned from his dual assignments in 2000, citing health reasons. Fr. Madrid remained a priest and is believed to be living in Tempe, Arizona. Fr. Marsicek was included on the Diocese of Phoenix's *"Names of priests of religious communities who have served in the Diocese of Phoenix and have been laicized and/or removed from ministry by their communities due to sexual misconduct with a minor."* Fr. Marsicek's status as a priest, current whereabouts, and whether he has access to children are unknown.

Notes: Fr. Donald McGuire was a Jesuit priest accused of sexually abusing many children throughout his career. The Jesuits allegedly first received reports of Fr. McGuire's child sexual abuse in the late 1960s. Several more reports regarding Fr. McGuire's sexually abusive behavior were made in the decades that followed. In 2006, Fr. McGuire was criminally convicted of sexually abusing two minor students of Loyola Academy in Wilmette, Illinois, between 1968 and 1969, during his time as a faculty member at the school. In 2008, he was criminally convicted of traveling to engage in sex acts with a minor teenager who he took on trips to Minnesota, Switzerland, and Austria from approximately 1999 to 2002. Fr. McGuire has also been named as a defendant in multiple civil lawsuits alleging both child and adult sexual abuse of the plaintiffs. Fr. McGuire was listed on the Illinois Sex Offender Registry until his death in 2017. According to the Diocese of Phoenix, Fr. McGuire worked at Mount Claret Retreat Center in Phoenix, Arizona. Fr. McGuire is named on the Diocese of Phoenix's "Names of priests of religious communities who have served in the Diocese of Phoenix and have been laicized and/or removed from ministry by their communities due to sexual misconduct with a minor." He is also named on the Jesuit's West Province of the Society of Jesus' "List of Jesuits from Jesuits West Province with Credible Claims of Sexual Abuse of a Minor or Vulnerable Adult" in the section "Deceased and Former California Province Jesuits with Credible Claims." Fr. McGuire was laicized in 2008. His whereabouts and whether he had access to children from 2006 until his death are unknown.

Fr. Dennis A. Pecore, S.D.S

Notes: Prior to becoming a priest, Fr. Dennis A. Pecore was a Salvatorian brother. He reportedly worked as a Salvatorian brother from 1975 to 1976 at Holy Trinity in Glen Burie, Maryland. There has been at least one allegation of sexual abuse involving Fr. Pecore when in Maryland. In 1987, Fr. Pecore was charged with sexually abusing a child at Mother of Good Council in Milwaukee, Wisconsin in approximately 1985. Fr. Pecore was sentenced to one year in the Milwaukee County House of Correction with work release privileges and was placed on five years' probation. In 1993, Fr. Pecore was accused of sexually abusing his nephew, a minor boy, from approximately 1989 to 1992. Upon his conviction, he was sentenced to twelve years in prison and ten years' probation. In 2018, a lawsuit was filed alleging that Fr. Pecore sexually abused a minor at St. Mary's in Phoenix, Arizona. Fr. Pecore was laicized in 1995. Fr. Pecore was included on the Diocese of Phoenix's "Names of priests of religious communities who have served in the Diocese of Phoenix and have been laicized and/or removed from ministry by their communities due to sexual misconduct with a minor." Fr. Pecore is currently believed to be living in Milwaukee, Wisconsin. His status as a priest and whether he has access to children are unknown.

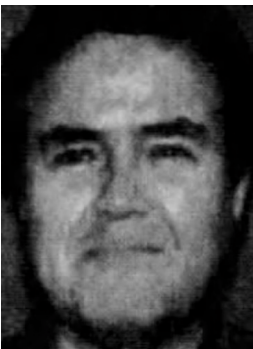

In 2009, Deacon Pelton was arrested and charged with sexually abusing a minor child. At that time, his faculties were revoked and a civil claim was filed against him in 2010. Deacon Pelton is listed on the Diocese of Phoenix's "List of priests and deacons who have been laicized and/or removed from ministry due to sexual misconduct with a minor." Deacon Pelton's whereabouts and whether he had access to children prior to his death in 2010 are unknown.



Fr. Henry Perez, S.M.

Ordained, 1973

Notes: Fr. Perez was included in the Archdiocese of Los Angeles', "Report to the People of God: Clergy Sexual Abuse Archdiocese of Los Angeles." According to this report, Fr. Henry Perez was originally ordained a Marist priest in Arizona. He was incardinated into the Diocese of Orange, California, in May 1989. In 1991, Fr. Perez left active ministry and was placed on administrative leave without faculties in the Diocese of Orange. In 1993, two lawsuits were filed against Fr. Perez that accused him of sexually abusing a minor boy from approximately the late 1970s to early 1980s while he worked in the Diocese of Phoenix. Fr. Perez was indicted on six felony charges of sexual conduct with a minor and one charge of misdemeanor public sexual indecency. Shortly following the indictment, Fr. Perez died. Fr. Perez was named in the Diocese of Orange's "List of Credibly Accused Priests Incardinated in the Diocese of Orange" in the section "Removed from ministry (forbidden from presenting himself as a priest or from performing any priestly functions)." Fr. Perez was also included on the Diocese of Phoenix's "List of names of priests of religious communities who have served in the Diocese of Phoenix and have been laicized and/or removed from ministry by their communities due to sexual misconduct with a minor." Fr. Perez's whereabouts and whether he had access to children from 1992 until his death in 2003 are unknown.

Perreault was permanently banned from ministry in the Diocese of San Bernardino and retired without faculties. Fr. Perreault's current whereabouts and whether he has access to children are unknown.

Despite a record of sexual abuse allegations stemming from his assignments in Boston and New Jersey, the Diocese of Phoenix accepted Fr. Picardi into the Diocese to "begin his ministry again in Phoenix." Fr. Picardi is currently believed to be living in Arlington, Massachusetts. His status as a priest and whether he has access to children are unknown.

Riebe is listed on the Diocese of Phoenix's list of "Names of priests and deacons from other dioceses who may no longer serve in the Diocese of Phoenix due to an accusation of sexual misconduct with a minor." It is believed Fr. Riebe was residing in Los Angeles as of 2016. His current status as a priest, whereabouts and whether he has access to children are unknown.

Fr. Rourke has been named in at least one civil lawsuit. Fr. Rourke reportedly died by suicide in 1993 while under investigation for alleged sexual abuse of children in Albuquerque, New Mexico. Fr. Rourke's status as a priest, whereabouts, and whether he had access to children from 1983 until his death are unknown.

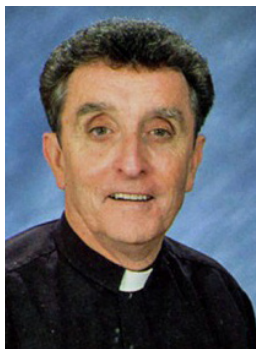

There were a total of four credible allegations before a special tribunal recommended Fr. Spaulding be laicized in 2014, after it found him guilty of "sins against the Sixth Commandment with a minor." Fr. Spaulding was included on the Diocese of Phoenix's list of "Diocese of Phoenix Priests and Deacons who have been accused of sexual misconduct with a minor and have a Canonical case in process." It is believed Fr. Spaulding may be residing in Phoenix. Fr. Spaulding's status as a priest and whether he has access to children are unknown.

By 2002, six women had come forward alleging that they had been sexually abused as children by Fr. Sullivan in Grand Rapids, Michigan. Fr. Sullivan is on the Diocese of Phoenix's List of "Diocese of Phoenix priests and deacons who have been laicized and/or removed from ministry due to sexual misconduct with a minor." His whereabouts and whether he had access to children from 1980 until his death in 1999 are unknown.

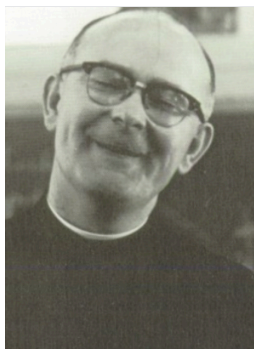

In 2014, a civil lawsuit was filed alleging child sexual abuse by Br. Zlatis. In 2016, Br. Zlatis was named in another lawsuit in Hawaii. The plaintiff alleged Br. Zlatis sexually abused him in approximately 1982 when he was a student at Damien Memorial High School. It is believed that Br. Zlatis remained in ministry without restriction until he died in 2009.

Notes: Fr. Francis “Frank” R. Zappitelli was ordained in the Diocese of Youngstown, Ohio. He moved to Arizona in 1983 and was incardinated into the Diocese of Phoenix. In 2018, Fr. Zappitelli was removed from public ministry in the wake of an allegation that he engaged in sexual misconduct with a minor in the mid-1970s. Fr. Zappitelli was included on the Diocese of Youngstown’s list of “*Clergy of the Diocese of Youngstown against whom credible, substantiated allegations of sexual abuse of a minor have been made.*” Fr. Zappitelli was also included on the Diocese of Phoenix’s list of “*Diocese of Phoenix priests and deacons who have been laicized and/or removed from ministry due to sexual misconduct with a minor.*” Fr. Zappitelli’s status as a priest, current whereabouts, and whether he has access to children are unknown.
