DECLARATION OF STEVEN VICTOR TALLARICO

I, Steven Victor Tallarico, a/k/a Steven Tyler, declare as follows:

I am a defendant in this action. I submit this declaration in support of my Special
 Motion to Strike Portions of Plaintiff's Complaint Pursuant to Code of Civil Procedure § 425.16
 and for Attorneys' Fees. If called as a witness, I could and would competently testify under oath to
 all the facts within my personal knowledge except where stated upon information and belief.

7 2. My bandmates and I formed Aerosmith in or around 1970, and I have been writing,
8 recording and performing music as Aerosmith's lead singer for more than fifty years. During that
9 time, Aerosmith has released fifteen studio albums, including top-10 hit songs such as "Dream
10 On" and "Walk This Way" in the 1970s, "Janie's Got a Gun," "What It Takes," and "Love in an
11 Elevator" in the 1980s, "I Don't Want to Miss a Thing" in the 1990s, and "Jaded" in the 2000s.

3. Aerosmith's 1998 rock ballad "I Don't Want to Miss a Thing" was the first song by
a rock band to debut at the number one spot on the *Billboard* Hot 100 and received an Academy
Award nomination for "Best Original Song" (among other nominations and awards) as the theme
song for the film *Armageddon*.

16 4. I played the Super Bowl halftime show with Aerosmith in 2001. We were also17 inducted into the Rock and Roll Hall of Fame that same year.

18 5. In or around 2008, I was included on *Rolling Stone*'s list of the 100 Greatest
19 Singers of All Time. In 2013, I was inducted into the Songwriters' Hall of Fame.

20 6. On January 19, 2011, I made my debut appearance on the hit-TV show *American*21 *Idol.* I served on *American Idol*'s panel of judges for two seasons of the show—specifically,
22 Seasons 10 and 11.

23 7. In or around 2008, the right to publish my personal memoir, which had not yet been
24 written, was auctioned for millions of dollars.

8. Walk This Way: The Autobiography of Aerosmith was published in 1997, and Does
the Noise in My Head Bother You?: A Rock 'n' Roll Memoir was published in May of 2011. I was
