17 PRELIMINARY ALLEGATIONS

18 *A. Jurisdiction*

- 19 1. This action involves fraudulent transfers of real property in San Diego and
20 Imperial Counties including transfers in the city of San Diego. Plaintiffs' principal
21 damages exceed \$25,000.

22 *B. The Parties*

- 23 2. Plaintiffs are all individuals who reside in various states, including California.
24 Some of the Plaintiffs reside in San Diego County.
- 25 3. Defendant THE ROMAN CATHOLIC BISHOP OF SAN DIEGO, A
26 CORPORATION SOLE ("Diocese") is a California corporation sole, authorized to
27 conduct business and conducting business in the State of California, with its principal
28

1 place of business in the city and county of San Diego, California. Defendant Diocese has
2 responsibility for Roman Catholic Church operations in San Diego and Imperial
3 Counties, California. Defendant Diocese is run by the individual holding the title of the
4 Roman Catholic Bishop of San Diego, and Defendant Diocese is the corporation through
5 which the Roman Catholic Diocese of San Diego operates. The Diocese of San Diego is
6 the Diocese in which the sexual abuse of Plaintiffs occurred.
7

8 4. The other named Defendants (individually a “Parish” and two or more “Parishes”)
9 are each a Roman Catholic Real Property Support Corporation corresponding to a Roman
10 Catholic church in San Diego or Imperial County. Each Defendant Parish was created to
11 aid the Catholic Church with which it is associated, including by holding title to real
12 property. Because each of the Real Property Support Corporations is only involved in
13 one or a few of the causes of action alleged below, rather than identify each such
14 Defendant in this section, each such Parish will be identified in the first of the Causes of
15 Action applicable to that Parish.
16

17 5. Defendant Does 1 through 1000, inclusive, are individuals and/or business or
18 corporate entities incorporated in and/or doing business in California whose true names
19 and capacities are unknown to Plaintiffs, who therefore sue such Defendants by such
20 fictitious names, and who will amend the Complaint to show the true names and
21 capacities of each such Doe Defendant when ascertained. Each such Defendant Doe is
22 legally responsible in some manner for the events, happenings and/or tortious and
23 unlawful conduct that caused the injuries and damages alleged in this Complaint.
24

25 6. Each Defendant is the agent, servant and/or employee of other Defendants, and
26 each Defendant was acting within the course and scope of his, her or its authority as an
27 agent, servant and/or employee of the other Defendants. The Defendants, and each of
28 them, are individuals, corporations, partnerships and other entities which engaged in,

1 joined in and conspired with the other wrongdoers in carrying out the tortious and
2 unlawful activities described in this Complaint. Each of the Defendants ratified the acts
3 of the other Defendants as described in this Complaint.

4 C. *Plaintiffs' Claims*

5 7. Since January 2, 2020, Plaintiffs collectively filed 36 lawsuits against the
6 Diocese, and/or others, San Diego Superior Court, Case Nos. 2020-00000284, 2020-

14 an "Underlying Action" and two or more the "Underlying Actions").

15 8. In each of the Underlying Actions, each of the Plaintiffs alleges that they were
16 sexually abused by a Catholic Priest, Catholic Priests, or other employees of a catholic
17 entity in San Diego or Imperial County, that they suffered damages as a result of the
18 abuse, that they are entitled to money damages as a result of the abuse and that the
19 Diocese is jointly liable for all money damages which each of the Plaintiffs is entitled to
20 recover.
21

22 9. By virtue of their allegations in the Underlying Actions, each of the Plaintiffs is a
23 "Creditor" as defined in Civil Code § 3439.01(c) and each of the Plaintiffs have a
24 "Claim" against each of the Defendants (collectively the "Claims") in this lawsuit as
25 defined in Civil Code § 3439.01(b).

1 10. All of the tortious conduct alleged by each of the Plaintiffs in the Underlying
2 Actions, occurred before September 1, 2019.

3 11. Reserved.

4 **D. *The Diocese’s Prior Efforts to Shield its Assets and Defraud Survivors of Clergy Sexual***
5 ***Abuse.***

6 12. Effective January 1, 2003, the Legislature amended Code of Civil Procedure §
7 340.1 to allow for civil actions based on childhood sexual abuse – even abuse dating back
8 many years - to be filed at any time during the 2003 calendar year. During that one-year
9 period at least 146 civil lawsuits were filed against Diocese. These lawsuits alleged
10 sexual abuse by Catholic priests and other employees of the Diocese. The Diocese’s
11 efforts to defraud survivors of child sexual abuse by its clergy date back at least to that
12 earlier litigation.

13 13. In February of 2007, when the first of those 146 clergy abuse survivors were on
14 the doorstep of the first civil trial against the Diocese, the Diocese filed a Chapter 11
15 Bankruptcy as a tactic to avoid trial. The filing of the bankruptcy proceeding
16 automatically stayed the imminent jury trial and halted all pending litigation in every
17 other civil case.

18 14. While the filing of the bankruptcy caused all state court proceedings to come to a
19 halt, it also required the Diocese to make a full and complete disclosure - under the
20 penalty of perjury - of all of its assets including all real estate, cash and cash equivalents.

21 15. In an apparent effort to deceive the bankruptcy court and defraud the child abuse
22 survivor creditors, the Diocese’s required bankruptcy schedules omitted as assets of the
23 Diocese: 1) nearly \$100,000,000.00 in cash held in what it referred to as “the Diocesan
24 Bank”; 2) hundreds of parcels of real property (although the deeds were titled in The
25 Roman Catholic Bishop of San Diego, a corporation sole, or some variation of that
26 27

1 name); and 3) a \$50,000,000 gift, which the Diocese conveniently converted to a loan
2 just before filing for bankruptcy.

3 16. The Diocesan Bank was, in fact, several individual accounts held at Union Bank
4 under the taxpayer identification of the Diocese. When the Diocese was questioned about
5 its failure to disclose these funds in its bankruptcy schedules, it claimed that it was
6 merely holding the funds in trust for the Parishes. On the other hand, when the Diocese
7 had previously applied for construction financing to build Cathedral Catholic High
8 School, the Diocese had represented to the lender, under oath, that the money in these
9 individual accounts at Union Bank totaling the nearly \$100,000,000.00 were assets of the
10 Diocese.
11

12 17. During the bankruptcy proceedings, Union Bank advised Judge Louise DeCarl
13 Adler that the Diocese was attempting to change the tax identification numbers of these
14 accounts to the tax identification numbers of various parishes. Judge Adler summoned
15 Diocesan officials to appear and threatened to hold them in contempt for attempting to
16 transfer assets when, as a matter of law, all assets were frozen by the bankruptcy.
17

18 18. Judge Adler appointed a neutral auditor to investigate several suspicious transfers
19 and other deceptive dealings by the Diocese which had occurred either during the
20 bankruptcy or in contemplation of the bankruptcy. The auditor wrote a scathing report
21 detailing attempts by some parish priests to hide money, the Diocese's efforts to seriously
22 undervalue its properties, as well as its failure to account for certain interest income that
23 belonged to the Diocese.
24

25 19. Prior to filing for bankruptcy, the Diocese had asked for and received a
26 commitment for a \$50,000,000 gift from the ALSAM foundation to help build Mater Dei
27 Catholic High School. Years later, in contemplation of the bankruptcy, the Diocese
28 converted the gift to a loan encumbered by the new school. Thus, the Diocese attempted

1 to convert a \$50,000,000 asset into a debt, even though the terms of the loan permitted a
2 forgiveness of the debt later.

3 20. Among the Diocese's real property holdings at the time of the bankruptcy were
4 nearly 300 parcels of real property (which are the parcels at issue in this action) titled in
5 the name of the Diocese. Despite holding title to these properties, the Diocese claimed it
6 did not really own them, but instead held them in trust for its parishioners.
7

8 21. During 2003, when a flood of lawsuits were being filed by childhood sexual abuse
9 survivors against the Diocese, its general counsel, Michael Webb, learned that attorney
10 Irwin Zalkin would be filing lawsuits on behalf of dozens of clients against not only the
11 Diocese, but also the individual parishes. Webb contacted Zalkin via email and advised
12 that there was no need to name the parishes separately in any lawsuit because the
13 "parishes are ours" referring to the Diocese.
14

15 22. As with the Webb email, the Diocese had successfully argued in litigation that it
16 owned and controlled certain Parish property. In 1974, a group of Spanish-speaking
17 parishioners used their own funds to purchase a parcel of land in Pauma Valley along
18 Highway 76 with the intention of building a parish hall - Centro Guadalupano de Pauma
19 Valley. The deed to the property was titled in the name of the Roman Catholic Bishop of
20 San Diego and Centro Gaudalupano de Pauma Valley.
21

22 23. In 2003, the Diocese decided to transfer the property to Father Joe Carroll,
23 president of S.V.D.P. Management, Inc., to develop affordable housing. In 2004, a group
24 of parishioners sued the Diocese claiming that the property was theirs and was simply
25 being held in the name of the Diocese for their benefit. The parishioners claimed the
26 Diocese had no right to transfer their property. The Diocese sought and was granted
27 summary judgment. The court held that the parishioners, even though their parish was on
28

1 the deed and they had located and purchased the real property, had no standing to sue.
2 The Diocese was free to transfer title to the property.

3 24. Ultimately, on the eve of Judge Adler remanding numerous cases to the state
4 court to proceed to trial, the Diocese settled 144 pending actions (unintentionally
5 omitting two which settled later) for more than \$198,000,000: an average of
6 approximately \$1,375,000 per case.
7

8 ***E. The Diocese's Efforts to Settle the Claims of Clergy Abuse Survivors For Pennies on the***
9 ***Dollar.***

10 25. By January of 2019, it was a near certainty that the California Legislature would
11 pass legislation to amend the statute of limitations applicable to claims based on
12 childhood sexual assault. On January 16, 2019, Assemblywoman Lorena Gonzalez
13 Fletcher introduced Assembly Bill 218 ("AB 218.") AB 218 would amend Code of Civil
14 Procedure § 340.1 to create a three-year filing period for survivors of childhood sexual
15 assault to commence civil actions. In practical effect, AB 218 ensured that Plaintiffs'
16 Underlying Actions could proceed.
17

18 26. On April 1, 2019, AB 218 passed the Assembly by a vote of 64-3. AB 218
19 moved on to the Senate where it was passed by the Senate Judiciary Committee on July
20 2, 2019 by a vote of 7-1. On August 30, 2019, AB 218 passed from the Senate
21 Appropriations Committee suspense file with a minor amendment. The Senate passed
22 the amended version of AB 218 on September 14, 2019 by a vote of 33-0. That same day
23 the Assembly voted 69-0 to concur in the amendments and send AB 218 on to the
24 Governor for signature. On October 13, 2019, the Governor signed AB 218.
25

26 27. To provide some scale to the potential liability facing the Diocese by virtue of AB
27 218, consider Father Edward Anthony Rodrigue. On information and belief, Father
28 Rodrigue was ordained in April of 1962 and assigned to Mary Star of the Sea Catholic

1 Church in La Jolla. Father Rodrigue continued to serve in various parish assignments
2 with the Diocese until the Diocese of San Bernardino was formed in approximately 1978
3 and Father Rodrigue was transferred to the Diocese of San Bernardino.

4 28. Plaintiffs are informed and believe, and on that basis allege that Father Rodrigue
5 was twice arrested for child molestation. During one of those prosecutions, Father
6 Rodrigue admitted to molesting boys throughout the entirety of his time as a priest; likely
7 more than 100 boys over the years.

8 29. Upon information and belief, approximately 31 of those boys had pursued
9 lawsuits prior to January 1, 2020, meaning the Diocese potentially faced an additional 70
10 or more claims based on childhood sexual assault by Father Rodrigue alone.

11 30. In March of 2007, the Diocese published a list of clergy against whom it had
12 received allegations of child molestation that it deemed “credible.” That list was later
13 amended and now includes at least 51 credibly accused clerics. The volume of potential
14 AB 218 claimants was high.

15 31. Thus, with AB 218 moving through the Legislature, and substantial liability
16 looming, the Diocese began taking steps to secure its financial position against the
17 multitude of claims that it knew would be coming when AB 218 took effect. First, by
18 August 13, 2018, the Diocese had announced that it was participating in what it called an
19 “Independent Compensation Fund” for survivors of clergy sexual abuse. Through this
20 “Independent Compensation Fund” which took effect in September of 2019 a survivor of
21 childhood sexual abuse perpetrated by a priest of the Diocese could submit a claim form
22 to be evaluated by an “independent” claim evaluator. If the claimant qualified for the
23 program, a final settlement offer would be made. Individuals abused by non-priest
24 employees of the Diocese, or by priests associated with religious orders, were not eligible
25 for the program.
26
27
28

1 32. Plaintiffs are informed and believe and on that basis allege that the “Independent
2 Compensation Fund” was designed to draw out individuals who would otherwise be
3 eligible to bring a lawsuit pursuant to AB 218 and settle their claims for pennies on the
4 dollar. Indeed, the fund administrator announced that as of January 17, 2020, 69
5 individuals had registered claims against the Diocese through the fund program, and 27
6 of those had submitted completed claim forms. The administrator expected additional
7 applications and claims to be submitted in the ensuing 6 weeks that the claim filing
8 period remained open. As of January 17, 2020, 18 such claims had been processed, and
9 the program had authorized offers totaling \$1,334,000: an average of \$74,111 per
10 complainant. On average, the offers by the “Independent Compensation Fund” were
11 approximately 5% of the average settlement paid at the time of the Diocese’s bankruptcy
12 filing thirteen years earlier.

13
14
15 33. At the same time that the “Independent Compensation Fund” was becoming
16 operational and the Senate was passing AB 218 on to the Governor in mid-September of
17 2019, the Diocese was engaged in a massive effort to transfer title to hundreds of millions
18 of dollars of real property for no consideration. Plaintiffs are informed and believe and
19 on that basis allege that this fraudulent scheme, which is described below and is the
20 subject of this lawsuit, was intended to defraud Plaintiffs and others with claims based on
21 clergy sexual abuse.

22
23 ***F. The Current Fraudulent Scheme***

24 34. Plaintiffs believe and allege that all of the transfers described below were done as
25 part of a scheme created, masterminded, and designed by Diocese and the Parishes for the
26 Diocese to transfer properties to the Parishes so the assets of the Diocese are not
27 reachable by the Diocese’s creditors, particularly not reachable by Plaintiffs to satisfy
28 Plaintiffs’ Claims against the Diocese. The current fraudulent scheme involves the

1 transfer of at least 291 parcels of real property between September of 2019 and February
2 of 2020. Plaintiffs are informed and believe and on that basis allege that the total
3 assessed value of the transferred property is approximately \$453,385,107.
4

5 **1. Transfer of 6590 La Jolla Scenic Drive - Against the Diocese and All Hallows RPSC**

6 **FIRST CAUSE OF ACTION**

7 **[Set Aside Voidable Transaction - Civil Code § 3439.04(a)(1)]**

8 35. Plaintiffs re-allege and incorporate by this reference paragraphs 1-34 of the
9 Preliminary Allegations.

10 36. Plaintiffs are informed and believe and thereupon allege that Defendant ALL
11 HALLOWS PARISH IN SAN DIEGO, CALIFORNIA REAL PROPERTY SUPPORT
12 CORPORATION (“All Hallows RPSC”) is a California religious corporation.
13

14 37. Prior to September 1, 2019, the Diocese acquired the real property at 6590 La
15 Jolla Scenic Drive, La Jolla San Diego, 92037 (“6590 La Jolla Scenic Drive”).

16 38. By Grant Deed recorded September 24, 2019, for no consideration, the Diocese
17 transferred 6590 La Jolla Scenic Drive to All Hallows RPSC.

18 39. Plaintiffs believe and allege that on the date of the transfer of 6590 La Jolla
19 Scenic Drive, as alleged in ¶38 above, creditors, including Plaintiffs, had outstanding
20 claims against the Diocese, for which it was indebted, and that the transfer of 6590 La
21 Jolla Scenic Drive was made with the actual intent to hinder, delay, or defraud the
22 creditors of the Diocese in violation of Civil Code §3439.04(a)(1).
23

24 40. Plaintiffs seek to set aside the transfer of 6590 La Jolla Scenic Drive.

25 41. Plaintiffs are entitled to recover from the Diocese and All Hallows RPSC the full
26 amount owed or awarded to Plaintiffs on their Claims against the Diocese in the
27 Underlying Actions, including any judgments awarded or entered.
28

42. The Diocese and All Hallows RPSC did the things herein alleged maliciously and

1 to oppress the Diocese's creditors.

2 **SECOND CAUSE OF ACTION**

3 **[Set Aside Voidable Transaction - Civil Code § 3439.05]**

4 43. Plaintiff re-allege and incorporate by this reference paragraphs 1-34 of the
5 Preliminary Allegations and 35-42 of the First Cause of Action.

6 44. Plaintiffs believe that when 6590 La Jolla Scenic Drive was transferred, as alleged
7 in ¶38 above, creditors, including Plaintiffs, had outstanding claims against the Diocese,
8 for which it was indebted, and that the transfer of 6590 La Jolla Scenic Drive was made
9 without the Diocese receiving reasonably equivalent value and the Diocese was either
10 insolvent at the time of the transfer or became insolvent as a result of the transfer, in
11 violation of Civil Code §3439.05.

12 45. Plaintiffs are entitled to recover from the Diocese and All Hallows RPSC the full
13 amount owed or awarded to Plaintiffs on their Claims against the Diocese in the
14 Underlying Actions, including any judgments awarded or entered.

15 46. The Diocese and All Hallows RPSC did the things herein alleged maliciously and
16 to oppress the Diocese's creditors.

17 **2. *Transfer of 6600 La Jolla Scenic Drive - Against the Diocese and All Hallows RPSC***

18 **THIRD CAUSE OF ACTION**

19 **[Set Aside Voidable Transaction - Civil Code § 3439.04(a)(1)]**

20 47. Plaintiffs re-allege and incorporate by this reference paragraphs 1-34 of the
21 Preliminary Allegations.

22 48. Prior to September 1, 2019, the Diocese acquired the real property at 6600 La
23 Jolla Scenic Drive, La Jolla San Diego, 92037 ("6600 La Jolla Scenic Drive").

24 49. By Grant Deed recorded December 10, 2019, for no consideration, the Diocese
25

1 transferred 6600 La Jolla Scenic Drive to All Hallows RPSC

2 50. Plaintiffs believe and allege that on the date of the transfer of 6600 La Jolla
3 Scenic Drive, as alleged in ¶49 above, creditors, including Plaintiffs, had outstanding
4 claims against the Diocese, for which it was indebted, and that the transfer of 6600 La
5 Jolla Scenic Drive was made with the actual intent to hinder, delay, or defraud the
6 creditors of the Diocese in violation of Civil Code §3439.04(a)(1).
7

8 51. Plaintiffs seek to set aside the transfer of 6600 La Jolla Scenic Drive.

9 52. Plaintiffs are entitled to recover from the Diocese and All Hallows RPSC the full
10 amount owed or awarded to Plaintiffs on their Claims against the Diocese in the
11 Underlying Actions, including any judgments awarded or entered.
12

13 53. The Diocese and All Hallows RPSC did the things herein alleged maliciously and
14 to oppress the Diocese's creditors.

15 **FOURTH CAUSE OF ACTION**

16 **[Set Aside Voidable Transaction - Civil Code § 3439.05]**

17 54. Plaintiff re-allege and incorporate by this reference paragraphs 1-34 of the
18 Preliminary Allegations and 47-53 of the Third Cause of Action.

19 55. Plaintiffs believe that when 6600 La Jolla Scenic Drive was transferred, as alleged
20 in ¶49 above, creditors, including Plaintiffs, had outstanding claims against the Diocese,
21 for which it was indebted, and that the transfer of 6600 La Jolla Scenic Drive was made
22 without the Diocese receiving reasonably equivalent value and the Diocese was either
23 insolvent at the time of the transfer or became insolvent as a result of the transfer, in
24 violation of Civil Code §3439.05.
25

26 56. Plaintiffs seek to set aside the transfer of 6600 La Jolla Scenic Drive.

27 57. Plaintiffs are entitled to recover from the Diocese and All Hallows RPSC the full
28 amount owed or awarded to Plaintiffs on their Claims against the Diocese in the

1 Underlying Actions, including any judgments awarded or entered.

2 58. The Diocese and All Hallows RPSC did the things herein alleged maliciously and
3 to oppress the Diocese's creditors.

4 **3. *Transfer of 11292 Clairemont Mesa Boulevard - Against the Diocese and Ascension RPSC***

5 **FIFTH CAUSE OF ACTION**

6 **[Set Aside Voidable Transaction - Civil Code § 3439.04(a)(1)]**

7 59. Plaintiffs re-allege and incorporate by this reference paragraphs 1-34 of the
8 Preliminary Allegations.

9 60. Plaintiffs are informed and believe and thereupon allege that Defendant
10 ASCENSION CATHOLIC PARISH IN SAN DIEGO, CALIFORNIA REAL
11 PROPERTY SUPPORT CORPORATION ("Ascension RPSC") is a California religious
12 corporation.

13 61. Prior to September 1, 2019, the Diocese acquired the real property at 11292
14 Clairemont Mesa Boulevard, San Diego 92124 ("11292 Clairemont Mesa Boulevard").

15 62. By Grant Deed recorded October 11, 2019, for no consideration, the Diocese
16 transferred 11292 Clairemont Mesa Boulevard to Ascension RPSC.

17 63. Plaintiffs believe and allege that on the date of the transfer of 11292 Clairemont
18 Mesa Boulevard, as alleged in ¶62 above, creditors, including Plaintiffs, had outstanding
19 claims against the Diocese, for which it was indebted, and that the transfer of 11292
20 Clairemont Mesa Boulevard was made with the actual intent to hinder, delay, or defraud
21 the creditors of the Diocese in violation of Civil Code §3439.04(a)(1).

22 64. Plaintiffs seek to set aside the transfer of 11292 Clairemont Mesa Boulevard.

23 65. Plaintiffs are entitled to recover from the Diocese and Ascension RPSC the full
24 amount owed or awarded to Plaintiffs on their Claims against the Diocese in the
25 Underlying Actions, including any judgments awarded or entered.
26
27
28

1 74. By Grant Deed recorded October 11, 2019 for no consideration, the Diocese
2 transferred 5391 Outlook Point to Ascension RPSC.

3 75. Plaintiffs believe and allege that on the date of the transfer of 5391 Outlook Point,
4 as alleged in ¶74 above, creditors, including Plaintiffs, had outstanding claims against the
5 Diocese, for which it was indebted, and that the transfer of 5391 Outlook Point was made
6 with the actual intent to hinder, delay, or defraud the creditors of the Diocese in violation
7 of Civil Code §3439.04(a)(1).
8

9 76. Plaintiffs seek to set aside the transfer of 5391 Outlook Point.

10 77. Plaintiffs are entitled to recover from the Diocese and Ascension RPSC the full
11 amount owed or awarded to Plaintiffs on their Claims against the Diocese in the
12 Underlying Actions, including any judgments awarded or entered.
13

14 78. The Diocese and Ascension RPSC did the things herein alleged maliciously and
15 to oppress the Diocese's creditors.

16 **EIGHTH CAUSE OF ACTION**

17 **[Set Aside Voidable Transaction - Civil Code § 3439.05]**

18 79. Plaintiffs re-allege and incorporate by this reference paragraphs 1-34 of the
19 Preliminary Allegations and 72-78 of the Seventh Cause of Action.
20

21 80. Plaintiffs believe that when 5391 Outlook Point was transferred, as alleged in ¶74
22 above, creditors, including Plaintiffs, had outstanding claims against the Diocese, for
23 which it was indebted, and that the transfer of 5391 Outlook Point was made without the
24 Diocese receiving reasonably equivalent value and the Diocese was either insolvent at the
25 time of the transfer or became insolvent as a result of the transfer, in violation of Civil
26 Code §3439.05.
27

28 81. Plaintiffs seek to set aside the transfer of 5391 Outlook Point.

82. Plaintiffs are entitled to recover from the Diocese and Ascension RPSC the full

1 amount owed or awarded to Plaintiffs on their Claims against the Diocese in the
2 Underlying Actions, including any judgments awarded or entered.

3 83. The Diocese and Ascension RPSC did the things herein alleged maliciously and
4 to oppress the Diocese's creditors.
5

6 **5. *Transfer of 4540 El Cerrito Drive - Against the Diocese and Blessed Sacrament RPSC***

7 **NINTH CAUSE OF ACTION**

8 **[Set Aside Voidable Transaction - Civil Code § 3439.04(a)(1)]**

9 84. Plaintiffs re-allege and incorporate by this reference paragraphs 1-34 of the
10 Preliminary Allegations.

11 85. Plaintiffs are informed and believe and thereupon allege that Defendant
12 BLESSED SACRAMENT CATHOLIC PARISH IN SAN DIEGO, CALIFORNIA
13 REAL PROPERTY SUPPORT CORPORATION ("Blessed Sacrament RPSC") is a
14 California religious corporation.
15

16 86. Prior to September 1, 2019, the Diocese acquired the real property at 4540 El
17 Cerrito Drive, San Diego, 92115 ("4540 El Cerrito Drive").

18 87. By Grant Deed recorded September 13, 2019, for no consideration, the Diocese
19 transferred 4540 El Cerrito Drive to Blessed Sacrament RPSC.

20 88. Plaintiffs believe and allege that on the date of the transfer of 4540 El Cerrito
21 Drive, as alleged in ¶87 above, creditors, including Plaintiffs, had outstanding claims
22 against the Diocese, for which it was indebted, and that the transfer of 4540 El Cerrito
23 Drive was made with the actual intent to hinder, delay, or defraud the creditors of the
24 Diocese in violation of Civil Code §3439.04(a)(1).
25

26 89. Plaintiffs seek to set aside the transfer of 4540 El Cerrito Drive.

27 90. Plaintiffs are entitled to recover from the Diocese and Blessed Sacrament RPSC
28 the full amount owed or awarded to Plaintiffs on their Claims against the Diocese in the

1 Underlying Actions, including any judgments awarded or entered.

2 91. The Diocese and Blessed Sacrament RPSC did the things herein alleged
3 maliciously and to oppress the Diocese's creditors.

4 **TENTH CAUSE OF ACTION**

5 **[Set Aside Voidable Transaction - Civil Code § 3439.05]**

6 92. Plaintiffs re-allege and incorporate by this reference paragraphs 1-34 of the
7 Preliminary Allegations and 84-91 of the Ninth Cause of Action.

8 93. Plaintiffs believe that when 4540 El Cerrito Drive was transferred, as alleged in
9 ¶87 above, creditors, including Plaintiffs, had outstanding claims against the Diocese, for
10 which it was indebted, and that the transfer of 4540 El Cerrito Drive was made without
11 the Diocese receiving reasonably equivalent value and the Diocese was either insolvent at
12 the time of the transfer or became insolvent as a result of the transfer, in violation of Civil
13 Code §3439.05.

14 94. Plaintiffs seek to set aside the transfer of 4540 El Cerrito Drive.

15 95. Plaintiffs are entitled to recover from the Diocese and Blessed Sacrament RPSC
16 the full amount owed or awarded to Plaintiffs on their Claims against the Diocese in the
17 Underlying Actions, including any judgments awarded or entered.

18 96. The Diocese and Blessed Sacrament RPSC did the things herein alleged
19 maliciously and to oppress the Diocese's creditors.

20 **6. *Transfer of 4510 El Cerrito Drive - Against the Diocese and Blessed Sacrament RPSC***

21 **ELEVENTH CAUSE OF ACTION**

22 **[Set Aside Voidable Transaction - Civil Code § 3439.04(a)(1)]**

23 97. Plaintiffs re-allege and incorporate by this reference paragraphs 1-34 of the
24 Preliminary Allegations.

25 98. Prior to September 1, 2019, the Diocese acquired the real property at 4510 El
26

1 Cerrito Drive, San Diego, 92115 (“4510 El Cerrito Drive”).

2 99. By Grant Deed recorded December 2, 2020 for no consideration, the Diocese
3 transferred 4510 El Cerrito Drive to Blessed Sacrament RPSC.

4 100. Plaintiffs believe and allege that on the date of the transfer of 4510 El Cerrito
5 Drive, as alleged in ¶99 above, creditors, including Plaintiffs, had outstanding claims
6 against the Diocese, for which it was indebted, and that the transfer of 4510 El Cerrito
7 Drive was made with the actual intent to hinder, delay, or defraud the creditors of the
8 Diocese in violation of Civil Code §3439.04(a)(1).

9 101. Plaintiffs seek to set aside the transfer of 4510 El Cerrito Drive.

10 102. Plaintiffs are entitled to recover from the Diocese and Blessed Sacrament RPSC
11 the full amount owed or awarded to Plaintiffs on their Claims against the Diocese in the
12 Underlying Actions, including any judgments awarded or entered.

13 103. The Diocese and Blessed Sacrament RPSC did the things herein alleged
14 maliciously and to oppress the Diocese’s creditors.

15
16
17 **TWELFTH CAUSE OF ACTION**

18 **[Set Aside Voidable Transaction - Civil Code § 3439.05]**

19 104. Plaintiffs re-allege and incorporate by this reference paragraphs 1-34 of the
20 Preliminary Allegations and 97-103 of the Eleventh Cause of Action.

21 105. Plaintiffs believe that when 4510 El Cerrito Drive was transferred, as alleged in
22 ¶99 above, creditors, including Plaintiffs, had outstanding claims against the Diocese, for
23 which it was indebted, and that the transfer of 4510 El Cerrito Drive was made without
24 the Diocese receiving reasonably equivalent value and the Diocese was either insolvent at
25 the time of the transfer or became insolvent as a result of the transfer, in violation of Civil
26 Code §3439.05.

27 106. Plaintiffs seek to set aside the transfer of 4510 El Cerrito Drive.
28

1 107. Plaintiffs are entitled to recover from the Diocese and Blessed Sacrament RPSC
2 the full amount owed or awarded to Plaintiffs on their Claims against the Diocese in the
3 Underlying Actions, including any judgments awarded or entered.

4 108. The Diocese and Blessed Sacrament RPSC did the things herein alleged
5 maliciously and to oppress the Diocese's creditors.
6

7 **7. *Transfer of 4530 El Cerrito Drive - Against the Diocese and Blessed Sacrament RPSC***

8 **THIRTEENTH CAUSE OF ACTION**

9 **[Set Aside Voidable Transaction - Civil Code § 3439.04(a)(1)]**

10 109. Plaintiffs re-allege and incorporate by this reference paragraphs 1-34 of the
11 Preliminary Allegations.

12 110. Prior to September 1, 2019, the Diocese acquired the real property at 4530 El
13 Cerrito Drive, San Diego, 92115 ("4530 El Cerrito Drive").

24 judgment that might be awarded or entered;

25 C. For costs of suit herein incurred; and

26 D. For such other and further relief as the Court deems fair and proper.

JURY DEMAND

Plaintiffs demand a jury trial on all issues so triable.
